9. That no children were born of the common law marriage between Andrew Woods and the decedent Mary E. Anderson aka Mary Woods.

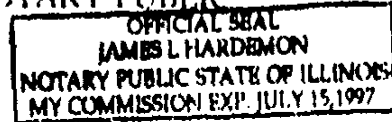
10. Alfred P. Anderson, Geraldine Brown and Mariette Stewart survived the decedent and are her only heirs at law.
