#### ASSUMPTION AGREEMENT

THIS ASSUMPTION AGREEMENT (the "Agreement") is entered into this 28th day of June, 1996, by and among IRENE R CORPORATION, an Illinois corporation ("Irene R"), AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, not personally, but solely as Trustee under Trust Agreement dated June 25, 1996 and known as Trust No. 121785-05 ("Trust") and MADISON BANK, N.A., a national banking association ("Lender").

WHEREAS, Irene R, as fee owner of that certain real estate described on Exhibit A attached hereto and made a part hereof (the "Premises"), executed and delivered to Lender those certain loan documents described on Exhibit B attached hereto (the "Loan Documents"), wherein Irene R promises to pay to the order of Lender the maximum aggregate amount of up to Eight Million Five Hundred Thousand and No/100 Dollars (\$8,500,000.00);

WHEREAS, Irera R, concurrent with the execution of this Agreement, has transferred its interest in the Premises to Trust in accordance with the terms of the Loan Documents;

WHEREAS, Trust has agreed, upon receipt of the Premises, to assume all of Irene R's obligations under the Loan Documents;

WHEREAS, Lender, upon Trust's assumption of Irene R's obligations under the Loan Documents, agrees to consent to the Transfer of the Premises to the Trust.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are nereby acknowledged, the parties hereto agree as follows:

- 1. Assumption. Trust hereby assumes all of the obligations, covenants and liabilities of Irens R under the Loan Documents.
- 2. No Release. Irene R, notwithstanding Trust's assumption of all of its obligations, covenants and l'abilities under the Loan Documents, acknowledges and agrees that it shall retain all of its obligations, covenants and liabilities under the Loan Documents and that it has not been released from any such obligations, covenants or liabilities under the Loan Documents.
- 3. <u>Consent</u>. Lender hereby consents and agrees to the aforesaid transfer of interest in the Premises to Trust and to Trust's assumption of Irene R's obligations, covenants and liabilities under the Loan Documents.
- 4. Trustee Exculpation. This Agreement is executed by American National Bank and Trust Company of Chicago, not personally but solely as Trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee (and said American National Bank and Trust Company of Chicago hereby

warrants that it possesses full power and authority to execute this Agraement), and it is expressly understood and agreed that nothing contained aerein shall be construed as creating any liability on the part of American National Bank and Trust Company of Chicago personally to make any payment or to perform any covenant, warranty or indemnity, either express or implied, contained herein, all such liability, if any, being expressly waived by Lender and all other parties now or hereafter claiming any right or security hereunder.
