ORDINANCE NO. 538 ARLINGTON HEIGHTS PARK DISTRICT

An Ordinance Annexing Certain Territory unto the Arlington Heights Park District

WHEREAS, the Arlington Feights Park District, Cook and Lake Counties, Illinois, has heretofore been duly organized under the provisions of "An Act to provide for the organization of Park Districts and the transfer of submerged lands to those bordering on navigable bodies of water," approved June 24, 1895, as amended, and is now operating under the provisions of "The Park District Code"; and

WHEREAS, Section 3-10 of The Park District Code provides:

"Whenever a Park District operating within territory predominately in a city or village or 2 or more cities or villages would become coterminous or nearly coterminous with such city or village or 2 or more cities or villages upon the annexation or additional territory within such municipalities but not incorporated within a park district, such Park District may annex such additional territory by the passage of an ordinance to that effect", 211

WHEREAS, Arlington Heights Park District is operating within territory predominately in the Village of Arlington Heights, Cook and Lake Counties, Illinois; and

WHEREAS, the territory hereinafter described lies within the corporate boundaries of the Village of Arlington Heights but is not presently incorporated within any park district; and

WHEREAS, upon the annexation of the territory described herein, the boundaries of Arlington Heights Park District and the Village of Arlington Heights will become nearly coterminous.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Arlington Heights Park District, Cook and Lake Counties, Illinois, pursuant to the statutes of the State of Illinois in such cases made and provided, as follows:

SECTION 1: That the territory hereinafter described shall be, and the same is, hereby annexed to the Arlington Heights Park District, Cook and Lake Counties, Illinois, so that hereafter said territory shall be included within the boundary lines and limits of the Arlington Heights Park District, Cook and Lake Counties, Illinois, as by law in such cases made and provided.

SECTION 2: That the territory hereby annexed is described as follows:

Lot 16 in Lynnwood Subdivision, Unit Number 3, being a subdivision in the East half of the West half of the Northwest quarter of Section 19, and in the West half of the East half of the Northwest quarter of Section 19, all in Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois, together with all that part of Lynnwood Avenue lying South of and adjoining the South line of said Lot 16.


