THIS FLEXEQUITY MORTGAGE is made this 29th day of June 1996 by and between Henry V. Cantwell and Irene T. Cantwell, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated June 29, 1996 (herein "Note") with a credit limit of Ten Thousand Dollars and no / 100 dollars (\$ 10,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXXXXXXXXXX has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. 2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attach over this Mortgagor's land and ground rents on the Property if any, plus one-twelfth of yearly premium installments for hazard insurance.

insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

**3. PRIOR ENCUMBRANCE; CHARGES; LIENS.** Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

**4. 6. **PROTECTION OF LENDER'S SECURITY.** If Borrower fails to perform the covenants and agreements contained in this Mortgage or in the Credit Documents, or if any action or proceeding is commenced against Borrower's interest in the property or powers of Lender hereunder, including but not limited to eminent domain, insolvency, code enforcement or arrangements involving a bankruptcy or decedent, then Lender, without demand upon Borrower but upon notice to Borrower pursuant to Paragraph 11 hereof, may, without notice to Borrower, make such appearance as Lender deems necessary to protect the security of this Mortgage, to include making reasonable attorney's fees, and take such action as Lender deems necessary to protect the security of this Mortgage. If Lender has required monies in accordance with the terms of this Mortgage, Lender shall pay the premiums required to maintain such insurance in effect until such time as the Borrower shall pay the premium required to maintain such insurance in effect until such time as the Borrower has paid all amounts due under this Mortgage.

If under Paragraph 17 hereof the Property is acquired by Lender, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to such sale or acquisition shall become the Property of Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

Subject to the rights and terms of any mortgage, deed of trust or other security agreement with a lessor which has or appears to do so, a duly priori over this Mortgage and unless Borrower and Lender otherwise agree in writing insurance proceeds shall be applied to restoration of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is economically feasible or if the security of this Mortgage would be impaired, the Insurance proceeds shall not be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. Such application shall not cure or waive any default under this Mortgage or invalidate any act done pursuant to such default.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

The insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lender; provided, that such approval shall not be reasonably withheld. All insurance policies and renewals shall be in a form acceptable to Lender. Lender shall have the right to hold the policies and renewals hereof, subject to the terms of any mortgage, deed of trust or other security agreement with a lessor which has or appears to have any priority over this Mortgage. All premiums in insurance policies shall be paid in the manner provided in Paragraph 2 hereof or, if not paid in such manner, by Borrower mailing payment, when due, directly to the insurance carrier. If Borrower makes the premium payment late, Borrower shall promptly furnish to Lender all renewal notices and, if requested by Lender, all receipts of payment due by Borrower. Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDEMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

9. **BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER.** Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release in any manner the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof, Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Borrower understands that Lender will not permit the assumption of the outstanding balance under the Note in any event and will declare the entire outstanding principal balance plus accrued interest and other charges due to be immediately due and payable (see Paragraph 17 hereof), unless (i) Borrower has submitted to Lender a written acknowledgement from the transferee that the transferee has received (a) a copy of each of the Credit Documents and (b) notice of the amount of Borrower's outstanding principal balance on the line of credit; (ii) Borrower has submitted to Lender a written acknowledgement from transferee that transferee has received such material and understands that Lender's security interest reflected by this Mortgage and the Security Agreement, if any, will remain on the Property and the Beneficial Interest, if any, until the entire outstanding principal balance of Borrower's line of credit as of the date of such sale or transfer or promise, plus any subsequent borrowing made under Borrower's line of credit before Lender has actual knowledge of the sale or transfer, together with accrued interest and other charges, is paid in full; (iii) Borrower causes to be submitted to Lender from the transferee a loan application as required by Lender so that Lender may evaluate the creditworthiness of the transferee as if a new loan were being made to the transferee; and (iv) Lender does not in its sole opinion, believe that (a) its security will be adversely affected, or (b) a breach of any promise or agreement in this Mortgage or the Security Agreement, if any, will occur or (c) such transfer will permit the acceleration of any loan which has priority in right of payment over the indebtedness evidenced by the Note. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. **ACCELERATION, REMEDIES (INCLUDING FREEZING THE LINE).** Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.

22. **TIME OF THE ESSENCE.** Time is of the essence to this Mortgage and all provisions relating thereto are to be strictly construed.

21. INCORPORATION OF TERMS. All of the terms, conditions and provisions of the Note are by this reference incorporated herein as if set forth in full. Any Event of Default under the Note shall constitute an Event of Default hereunder without further notice to Borrower.

20. **REOUEST FOR NOTICES.** Borrower requests that copies of any notice of default, sale and foreclosure from the holder and sent to the Property Address. Lender, requests that copies of notices of default, sale and foreclosure from the holder or any person which has priority over this Mortgage be sent to Lender's address, as set forth on a page one of this Mortgage.

19. RELEASE. Upon payment and discharge of all sums secured by this mortgage, the remittance of the account, this mortgage shall become null and void and Lender shall release this Mortgage without charge to Borrower.

Upon acceleration under Paragraph 17 hereof, or abandonment, I tender at any time without notice, in person, by affidavit or judicially apppointed receiver, and without regard to the date of any security for the indebtedness secured by this Mortgage, shall be entitled to eat up, take possession of, and in image the Property, and in its own name sue for or collect the rents of the Property, including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of operation and management of the Property and collection of rents, including, but not limited to, recievers fees, premiums on receivers bonds and reasonable attorney's fees, and then to the sums accrued by this Mortgage. Lender and the receiver shall be liable to account only for losses actually received. The entering upon and taking possession of the Property and application of the rents shall not cure or waive any default or notice of default hereunder or invalidate any act done pursuant to such notice.

18. ASSIGNMENT OF RENTS, AGREEMENT OF RECEIVER; LENDER IN POSSESSION. As additional security hereunder, Borrower hereby agrees to lease to lessors the rents of the Property, provided that prior to acceleration under Paragraph 17 hereof or the occurrence of an Event of Default hereunder or abandonment of the property, Borrower shall have the right to collect and retain such rents as they become due and payable.

As additional specific protection, without delaying any other term of the Note, Lender, without departing from the general purpose of the Note, may cancel Borrower's right to any future advance under the Note, (that is, "reduce," the line of credit), or may reduce the maximum amount of credit available to Borrower under the Note (that is, "reduce," the line of credit), without reducing accelerating repayment of the outstanding principal balance, upon the occurrence and during the continuation of any of the following events: (i) the value of the property held by Borrower will be unable to fulfill the payment obligation under the Note because of a material change in Borrower's financial condition; (ii) the occurrence of an Event of Default; (iii) the priority of Lender's security interest in action from the Collateral is adversely affected by government action to the extent that the value of the security interest is less than 20% of the line of credit evidenced by the Note; (iv) Lender is notified by its regulatory agency that continued advances under the Note constitute an unsafe and unsound practice; or (v) the maximum interest rate permitted to be charged by Lender under the Note is reached.


