SPECIAL WARRANTY DEED

Grantee acknowledges and agrees that Grantor has not made, does not make and specifically disclaims any representations, warranties, promises, covenants, agreements, or guaranties of any kind or character whatsoever, whether express or implied, oral or written, past, present or future, of, as to, concerning or with respect to (i) the nature, quality or condition of the Property, including, without limitation, the water, soil, and geology, or the presence or absence of any pollutant, hazardous waste, gas or substance or solid waste on or about the Property; (ii) the income to be derived from the Property; (iii) the suitability of the Property for any and all activities and uses which Grantee may intend to conduct thereon; (iv) the compliance of or by the Property or its operation with any laws, rules, ordinances or regulations of any governmental authority or body having jurisdiction; (v) the habitability, merchantability or fitness for

a particular use or purpose of the Property; or (vi) any other matter related to or concerning the Property. Grantee shall not seek recourse against Grantor on account of any loss, cost or expense suffered or incurred by Grantee with regard to any of the matters described in clauses (i) through (vi) above. Grantee acknowledges that Grantee, having been given the opportunity to inspect the Property, is relying solely on its own investigation of the Property and not on any information provided or to be provided by Grantor. Grantee further acknowledges that no independent investigation or verification has been or will be made by Grantor with respect to any information supplied by Grantor concerning the Property, and Grantor makes no representation as to the accuracy or completeness of such information, it being intended by the parties that Grantee shall verify the accuracy and completeness of such information itself.

TO HAVE AND TO HOLD the said premises as above described, with the appurtenances thereunto belonging, unto Grantee, Grantee's successors and assigns, forever. And the Grantor, for itself, and its successors, does covenant, promise and agree, to and with Grantee and its successor, that it has not done or suffered to be done, anything whereby the said Property hereby granted are, or may be, in any manner encumbered or charged, except as herein recited; and that it WILL WARRANT AND DEFEND the said Property against all persons lawfully claiming, or to claim the same, by, through or under Grantor, but not otherwise, SUBJECT TO the matters recited on Exhibit "B" attached hereto and made part hereof for all purposes.

And the Grantor hereby releases and waives all rights under and by virtue of the Homestead Exemption Laws of the State of Illinois.

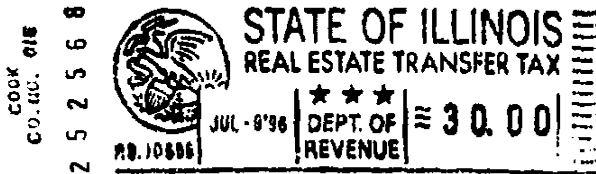
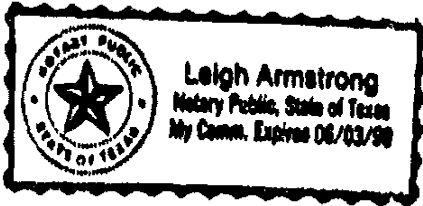
