Together with all the improvements now or hereafter erected on the property, and all essements, rights, appurtenences, rents, royalties, mineral, oil and gas rights and profits, water rights and stock and all fatures now or hereafter a part of the property. All replacements and additions shall also be powered by this Mortgage. All of the foregoing is referred to in this Mortgage as the "property."

You government that you are lewfully esteed of the setate he stoy conveyed and have the right to mortgage, grant and convey the property and that the property is unencumbered, except for encumbrances of record. You, unless you are an Winds land trust, warrant and will defend generally the title to the property against all claims and demands, subject to any

ancumbrances of record.

You acknowledge that this Mortgage secures an Agreement that contains provisions allowing for changes in the interest rate, and that we may, prior to the meturity of the Agreement and subject to certain conditions, reduce the Available Line of Oredit and/or require repayment of the total balance outstanding under the Agreement.

Covenents. You and we covenent and scree as follows:

1. (A) PAYMENT OF PRINCIPAL AND INTEREST. You shall promptly page when due the principal of and interest accrued on the Indebtedness evidenced by the Agreement, together with any other real, stranges or premiums imposed by

the Agreement, the Security Agreement, or by this Mortgage.

(B) LINE OF CREDIT LOAN. This Mortgage secures a Line of Credit Loan Agreement. You will enjoy access to that Line of Credit during the first abity (60) Billing Cycles assigned to your Account. Each Billing Cycles approximately one month. (Your initial Billing Cycle may be less than one month). The Revolving Line of Credit Texts of the Agreement is therefore approximately five (8) years long. The minimum payment due is the sum of the following charges accrued or incurred in the Silling Cycle: (1) Finance Charges; (2) premiums for Optional Cradit Life insurance; (3) the Annual Fee; (4) all other charges incurred pursuant to the greement except fees and charges charged to your Account at the Inception of the Agreement as permitted by Paragraph 11 (8) and (C) of the Agreement; (5) principal necessary to reduce the Outstanding Balance of your account to your Credit Limit; and (6) any past due payments. (D) INTEREST DURING THE LOAN TERM. You agree to pay interest (a "FINANCE CHARGE") on the Outstanding

Principal Balance of your Home Equity Line as determined by the Agreement.

The rate of interest ("ANNUAL PERCENTAGE RATE") will be determined and will vary based upon a "REFERENCE HATE". This Reference Rate shall be the prime rate of interest as published in the Money Rates Section of the Wall Street Journal on the abdeenth (16) day of each month, regardless of when such rates were quoted by the Commercial Banks to the Wall Street Journal. The Reference Rate is defined by the Wall Street Journal as the base rate on corporate loans at things U.S. Money Center Commercial Banks. In the event more than one Reference Rate is published by the Wall Street Journal for any applicable day, the lowest rate so published shall apply. In the event such a Reference Rate oesses to be published by the Wall Street Journal, we will select a new Reference Rate that is based upon a comparable information, and if necessary, a substitute "MARGIN", so that the change in the Reference Rate results in substantially the same "ANNUAL PERCENTAGE RATE" required under the previous Reference Rate.

The Reference Rate so determined shall be effective for any Billing Cycle that begins in that month. However, the Reference Rate effective for your initial Billing Cycle shall be determined in one of two ways. If your initial Billing Cycle Billing Date occurry in the same month as the effective date of this Agreement, the Reference Rate shall be the one determined on the abdranth (16) day of the preceding month. If your initial Billing Cycle Billing Date occurs in the month after the effective date of this Agreement, the Reference Rate shall be the one determined on the abdranth (16) day of the

month in which the effects of this Agreement occurs.

Your rate of interest ("ANNUAL PERCENTAGE RAGE") shall be the Reference Rate plus a "MARGIN" of ONE AND 100/1000 (1.000 %) percent for the applicable Billing Cycle.

Finance Charges will be assessed on a daily basis by applying the Daily Periodic Rate (the "DAILY PERIODIC RATE") is the Annual Percentage Rate applicable to that Billing Cycle, divided by 365 or 368 in Leap Year) to the Daily Principal Balance of your Home Equity Line for each day of the Billing cycle in which there is an Outstanding Principal Balance.

If you have used Home Equity Line checks that have not been posted to your account as of the Conversion Date, and those checks are subsequently paid by us, your initial Closed-End Principal balance will be increased on subsequent periodic Billing Statement to reflect such Loans.

Each new interest rate will become effective with each Change Date, and we be reflected in the payment due

immediately after that Change Date.

- 2. APPLICATION OF PAYMENTS. If there is a balance on your Account, we will send you billing statements, approximately monthly, reflecting account transactions and your balance. You can pay the halance, together with current interest, in full without penalty, or defer full payment, in which case you must pay at least the printing of the deferment. Your payment is due on or before the date shown on your statement and it should be sent with the remittance portion of your billing statement. We may apply payments to your obligations under this Agreement and the Deed of Trust in the order we choose. However, we will ordinarily apply your payments to: (1) lineance charges, (2) life insurance premiums, if due (3) principal (except for minimum payments during the Revolving Period), and (4) other charges, in that order. Payments will always be applied to past due and current amounts in each category in order. The amount of any payment in excess of the Minimum Payment Due will be applied first to the principal Account balance if no due amounts exist in another payment. Make your payments by mail or at our branch using the remittance portion of your billing statement.
- 3. CHARGES; LIENS. You shall pay all taxes, assessments, charges, fines and impositions attributable to the property which may attain priority over this Mortgage, and lessehold payments or grounds rents, if any. You shall pay these obligations in the manner provided in paragraph 2, or if not paid in that manner, you shall pay them on time directly to the person owed payments. You shall promptly furnish to us all notices of amounts to be paid under this paragraph. If you make these payments directly, you shall promptly furnish to us receipts evidencing the payments.
- 4. HAZARO INSURANCE. You shall keep the improvements now existing or hereafter erected on the property insured against loss by fire, any hazard included within the term "EXTENDED COVERAGE" and any other hazard for which we require insurance. This insurance shall be maintained in the amounts and for the period that we require. The insurance carrier providing the insurance shall be chosen by you subject to our approval which shall not be unreasonably withheld.

All insurance policies and renewals shall be acceptable to us and shall include a standard mortgage clause. We shall "
have the right to hold the policies and renewals. If we require, you shall promptly give to us all receipts of paid premiums
and renewal notices. In the event of loss, you shall give prompt notice to the insurance certier and us. We may make

proof of loss if not made promptly by you.

Unless we and you otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the property damages, if the restoration or repair is economically feasible and our security is not lessened. If the restoration or repair is not economically feasible or our security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage, whether or not then due, with any excess paid to you. If you shandon the property, or do not answer within thirty (30) days a notice from us that the insurance carrier has offered to settle a claim, we may collect the insurance proceeds. We may use the proceeds to repair or restors the property or to pay sums secured by this Mortgage, whether or not then due. The 30-day period will begin when the notice is given.

Unless we and you otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of the payments referred to in paragraphs 1 and 2 or change the amount of the payments. If under paragraphs 30, the property is acquired by us, your right to any insurance policies and proceeds resulting from damage to the property prior to the acquired by this Mortgage immediately prior to the

acquisition.

6. PRESERVATION AND MAINTENANCE OF PROPERTY; LEASEHOLDS. You shall not destroy, dernage or substantially change the property, allow the property to deteriorate or commit wasts. If this Mortgage is on a lessehold, you shall comply with the protection of the lesse, and if you acquire fee title to the property, the lessehold and fee title shall

not merge unless we agree to the marger in writing.

a. PROTECTION OF OUR RIGHTS IN THE PROPERTY; MONTGAGE GUARANTY INSURANCE. 7. INSPECTION. We or our agent may make reasonable entries upon and trepections of the property. We shall give

a. CONDEMNATION. The proceeds of any award or claim for damages, Great or consequential, in connection with any condemnation or other taking of any part of the property, or for conveyance in Seu of condemnation, are hereby

In the event of a total taking of the property, the proceeds shall be applied to the across secured by the Mortgage, whether or not then due, with any excess paid to you. In the event of a partial taking of the property, unless you and we otherwise agree in writing, the sums secured by this Mortgage shall be reduced by the amount of the sums secured immediately before the taking, stilled by (b) the fair market value of the property immediately before the taking. Any belance shall be paid to you.

If you abandon the property, or if, after notice by us to to you that the condemnor offers to make a linkerd or settle a claim for damages, you felt to respond to ours within thirty (30) days after the date the notice is given, we are authorized to collect and apply the proceeds, at our option, either to restoration or repair of the property or to the sums secured by this

Mortgage, whether or not then due.

Unless we and you otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the

due date of the periodic payments referred to in paragraphs 1 and 2 or change the amount of such payments.

8. YOU'RE NOT RELEASED; FORSEARANCE BY US NOT A WAIVER. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by us to any successor in interest of yours shall not operate to release the liability of your original successor in interest. We shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by you or your successors in interest. Any forbearance by us in exercise any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.

10. SUCCESSOR AND ASSIGNS SOUND; JOINT AND SEVERAL LIABILITY; CO-SIGNERS. The covenants and agreements of this mortgage shall bind and benefit our and your successors and assigns, subject to the provisions of paragraph 19. Your covenants and agreements shall be joint and several. Any Mortgagor who co-signs this Mortgage but does not execute the Agreement (at) is co-signing this Mortgage only to mortgage, grant and convey that Mortgagor's interest in the Property under the terms of this Mortgage; (b) is not personally obligated to pay the sums secured by this

11. LOAN CHARGES. 12. NOTICES. Any notice to you provided for in this Mortgage shall be given by delivering it or by mailing it by first class mall, unless applicable law requires use of another method. The notice shall be directed to the property address or any other address you designate by notice to us. Any notice to us shall be given by first class mall to our address stated herein or any other address we designate by notice to you. Any notice provided for in this Mortgage shall be deemed to

have been given to you or us when given as provided in this paragraph.

13. GOVERNING LAW: SEVERABILITY. This Mortgage shall be governed by federal law and regulation and the law of the juriediction in which the property is located. In the event that any provision or clause of this Mortgade or the Agreement conflicts with explicable law, such conflict shall not affect other provisions of this Mortgage or the Agreement which can be given effect without the conflicting provision. To this end the provisions of this Mortgage and the Agreement are declared to be severable.

14. YOUR COPY. You shall by given one conformed copy of the Agreement and of this Mortgage.

15. PRIOR MORTGAGES. 18. DEFAULT. (a) The occurrence of any of the knowing events shall constitute a detault by you under this Mortgage: (1) failure to pay when due any sum of money due under the Agreement or pursuant to this Mortgage, or the Security Agreement; (2) your action or inaction adversely alliggts our security for the Agreement or any right we may have in that security; (3) you gave or give us any false or materially misseding information in connection with any Loan to you or in your application for the Home Equity Line; (4) title to your home, the property, is transferred as more fully described

in peragraph 19 below; or (5) any of you die.

(b) if you are in detault under the Agreement or this Mortgage, we may terminate your Home Equity Line and require you to pay immediately the principal balance outstanding, any and all interer, you may owe on that amount, together with all other fees, costs or premiums charged to your ecoount. The principal beaution outstanding under the Agreement after default shall continue to accrue interest until paid at the rate provided for in the forwment as if no default had occurred. in addition to the right to terminate your Home Equity Line and declare all sums immediately due and owing under the Agreement, in the event of a defaut, we shall have the right to refuse to make additional Lorne to you under the Agreement (reduce your Credit Limit). 17. RIGHT TO REDUCE LINE OF CREDIT. We may, during the Revolving Line of Credit Turns, reduce your Credit Limit or suspend your credit privileges (refuse to make additional Loans) It: (a) the value of your property drops significantly below the appraised value upon which the Agreement was based; (b) a meterial change in your financial circumstances gives us reason to believe that you will not be able to make the required payments; (a) povernmental action precludes us from charging the Annual Percentage Rate permitted by the Agreement or governmental action adversely affects our lien priority such that the value of our security interest falls below 120 percent of your Credit Limit; (d) the cap on the maximum Annual Percentage Rate provided in the Agreement prevents us from increasing the Annual Percentage Flate to match one or more increases in the Reference Rate; (e) we are notified by our Regulatory Agency that continuing 👸 to make Loans constitutes an unsale and uneound practice; or (f) you are in default of any material obligation under the Agreement. If we refuse to make further Losns to you, but do not terminate your Home Equity Line, you must notify us in writing if you would like to obtain further Loans and can demonstrate that the conditions that gave us the right to refuse to make further Loans has changed.

18. TRANSFER OF THE PROPERTY. 19. ACCELERATION; REMEDIES. We shall give notice to you prior to acceleration following your breach of any covenent or agreement in the Mortgage (but not prior to acceleration under paragraph 19 unless applicable law provides otherwise). The notice shall specify: (a) the default; (b) the action required to ours the default; (c) a date, not less than 30 days from the date the notice is given to you, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and eale of the property. The notice shall further inform you of the right to reliebate after acceleration and the right to ascert in the foreclosure proceeding the nonestatence of a default or any other defense to acceleration and foreclosure. If the default is not cured on or before the date specified in the notice, at our option, we may require immediate payment in full of all sums secured by this Mortgage without further demand and may foreclose this Mortgage by Judicial proceeding.
