TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by junistiction to constitute a uniform security instrument covering real property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 4. Charges; Liens. Borrower shall ray all taxes, assessments, charges, fines and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, if any. Borrower shall pay these obligations in the namer provided in paragraph 2, or if not paid in that manner, Borrower shall pay them on time directly to the person owed payment. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate, or commit waste on the Property. - 8. Mortgage Insurance. If Lender required mortgage insurance as a condition of making the loan secured by this Security Instrument, Borrower shall pay the premiums required to maintain the mortgage insurance in effect. If, for any reason, the mortgage insurance coverage required by Lender lapses or ceases to be in effect, Borrower shall pay the premiums required to obtain coverage substantially equivalent to the mortgage insurance previously in effect, at a cost substantially equivalent to the cost to Borrower of the mortgage insurance previously in effect, from an alternate mortgage insurer approved by Lender. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.

- 12. Successors and Assigns Bound; Joint and Several Liability; Co-signers. The covenants and agreements of this Security Instrument shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 17. Borrower's covenants and agreements shall be joint and several. Any Borrower who co-signs this Security Instrument but does not execute the Note: (a) is co-signing this Security Instrument only to mortgage, grant and convey that Borrower's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without that Borrower's consent.

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

- 21. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement in this Security Instrument (but not prior to acceleration under paragraph 17 unless applicable law provides otherwise). The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Security Instrument, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and foreclosure. If the default is not cured on or before the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Security Instrument without further demand and may foreclose this Security Instrument by judicial proceeding. Lender shall be entitled to collect all expenses incurred in pursuing the remedies provided in this paragraph 21, including, but not limited to, reasonable attorneys' fees and costs of title evidence.
- 22. Release. Upon payment of all sum socured by this Security Instrument, Lender shall release this Security Instrument to Borrower. Borrower shall pay any recordation costs. Lender may charge Borrower a fee for releasing this Security Instrument, but only if the fee is paid to a third party for services rendered and the charging of the fee is permitted under applicable law.

THE NOTE PROVIDES FOR A CHANGE IN THE BORROWER'S FIXED INTEREST RATE TO AN ADJUSTABLE INTEREST RATE. THE NOTE LIMITS THE AMOUNT THE BORROWER'S ADJUSTABLE INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE THE BORROWER MUST PAY.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. ADJUSTABLE RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial fixed interest rate of 8.350%. The Note also provides for a change in the initial fixed rate to an adjustable interest rate, as follows:

4. ADJUSTABLE INTEREST RATE AND MONTHLY PAYMENT CHARGES

(A) Change Dates

The initial fixed interest rate I will pay will change to an adjustable interest rate on the first day of JULY, 2001, and the adjustable interest rate I will pay may change on that day every 12th month the earlier. The date on which my initial fixed interest rate changes to an adjustable interest rate, and each date on which my adjustable interest rate could change, is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an Index. The 'Index' is the weekly average yield on United States Treasury securities adjusted to a constant maturity of 1 year, as made available by the Federal Reserve Board. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO AND 750/1000 percentage points (2.750%) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes

The interest rate Lar, required to pay at the first Change Date will not be greater than 10.350% or less than 6.350%. Thereafter, my adjustable interest rate will never be increased or decreased on any single Change Date by more than two percentage points (2.0%) from the rate of interest I have been paying for the preceding 12 months. Transfer of the Property or a Beneficial Interest in Borrower. RIDER TO MORTGAGE

This Rider is made and attached as a part of that certain Mortgage dated JUNE 24, 1996 ("Security Instrument"), which secures a Promissory Note (the "Note") evidencing an indebtedness owed by the Borrower to Home Savings of America, FSB ("Lender") under the terms of its ARM T-5 loan made to Borrower and identified as Loan No. 01862061-7 . Borrower agrees that if the provisions that are contained in this Rider are in conflict with the terms in the printed Security Instrument and the Note, then the provisions of this Rider will control over the provisions in the printed Security Instrument and the Note.

The Security increment is hereby amended in the following respects:

- 1. Paragraph 5 of the Security List unent is deleted in its entirety and is replaced with a new paragraph 5 which reads in full as follows:
 - 5. Hazard or Property Insurance; Assignment and Waiver of Insurance Proceeds, Etc. Borrower at all times shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "special form coverage" and such other hazards, including floods and flooding, with respect to the Property for which Lender now or negative requires insurance (collectively, "required insurance"). Each required insurance policy shall be in an amount, for a term and in form and content and by such companies, as may be satisfactory to Lender, with loss payable to Lender and shall be delivered to, and remain in possession of, Lender as further security hereunder. Borrower shall also furnish Lender with written evidence showing payment of all premiums therefor. At least thirty (30) days prior to the expiration of any required insurance policy, a policy renewing or extending such expiring insurance shall be delivered to Lender with written evidence showing payment of the premium therefor. If any required insurance policy and evidence of payment of the premium are not delivered to Lender within the time period required by Lender, Borrower by executing this Security Instrument specifically requests Lender to obtain such insurance. Lender, but without obligation to do so, without notice to or demand upon Borrower and without releasing Borrower from any obligation hereof, may, acting solely for its own interests and not as Borrower's agent, obtain such insurance through or from any insurance agency or company acceptable to it, including an affiliate of Lender which will be entitled to receive a commission for its services, and pay the premium therefor. Any such amounts disbursed by Lender therefor shall be repaid by Borrower in accordance with paragraph 7. Lender shall be under no obligation to retain in place any insurance policy previously purchased by Bozzower Borrower agrees that any insurance policy purchased by Lender may be "forced order" insurance, and acknowledges that (i) the cost of any insurance policy purchased by Lender may be substantially more than the cost of any policy previously purchased or thereafter available for purchase by Borrower, and (ii) the coverage provided by such insurance policy may be different from the coverage of any policy previously purchased or thereafter available for purchase by Borray and Lender shall not be chargeable with obtaining or maintaining, or liable for not obtaining or maintaining any required insurance or for the collection of any such insurance monies or for any insolvency of any insurer or insurance underwriter. For purposes of this Security Instrument, a "voluntary insurance policy" shall mean and shall include any insurance policy that covers earthquake, flood, windstorm or any

other hazards to the Property but which is not required as a condition to the loan secured hereby, and any amendment, endorsement or rider (or any other document by which such insurance coverage is established) to any fire and other insurance policy, which amendment, endorsement or rider (or such other document by which such insurance is established) covers earthquake, flood, windstorm or any other hazards to the Property but which is not required as a condition to the loan secured hereby, and regardless of whether any such insurance policy, amendment, endorsement, rider or other document is established before, on or after the date of this Security Instrument.

Borrower hereby absolutely and irrevocably assigns to Lender all of Borrower's right, title and interest in and to all proceeds from any required insurance policy and any voluntary insurance policy that are due, paid or payable with respect to any damage to the Property, regardless of whether the required insurance policy or voluntary insurance policy is established before, on or after the date of this Security Insurance. By absolutely and irrevocably assigning to Lender all of Borrower's rights to receive any and all proceeds from any required insurance policy and any voluntary insurance policy. Borrower hereby waives, to the full extent allowed by law, all of Borrower's rights to receive any and all of such insurance proces its.

Borrower's right, title and interest in and to (a) any and all claims, present or future, known or unknown, absolute or comingent. (b) any and all causes of action, (c) any and all judgments and settlements (whether through litigation, mediation, arbitration or otherwise), (d) any and all funds sought against or from ray party or parties whosoever, and (e) any and all funds received or receivable in connection with any damage to the Property, resulting from any cause or causes whatsoever, including but not limited to, land subsidence, landslide, win sterm, earthquake, fire, flood or any other cause.

Borrower agrees to execute, colorwiedge if requested, and deliver to Lender and/or upon notice from Lender shall request any insurance agency or or mp my that has issued any required insurance policy or voluntary insurance policy to execute and deliver to Lender, any reministrational insurances or documents requested by Lender from time to time to evidence Borrower's absolute and irrevocable as ign pents set forth in this paragraph.

Lender, from since to time, may furnish to any insurance agency or company, or any other person, any information contained in, extracted from or relating of the required insurance policy theretofore delivered to Lender pursuant hereto or any voluntary insurance policy, and information concerning the loan secured hereby.

- 2. Paragraph 10 of the Security Instrument is deleted in its entirety and 's replaced with a new Paragraph 10 which reads in full as follows:
 - amount received or receivable by Lender pursuant to this Security Instrument and any amount received or receivable by Lender pursuant to this Security Instrument and any amount received or receivable by Borrower (a) as proceeds of any required insurance policy or voluntary insurance policy relating to the Property, regardless of whether the required insurance policy or voluntary insurance policy is emblished before, on or after the date of this Security Instrument, (b) in connection with any full, partial or temporary condemnation for public use of or injury to the Property, (c) for injury or damage to the Property or in connection with the masser on financed by the loan secured hereby, without reducing the indebtedness secured hereby, shall be received and control also by Lender, and shall be used to repair, replace, restore or reconstruct the Property to a condition satisfactory to Lender or, at the sole option of Lender, may be released in whole or in part to Borrower, or any such amount may be apparticated and applied in any manner by Lender to any one or more of such uses. No such application, use or release shall cure of waite any default or notice of default hereunder or invalidate any act done pursuant to such notice. Notwithstending anything contained in this paragraph to the contrary, (x) if the repair, replacement, restoration or reconstruction, or (z) if a full condemnation of the Property has occurred, then Lender, at its sole option, shall have the right to apply any such amount or any part thereof to any indebtedness secured

Lender does not make any warranty or representation regarding, and assumes no responsibility for, the work done on the Property, and Botrower shall not have any right to rely in any way on any inspection(s) by or for Lender or its agent. Borrower shall be solely responsible for determining that the work is done in a good, thorough, efficient and workmanlike manner in accordance with all applicable laws.

Unless Lender and Borrower otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of the monthly payments referred to in paragraphs 1 and 2 or change the amount of the payments. If under paragraph 21 the Property is acquired by Lender, Borrower's right to any insurance policies and proceeds resulting from damage to the Property prior to the acquisition shall pass to Lender to the extent of the sums secured by this Security Instrument immediately prior to the acquisition.

Except for the amendments to the Security Instrument contained in this Rider, all the other terms, conditions and provisions of the Security Instrument remain unmodified and in full force and effect.
