RIGHT OF FIRST REFUSAL AGREEMENT

THIS ACREEMENT is made as of the 25th day of June, 1996, by and between ANGHOR HARBOR SERVICES, INC., an Olinois corporation having an address at PO Rox 10 Lemont, 14 60 439 ("Anchor") and GARVEY MARINE, INC., a Kansas corporation having an address at One Foxfield Square, Suite 200, St. Charles, Illinois 60174 ("Garvey").

KECITALS:

- A. Anchor or an affiliate (which, together with Anchor are sometimes referred to herein collectively as "Anchor") has leased from the Metropolitan Water Reclamation District of Greater Chicago (formerly known as the Metropolitan Sanitary District of Greater Chicago and referred to herein as "MWRD") certain property, including barge slips No. 1 and No. 4 located near Mile 300 of the Chicago Sanitary and Ship Canal in Cook County, Illinois, which slips are depicted on the attached sketch and described by the legal description on Exhibit A hereto (the "Barge Slipa").
- B. Anchor and Ham Tug & Fleeting Service Co., Inc. ("Ham") are parties to an Operating Agreement dated December 14, 1988 (the "Operating Agreement"), which expires by its terms on October 31, 2003.
- C. Garvey has succeeded to the rights of Ham under the Operating Agreement.
- D. Anchor has agreed to grant to Garvey the rights provided herein.

In consideration of the mutual covenants and agreements herein stated and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged. Anchor hereby grants to Garvey the right of first refusal concerning the Barge Slips, together with all appurtenances thereto upon the following terms and conditions.

- Anchor acknowledges and agrees and hereby grants to Garvey a primary, continuing right of first refusal to extend the Operating Agreement with respect to the Barge Slips on the same terms and conditions as are now contained in the Operating Agreement except that Garvey shall assume and pay when due any increase in rent or other charges. imposed by MVRD in any lease renewal or extension. Accordingly, in the event MWRD or its successor or assign renews or extends its lease with Anchor or enters into a new lease with Anchor or sells property to Anchor, in each case that includes the Barge Slips, Anchor shall notify Garvey thereof not more than sixty (60) days following such event, which notice shall include the rate of compensation for any renewal by Garvey. Garvey shall have the right, but not the obligation, to renew the Operating Agreement for a term not exceeding the term of the right of Anchor to the Barge Slips. This right of first refusal shall expire and be of no further force or effect if not acted upon within 21 days of the notice to Garvey. This right shall continue for any such extension or renewal of Anchor's rights to the Barge Slips. In all events, the conveyance by Anchor of to rights to the Barge Slips or any portion thereof shall be subject to Garvey's rights described herein.
- Anchor represents and warrants to Carvey that it is the lessee of the Barge Slips and that Anchor has the power and authority to perform the terms and provisions of this Agreement and to bind the Barge Slips as contemplated by this Agreement.
 - 3. Time is of the essence of this Agreement.
- All notices and demands herein required shall be in writing and shall be served on the parties at the following addresses and may be made by personal service, overnight express delivery or United States mail:

Any notice given by mail shall be sent, postage prepaid, by certified mail, return receipt requested, addressed to the party to receive at the foregoing address or at such other address as the party may from time to time direct in writing. Express delivery and personally-served notices shall be desired given upon receipt. Postal notices shall be deemed to be given two (2) days after deposit with the United States Postal Service.

- 5. This Agreement constitutes the entire agreement and understanding of the parties as to this right of first refusel, and there are no other prior or contemporaneous written or oral agreements, undertakings, promises, warranties, representations, or other covenants not contained herein, other than the existing Operating Agreement.
- 6. This Agreement may be amencied only by a written instrument subsequently executed by Anchor and Garvey expressly stating the intention to amend this Agreement.
- 7. Anchor and Garvey agree that this Agreement may be recorded with the Cook County Recorder of Deeds and shall be an obligation running with the land.
- 8. This Agreement and all of the covenants and agreements herein contained shall be binding upon and inure to, Anchor's and Garvey's respective successors, heirs, executors, administrators and assigns.
- 9. Wherever possible, each provision of this Agreement shall be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Agreement shall be prohibited by or invalid under applicable law, such provision shall be ineffective to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Agreement.
