#### MORTGAGE

THIS MORTGAGE IS DATED JULY 11, 1996, between Peter James Skach and Denise F. Skach a/k/a Denise E. Skach, his wife, whose address is 414 N. LaGrange Road, LaGrange Park, IL 60525 (referred to below as "Grantor"); and Harris Bank Hinsdale, N. A., whose address is 50 South Lincoln, Hinsdale, IL 60521 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, wa rants, and conveys to Lender all of Grantor's right, title, and interest in and to the following described rep: property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; his easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minorals, oil, gas, geothermal and similar matters, located in Cook County, State of Illinois (the "Real Property"):

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not otherwise defined in this Mortgage shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean amounts in lawful money of the United States of America.

Credit Agreement. Existing Indebtedness. The words "Existing indebtedness" mean the indebtedness described below in the Existing indebtedness section of this Mortgage.

Grantor. The word "Grantor" means Peter James Skach and Denite F. Skach a/k/a Denise E. Skach. The Grantor is the mortgagor under this Mortgage.

Guarantor. The word "Guarantor" means and includes without limitation each and all of the guarantors, sureties, and accommodation parties in connection with the indebtedness.

Improvementa. The word "Improvements" means and includes without limitation all existing and future improvements, buildings, structures, mobile nomes affixed on the Real Property, facilities, additions, replacements and wher construction on the Real Property.

Indebtedness. The word indebtedness" means all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage. Right To Contest. If a lien orises or is filed as a result of nonphyment, Grantor shall within filteen (15) days after Grantor has notice of the filing, secure the discharge of the lien, or if requested by Lender, deposit with Lender cash or a solicitent corporate surely bond or other security satisfactory to Lender in an amount sufficient to discharge the lien plus any costs and attorneys feed or other charges that could accrue as a result of a foreclosure or stre under the lien. In any contest, Grantor shall defend itself and Lender and shall satisfy any adverse judgment before enforciment against the Property. Grantor shall name Lender as an additional obliges under any turety bond furnished in the contest proceedings.

Evidence of Payment. Grantor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Grantor shall notify Lender at least filteen (15) days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any materials ilen, or other lien could be asserted on account of the work, services, or malerals and the cost exceeds \$10,000.00. PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property a part of this Mortgage.

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgause clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably accoptable to Lender. Grantor shall deliver to Lender certificates of apverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a liminimum of ten (10) days prior written notice to Lender and not containing any disclaimer of the insurer's eliability for failure to give such notice.
