RIDER TO ARTICLES OF INCORPORATION FOR BAYPOINT CONDOMINIUM

Rider to the Articles of Incorporation under the General Not For Profit Corporation Act of Baypoint Condominium Association.

Article 4

To maintain, operate and manage the condominium residential building and improvements located at 3175 North Lincoln Avenue, Chicago, Illinois.

The members of the Baypoint Condominium Association shall consist of the respective Owners of the Property known as and located at the above described address in Chicago, Illinois, in accordance with the respective percentages of ownership interest in the Common Elements of the Property owned by the respective Owners, as said terms are defined in the Declaration of Condominium Ownership, Lydows, Easements, Restrictions, and Covenants executed by the Cinema Lofts Condominium Association, which Declaration will be recorded in the office of the Recorder of Deeds, Cook County, Illinois.
