All scheduled monthly payments of the amount financed and the time price differential, or finance charge, shall be applied first to the finance charge and the remainder, if any, to the amount financed. If Borrower owes Lender any late charges, or other fees or charges ("other charges"), they will be payable upon demand of Lender and applied in a manner at the absolute discretion of the Lender, subject to applicable law.
- 2. Prior Mortgages and Deeds of Trust; Charges; Liens. - 9. Successors and Assigns Bound; Joint and Several Liability; Signers. The covenants and agreements herein contained shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Lender and Borrower, subject to the provisions of Paragraph 12 hereof. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the sums secured by this Security Instrument to be immediately due and payable without further demand and may foreclose this Security Instrument by judicial proceeding or by any other remedies permitted by law. Lender shall be entitled to collect all expenses incurred by Innder in the event of Borrower's default, including but not limited to, court costs, collection agency fees and lawful attorner's' fees.
- 14. Assignment of Rents; Appointment of Receiver.
