14. Trustee may resign by instrument in writing filed in the office of the Recorder of Registrar of Titles in which this instrument shall have been recorded or filed. Any Successor in Trust hereunder shall have the identical title, powers and authority as are

herein given Trustee.

15. This Trust Deed and all provisions hereof, shall extend to the be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal notes or this Trust Deed.

16. Before releasing this trust deed, Trustee or successor shall receive for its services a fee as determined by its rate schedule in effect when the release deed is issued. - Payment of Principal and Interest: Prepayment and Late Charges. Mortgagor shall promptly pay when due the payments on the debt evidenced by the Note and any prepayment and the late charges due under the Note:
- Application of Payments. Unless applicable law provides otherwise, all payments received by Trustee shall be apriled; first, to late charges due under the Note; second, to prepayment charges due under the Note, third, to interest due; and last, to principal due.
- Condemnation. The proceeds of any award or claim for damages, direct or consequential. in connection with any condemnation or other taking of any part of the Premises, or for conveyance in lieu of condemuation, are hereby assigned and shall be paid to Trustee.

In the event of a total taking of the Frenises, the proceeds shall be applied to the sums secured by the Trust Deed whether or not then due, with any excess paid to Mortgagor.
