East of the Third Principal Meridian, Cook County, Illinois (the "Trustees of Schools"), to execute a Quit Claim Deed to The Illinois State Toll Highway Authority (the "Authority") conveying the parcel of real estate, commonly known as the Dosher School and site, which is located at 8000 South Cork Avenue, Justice, Illinois and is legally described in attached Exhibit A (the "Property").
