KNOW ALL MEN BY THESE PRESENTS, that BANK OF AMERICA ILLINOIS, a Illinois banking corporation, (the "Bank"), 231 S. 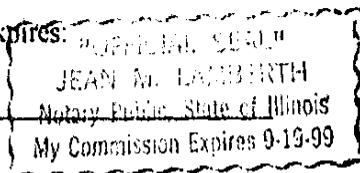
