#### THE COVENANTS, CONDITIONS AND PROVISIONS PREVIOUSLY REFERRED TO ARE:

- U. Promises of Borrower -- Borrower represents and warrants that:
  - a. Ikurrower owns the Property:
  - b. Iterrower has the right to mortgage, grant, and convey the Property to Trustee; and
  - . There are no claims or charges outstanding against the Property except any mortgages or trust deeds that are currently shown in the office where real estate records are filed for the County where the Property is located.

Borrower gives a general warranty of title to Trustee on behalf of the Holder of the Note. This meens that Borrower will be fully responsible for any losses which Trustee on behalf of the Holder of the Note suffers because someone other than Borrower has some of the rights in the Property that Borrower represents and warrants to have. Borrower will defend ownership of the Property against any claims of such rights.

- 2. Borrower's Promise to Pay The Agreement. Borrower promises to promptly pay all amounts due on the Agreement except as explained in prograph 9.
- 3. Borrower's Promise to Thy -- Charges and Assessments. Borrower promises to pay all present and future liens, taxes, assessments, utility bills, and odor charges on the Property, including any amounts on any prior mortgage or trust deed, as they become due.
- 4. Borrower's Promise to Buy Hazard Insurance. Rorrower promises to obtain a hazard insurance policy payable to Trustee for the benefit of the Holder of the Note, and which covers all buildings on the Property. The insurance must be satisfactory to the Holder of the Note and must cover loss or damage caused by fire and hazards normally covered by "extended coverage" hazard insurance policies. The insurance must be in the amounts and for the periods of time required by the Holder of the Note. Borrower will notify the Holder of the Note promptly if there is any loss or damage to the Property. The Trustee or Holder of the Note may file r Proof of Loss" form with the insurance company. Borrower directs the insurance company to pay all "proceeds" to Trustee for the benefit of the Holder of the Note. "Proceeds" are any money that the insurance company owes to the Borrower under the policy. Unless the Holder of the Note agrees in writing that the Proceeds can be used differently, the Proceeds will be applied to pay the amount Borrower owes the Holder of the Note.

If any Proceeds are used to reduce the amount which Borrower cares the Holder of the Note under the Agreement, Borrower will still have to make the regular payments under the Agreement until the entire amount Borrower owes is paid in full. If Trustee forecloses this Trust Deed on behalf of the Holder of the Note, anyone who buys the Property at the foreclosure sale will have all the rights under the insurance policy.

- 5. Borrower's Promise to Buy Flood Insurance. If the Land or any part of the Land is located in a designated official flood-hazard area, Borrower promises to buy flood insurance in the maximum amount available or the amount secured by this Trust Died, whichever is less. Borrower agrees to direct that any money payable under the Tood insurance will be paid to Trustee on behalf of the Holder of the Note, but Borrower will still have to make regular payment under the Agreement until the cutive amount Borrower owes is paid in full.
- 6. Boncower's Promise to Maintain and Repair the Property. Borrowers shall (a) promptly repair restore and rebuild any buildings or improvements now or hereafter on the Property which may become damaged or be destroyed; (b) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the Property superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Holder of the Note, (d) complete within a reasonable time any building or buildings new or at any time in process of erection upon said Property; (e) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof; (f) make no material alterations in said Property except as required by law or municipal ordinance.
- 7. Trustee/Holder of the Note Right to Take Action to Protect the Property. If (1) Borrower does not keep Borrower's promises and agreements made in this Trust Deed, or (2) someone (Borrower or anyone else) begins a legal proceeding that may significantly affect Trustee's or the Holder of the Note's rights in the Property (such as, for example, a legal proceeding in bankruptcy, or to condemn the Property), then Trustee or the Holder of the Note may do and pay for whatever is necessary to protect the value of the Property and the rights of Trustee or the Holder of the Note in the Property. Actions of the Trustee or the Holder of the Note under this section may include, for example, paying any amount due under any prior mortgage or trust deed, appearing in court, paying reasonable attorneys' fees, and entering on the Property to make repairs.

Borniwer promises to just Trustee or the Holder of the Note all amounts that either Trustee or Holder of the Note pays under this section. If Trustee and/or Holder of the Note pays an obligation, Trustee and/or Holder of the Note will have all of the rights that the person paid by Trustee or the Holder of the Note would have had against Borrower. This Trust Deed devers all these amounts that Trustee or Holder of the Note pays, plus interest, at the rate that is figured as if the money had been given under the Agreement, or if that rate violates the law, then at the highest rate that the law allows. This Trust Deed also covers reasonable con pensation to Trustee for each matter concerning which action herein authorized may be taken.

If Borrower fails to maintain insurance on the Property as required in paragraphs 4 or 5, the Trustee or the Holder of the Note may purchase insurance on the Property, without notice to Borrower and charge Boxrower for the coat as provided in this Trust Deed. If the Trustee or the Holder of the Note purchases this insurance, it will have the right to select the agent. Any hazard insurance and or flood insurance purchased by the Trustee or Holder of the Property may be limited to the amount due under the Agreement at the time the insurance is purchased, even in the Property is worth more. The Trustee or the Holder of the Note is not required to obtain the lowest cost insurance that might be available.

- 3. Rights of the Trust's and Holder of the Note. Any failure or delay by the Trustee or the Holder of the Note in enforcing the rights available to them in this Trust Deed or the law, will not cause the Trustee or Holder of the Note to give up those rights. The Trustee or Holder of the Note may exercise and enforce any of its rights until its rights under the Trustee or the Holder of the Note is separate. The Trustee or Holder of the Note may enforce and exercise from one at a time or all at once.
- 9. Joint Borrowers. Each person that right this Trust Deed is responsible for keeping all of the promises made by the Borrower. Trustee or Holder of the Note may choose to enforce their rights against anyone signing the Trust Deed as an individual or against all of them. However, if someone signed this Trust Deed, but did not sign the Agreement, then that person will not be required to pay any amount under the Agreement, but will have signed only to give Trustee or Holder of the Note the rights that person has in the Property under the terms of this Trust Deed.
- 10. Selling the Property. Borrower agrees not to sell or 'am fer all or any part of the Property, or any rights in the Property, including the sum or transfer of the beneficial ownership in the Property where Borrower is a Land Trum, without the written consent of the Fielder of the Note. This includes sale by Contract for Deed
- 11. No Defaults Under Prior Mortgages. If there is already a mortgage or deed of trust against the Property, the Borrower promises that there will a ever be a default under that mortgage or deed of trust.
- 12. Request for Notice of Default and Foreclosure. Borrower and Trustee, on const of the Holder of the Note request the holder of any mortgage, deed of trust or other encumbrance with a lien which has referrity over this Trust Deed to give Notice to Trustee, at Trustee's address set forth on page one of this Trust Deed, of any default under the superior encumbrance and of any side or other foreclosure action.
- 13. No Other Morigages or Deed of Trust. Borrower agrees not to morigage or encumber by a fixed of trust all or any part of the Property or siless anyone else to have a lien on the Property without the Holder of the Note is written consent.
- 14. Trustee/Holder of the Note Remedies and Foreclosure. If Trustee or Hulder of the Note require Porrower to pay the entire outstanding between under the Agreement in one payment (called "acceleration") and Borrower fails to make the payment when due, thes Holder of the Note or Trustee may foreclose this Trust Deed as provided below. However, before accelerating, the Trustee or the Holder of the Note will send Borrower a written notice by certified mail which states:
  - a. The promise that Barrower failed to keep or the representation or warranty that Borrower breached;
  - b. The action Borro was must take to correct that failure:
  - o. The date, at least 30 days away, by which the failure must be corrected;
- d. That if Borrower closen't correct the failure or the representation or warranty that Borrower breached, Trustee or Holder of the Note will accelerate, and if Borrower doesn't pay, Trustee or another person may buy the Property at a foreclosure sale:
  - That Illinois law allows Borrower to reinstate the Trust Deed after acceleration; and
- f. That Borrower may bring suit in court to argue that all promises were kept and to present any other defenses Borrower has to societation.

Trustee or Holder of the Note need not send the notice if the promise Borrower failed to keep consists of Borrower's sale for transfer of all or a part of the Property or any rights in the Property without the written consent of the Holder of the Note. If borrower does not correct the failure by the date stated in the notice, Trustee or Holder of the Note may accelerate. If Trustee or Holder of the Note accelerates, Trustee or Holder of the Note may foreclose this Trust Deed according to the illinois Statues. Borrower give Trustee/Holder of the Note a power to sell the Property at a public auction. Borrower also agrees to pay all attorneys' fees of Trustee or Holder of the Note and Trustee's fees for the foreclosure in the maximum amount allowed by law.

The proceeds of any foreclosure sale of the property shall be distributed and applied in the following order of priority: Pirst, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the proceding paragraph hereof; second, all other items which under the same hereof constitute secured indebtedness additional to that evidenced by the Agreement with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Agreement; fourth, any overplus to Borrower, their hairs, legal representatives or assigns, as their rights may appear.

15. Appointment of Reviver. Upon, or at any time after the filing of a bill to foreclose this Trust Deed, the court in which such bill is filed may appoint a receiver of said Property. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Borrower at the time of application for such receiver and without regard to the then value of the Property or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said property during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full attentory period of redemption, whether there be redemption or not, as well as during any further times when Borrower, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management, and operation of the Property during the whole of said period.

The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (a) The indebtedness secured hereby, or by any decree receiving this Trust Deed, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale and (b) the deficiency in case of such and deficiency.

- 16. Defenses. No action for the unforcement of the ilen or of any provision become shall be subject to any defense which would not be good and available to the party interposing same in an action at law upon the notes hereby secured.
- 17. Right of Inspection. Trustee or the Holder of the Note shall have the right to inspect the Property at all reasonable times and access thereto shall be permitted for that purpose.
- 18. Trustee's Obligations. Trustee has no duty to examine the title, location, existence, or condition of the Property, or to inquire into the validity of the signatures or the identity capacity, or authority of the signatories on the Agreement or the Trust Deed, nor shall Trustee be obligated to record this Trust Deed or to exercise any power horsin given unless expressly obligated by the terms hereof, nor be liable for any sous or ambasions hereunder, except in case of its own gross negligence or misconduct or that of the agents or employers of Trustee, and it may require indemnities satisfactory to it before exercising any power horsin given.
- 19. Release. Trustee abili release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the Agreement, representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the genuine Agreement herein described any Agreement which bear an identification number purporting to be placed thereon by a prior trustee hereunder or which conform in substance with the description herein contained of the Agreement and which purport to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original Trustee and it has never placed its identification number on the Agreement described herein, it may accept as the genuine Agreement herein described any agreement which may be presented and which conform in substance with the description herein contained of the Agreement and which purport to be executed by the persons herein designated as makers thereof. Borrower shall pay all costs associated with services provided by Trustee in connection with the Trust Deed, including but not limited to the Trustee's fees for the release of this Trust Deed and the costs of recordation of the release.
