- Mortgager shall (1) promptly repair, restore or rebuild any buildings or improvements, now or hereafter on the mortgaged Premises which may become damaged or be destroyed: (2) keep said mortgaged Premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof, (3) pay when due any indebtedness which may be secured by alien or charge on the mortgaged Premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time, any building or buildings now or at any time in process of erection upon said mortgaged Premises; (5) comply with all requirements of law or municipal ordinances with respect to the mortgaged Premises and the use thereof; (6) make no material alternations in said mortgaged Premises except as required by law or municipal ordinance.

Unless the property is declared exempt, Mortgagor shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the mortgaged Premises when due, and shall, upon written request, furnish to the Mortgagee duplecate receipts therefor. To prevent default hereunder, the Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which the Mortgagor may desire to contest.

Any surplus which may remain out of said award after payment of such cost of rebuilding and restoration shall, at the option of Mortgagee, be applied on account of the indebtedness secured hereby or be paid to any other party entitled thereto.

In case of default therein, Mortgagee may, but need not, make any payment or perform any act hereinbefore required of Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said mortgaged Premises or contest any tax or assessment. - Mortgagor shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the opinion of Mortgagee and without notice to Mortgagor all unpaid indebtedness secured by this Mortgage shall, notwithstanding anything in the Note or in this Mortgage to the contrary, become due and payable (a) immediately in the case of default in making payment of any installment of principal or interest on the Note, or (b) when default shall occur and continue for ten (10) days in the performance of any other agreement of the Mortgagor herein contained.

 - The terms "hazardous waste," "hazardous substance," "disposal," "release," A. and "threatened release," as used in this Mortgage, shall have the same meanings as set forth in the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended, 42 U.S.C. Section 9601, et seq. ("CERCLA"), the Superfund Amendments and Reauthorization Act of 1986, Pub. L. No. 99-499 ("SARA"), the Hazardous Materials Transportation Act, 49 U.S.C. Section 1801, et seq. the Resource Conservation and Recovery Act, 49 U.S.C. Section 6901, et seq., or other applicable state or Federal laws, rules, or regulations adopted purcuant to any of the foregoing. Mortgagor represents and warrants to Mortgagee that: (a) During the period of Mortgagor's ownership of the mortgaged Premises, there has been no use, generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous waste or substance by any person on, under, or about the mortgaged Premises; (b) Mortgagor has no knowledge of, or reason to believe that there has been, except as previously disclosed to and acknowledged by Mortgagee in writing, (i) any use, generation, manufacture, storage, treatment, disposal, release, or threatened release of any

Mortgagor hereby (a) releases and waives any future claims appliest Mortgagee for indemnity or contribution in the event Mortgagor becomes it alle for cleanup or other costs under any such laws, and (b) agrees to indemnify and hold harmless Mortgagee against any and all claims, losses, liabilities, damages, penalties, and expenses which Mortgagee may directly or indirectly sustain or suffer resulting from a breach of this Paragraph of this Mortgage of as a consequence of any use, generation, manufacture, storage, disposal, release occurring prior to Mortgagor's ownership or interest in the Premises, whether or not the same was or should have been known to Mortgagor. The provisions of this Paragraph of this Mortgage, including the obligation to indemnify shall survive the payment of the Indebtedness and the satisfaction and reconveyance of the lien of this Mortgage and shall not be affected by Mortgagee's acquisition of any interest in the mortgaged Premises, whether by foreclosure or otherwise.
