- A. "Assignee" shall mean Pioneer Bank and Trust Courany.
- B. "Assignment" shall mean this Assignment of Leases and Revis.
- C. "Assignor" shall mean Jose A. Desarden and Rosaura Lugo.
- D. "Assignor's Liabilities" shall mean the indebtedness of the liabilities of Lie A. Desarden and Rosaura Lugo pursuant to the Note or other Loan Instruments and the obligation and liabilities of Jose A. Desarder and Rosaura Lugo, pursuant to the Guaranties, to the Assignee of every kind, nature and description, whether direct or indirect, absolute or contingent, now or hereafter owing, together with the performance and observance of all covenants and obligations made by the Assignor in favor of the Assignes.

- H. "Guaranty" shall mean the Guaranties of even date herewith executed by Jose A. Desarden and Rosaura Lugo and any and all agreements executed in Assignor's favor guaranteeing, insuring or otherwise securing the obligations of any Lessee under any of the Leases, together with all rights, powers, privileges and other benefits of the Assignor thereunder.
- 1. "Leases" shall mean all oral and written leases with or without other agreements for the use and occupancy made by any person or entity for the use, occupancy or enjoyment of the Mortgage Property or the avails thereof, including all renewals, extensions, amendments, modifications and replacements thereof, whether now existing or hereafter arising.
- J. "Loan" shall mean that certain extension of credit by the Assignee to the Assignor and guaranteed by Jose A. Desarden and Rosaura Lugo, in an original principal amount of Fifty Thousand and 00/100 Dollars (350,000,00) all as evidenced by the Loan Instruments.
- K. "Loan Instruments" shall mean this Assignment, the Note, the Mortgage, any and all other agreements or understandings given to secure the payment of the indebtedness evidenced by the Note or in connection with the Loan and all renewals, axtensions, amendments, modifications and replacements thereof.
- L. "Mortgage" shall mean that certa'n Real Estate Mortgage of even date herewith securing the indebtedness evidenced by the Note, executed by the Assignor and pertaining to the Mortgaged Property.
- M. "Mortgage Property" shall mean the real property described in Exhibit "A" hereto and all improvements thereon and appurtenances thereto.
- N. "Note" shall mean that certain Secured Promissory Note of even date herewith evidencing the Loan executed by the Assignor and delivered to the Assignee.
- 0. "Rents" shall mean all sums which are due or may hereafter become due, whether pursuant to any of the Leases or otherwise from any Lessee, user or occupant of the Mort sage! Property to the Assignor, including, without limitation security deposits, insurance or condemnation proceeds or awards, damages or other sums.
- P. "Rights" shall mean all rights, powers, privileges, options and other benefits of the Assignor under the Leases, including but not limited to:
- 1. The immediate and continuing right to receive and collect all rents, income, revenues, issues, profits insurance proceeds, condemnation awards, monies and security deposits or the like;
- 2. The right to make all waivers and agreements, including any waivers pertaining to the obligations of lessees:
- 3. The right to give all notices, permissions, consents and releases, including consents to any instruments which subordinates or makes paramount the interest of a lessee to the Mortgage;
- 4. The right to take such action upon the happening of a default under any of the Leases (including commencement, conduct and consummation of proceedings at law or in equity) as shall be permitted under any provisions of the Leases or by law;
- 5. The right to do any and all other things whatsoever which Assignor is or may become entitled to do under the Leases including, without limitation, the right to cancel or alter Leases;

Granting Clauses

In consideration of the Loan to secure the payment of the indebtedness evidenced by the Note, to secure the payment of all amounts due under and the performance and observance of all covenant, conditions and obligations contained in the Loan Instruments and to secure Assignor's payment of all other Loan Instruments, Assignor hereby assigns to Assignee, all of the right, title and interest of Assignor in:

and Assignor authorizes Assignee:

- a. to manage the Mortgeged Property and take possession of the books and records relating thereto;
- b. to prosecute or defend any suts in connection with the Mortgaged Property or enforce or take any other action in connection with the League in the name of Assignee;
- c. to make such repairs to the Mortgaged Poperty as Assignee may deem advisable; and
- d. to do any and all other things with respect to the Mortgaged Property and the Collateral which an absolute owner or landlord has the right to do.

Covenants and Warranties

- A. Notwithstanding that this Assignment constitutes a present assignment of leases and rents, Assignor may collect the Rents and, subject to the terms and provisions of the Loap Documents, manage the Mortgaged Property in the same manner as if this Assignment had not been given, and only if and so long as an Event of Default has not occurred. If an Event of Default occurs, the right of Assignor to collect the Rents and to manage the Mortgaged Property shall terminate upon ten (10) days prior written notice of such default given by Assignee to Assignor and such right together with the other rights, powers and authorizations contained herein shall belong exclusively to Assignee.
- B. This Assignment confers upon Assignee a power coupled with an interest and cannot be revolved by Assignor.
- C. The Assignor represents and warrants as follows:
 - 1. Assignor is the sole owner of the lessor's entire interest in the Leases and the other Collateral has full right to assign the Collateral;
 - 2. There has been no previous assignment and, without Assignee's prior written consent, Assignor will permit no future assignment (as collateral or otherwise) of the lessor's right, title or interest in any of the Leases or other Collateral:
 - 3. The Leases are valid and enforceable in accordance with their terms and have not been altered, modified or amended in any manner whatsoever,

- 4. The lessees are not in default under the Leases and have no defenses, set-offs or counterclaims against the lessor under the Leases and have not been granted any waiver, release, reduction, discount, discharge, compromise or other concession by the lessor;
- 5. Assignor shall not permit or suffer to occur any default in the performance of any of its obligations under the Leasts, nor shall it permit or suffer any waiver of any of its rights or remedies pursuant to the Leases;
- 6. No rent reserved in the Leases has been assigned; and
- 7. No rent for any period subsequent to the date hereof has been collected more than thirty (30) days in advance of the time when said Rent becomes or would become due under the terms of the Leases.

- 1. It will deliver to Assignee reports of the rental income and expenses of the Mortgaged Property in such reasonable detail and at such times as Assignee may require verified by the responsible operating official of the Mortgaged Property;
- 2. It will not materially modify, change, alter, supplement, amend, cancel, surrender or accept surrender of any of the Leases without the Assignee's consent;
- 3. It will not consent to the assignment or subletting of the lessee's interest under any of the Leases without the Assignee's cousent;
- 4. It will not accept Rent more than thirty (v) days in advance under any of the Leases; and
- 5. It will not assert any right of setoff or other claim or take any action against any lessee under any of the Leases, or other rise seek recovery, damages or other relief against any such lessee, which would have the effect of relieving such lessee from any obligation or histolity or which would effect, impair or discharge any right of Assigner and, if Assignor shall recover any such sums from such lessee, Assignor will forthwith pay over the same to Assignee for application to the indebtedness accured hereby. Assignor further covenants that if any Lease provides for the abatement of rent during repair of the premises demised thereunder by reason of fire or other cast alty, Assignor shall furnish to Assignee rental insurance in an amount and form and written by insurance cor spanies as shall be satisfactory to Assignee.
- E. Assignor shall execute and deliver, at the written request of Assignee, all such further assurances and assignments as Assignee from time to time shall determine are necessary to effectuate the terms and provisions of this Assignment.
- Assignce shall be deemed to be the creditor of each lessee under the Leases in any assignment for the benefit of creditors and bankruptcy, reorganization, insolvency, dissolution, receivership or probate producings affecting such I assee (without any obligation on the part of the Assignee to file claims or otherwise to pursue creditors rights in such proceedings). All Moines received in connection with any such proceedings or occurrences shall constitute additional Rents hereunder.

Defaults and Remedies

- A. If an Event of Default shall occur or be continuing:
 - Assignee may exercise its rights as provided in this Assignment without regard to the adequacy of the security and without waiving any other remedy available to Assignee and without waiving such Event of Default;

- 2 In the event Assignce elects to invoke any of its rights hereunder or thereafter, for any reason, relinquishes to Assignor such rights, this Assignment shall not be terminated, but shall remain in full force and effect until Borrower's Liabilities are paid in full, it being the intent of the parties that Assignee shall, until release of this Assignment, have all the rights granted hereby and be able to exercise then from time to time if an Event of Default occurs.
- B. No delay or omission on the part of Assignee in the exercise of any remedy for an Event of Default shall operate as a waiver thereof. The remedies available to Assignee under this Assignment shall be in addition to, and exercisable in any combination with, any and all remedies available by operation of law and under the other Loan Instruments. Said remedies shall be cumulative and concurrent, may be pursued separately, successfully or to gether against Assignor or the Mortgaged Property at the sole discretion of Assignee and may be exercised as often as occasion therefor shall arise.
- C. Assignee ms, apply the Rents, in such order as Assignee may determine, to the payment of Assignor's Liabilities and real expenses for the care and management of the Mortgaged Property, including taxes, insurance, assessments management fees, usual and customary commissions to real estate brokers for leasing real estate and the reasonable expenses and fees of all attorneys, agents and employee engaged in connection with the exercise rights and powers granted to Assignee hereunder. For purposes of the preceding sentence, attorneys' fees shall be deciment to include compensation and actual overhead of staff counsel, if any, of Assignee in add tion to the fees of any other attorneys engaged by Assignee and shall include fees and expenses incurre 1 in connection with the appeal of any matter arising under the Loan Instruments if Assignee is the prevailing party therein.
- D. The receipt by Assignee of any Rents pursuant to this Assignment following and Event of Default and the exercise of any remedies provided for herein of in the other Loan Instruments shall not cure such Event of Default or affect or projudice the exercise of such remedies.
- E. Assignee's obligations as to any Rents actually collected and be discharged by application of such Rents to any of the purps ses specified in subparagraph C, above. Assignee shall not be liable for uncollected Rents or for failure to collect Rents or for any claim for damages or secoffs exising out of Assignee's management of the Mortgaged I roperty. Assignee shall not be liable to any lessee for the return of any security deposit made under any Lease unless Assignee shall have received such security deposit from the Assignor or such lessee. Assignee shall not by reason of this Assignment or the exercise of any right granted herein be obligated to perform any obligation of the lessor under any of the Leases, nor shall Assignee be responsible for any act committed by the lessor, or any breach or failure to perform by the lessor with respect to any of the Leases. Nothing contained herein shall be deemed to have the effect of making Assignee a morgagee in possession of the Mortgaged Property or any part thereof.
- F. Assignor shall reimburse Assignee for and indemnify Assignee against all expenses, losses, clamages and liabilities which Assignee may incur by reason of this Assignment or the exercise of any of the tights granted hereunder. Any and all amounts due any payable, shall be added to Assignor's Liabilities, shall bear interest at the Default I ate and shall be secured by this Assignment, and the other Loan Instruments.
- G. Each present and future lessee under any of the Leases is hereby authorized and directed to pay the rent payable thereunder to Assignee upon written demand from Assignee stating that an Event of Default has occurred with ut inquiry as to whether any such default has occurred or whether Assignee is rightfully entitled to such rent. Following receipt of any such demand, no lessee shall be given credit for any rent paid other than to I ssignee thereafter until Assignee instructs such lessee otherwise in writing.
