WILLIAM MCVEY DECLARATION OF TRUST DATED ATRIL 4, 1996, of 730 South Fairview Avenue, Park Ridge, Illinois 60068-4748, (hereinafter referred to as "said truste", regardless of the number of trustees) and unto all and every successor or successors in trust under said declaration of trus. the following described real estate in the County of Cook and State of Illinois, to-wit: AN UNDIVIDED ONE-HALF INTEREST IN: Lot 30 and the West 5 feet of Lot 31 in Benjamin Lombard's Subdivision of Block 50 in Subdivision of Section 19, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

TO HAVE AND TO HOLD the said premises with the argumentances upon the trusts and for the uses and purposes herein and in said declaration of trust set forth.

The interest of each and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to said real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid.

And the said grantors hereby expressly waive and release any and all right or benefit under and by virtue of any and all statutes of the Strae of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
