- Payments. Borrower shall promptly pay when due all payments evidenced by the Installment Contract. All scheduled monthly payments of the amount financed and the time price differential, or finance charge, shall be applied first to the finance charge and the remainder, if any, to the amount financed. - 14. Assignment of Rents; Appointment of Receiver.
