THIS FLEXEQUITY MORTGAGE is made this 23rd day of August 1996 by and between

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road,  
Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated  
August 23, 1996 (herein "Note"), with a credit limit of  
One Hundred Thousand Dollars and no/100  
dollars (\$ 100,000.00) (a minimum amount of \$10,000.00) of which an initial advance of  
XXXXXXXXXXXXXXXXXXXX (XXXXXX) has been made and  
against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount  
thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total  
amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note  
provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of  
principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner  
paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and  
convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey)  
unto Lender and its successors and assigns, the following described property located in the County of Cook, State

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgage, and ground rents on the property if any, plus one-twelfth of yearly premium installments for hazard insurance ("Funds").

1. PAYMENT AND COMPLIANCE WITH NOTE: APPLICABILITY OF PAYMENTS, Borrower shall promptly pay when charges imposed under the Note, and the principal and interest on any future Advances or other charges imposed under the Note, and the principal and interest on any future Advances (as defined in Paragraph 27 below) secured by this Mortgage. Unless otherwise agreed, all payments received under the Note and this Mortgage shall be applied by Lender first in Payment of any additional sums owing to Lender pursuant to the provisions of the Credit Documents, whether as advances, attorney's fees (to the extent permitted by law) or liquidated damages or otherwise.

**Covenants.** Borrower and Lender covenant and agree as follows:

**THIS MORTGAGE IS GIVEN TO SECURE:** (i) the repayment of all other sums, with interest thereon, advanced or the irredeemable advances evidenced by the Note; (ii) the payment of all costs of collection, advances in accordance with the Note; (iii) the performance of all covenants and agreements held by a Trust, in the Flexible Security Agreement (the "Security Agreement") of Mortgagor; and (iv) the property is held by a Trust, in the Flexible Security Agreement (the "Security Agreement") of Borrower; and, if little to the property is held by a Trust, in the Flexible Security Agreement (the "Security Agreement") of Borrower; and all instruments now or hereafter even date herewith, The Note, the Security Agreement, this Mortgage and any and all instruments now or hereafter given to evidence or secure the indebtedness evidenced by the Note are collectively referred to herein as the "Credit Documents". Insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower Interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds, if any, are pledged as additional security for the sums secured by this Mortgage, and are held by Lender as a creditor and not as a trustee.

If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

**3. PRIOR ENCUMBRANCE; CHARGES; LIENS.** Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

**4. HAZARD INSURANCE.** Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage" and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

6. **PROTECTION OF LENDER'S SECURITY.** If Borrower fails to perform the covenants and agreements contained in this Mortgage or in the Credit Documents, or if any action or proceeding is commenced against Borrower by virtue of the rights of powers of attorney heretofore granted, including but not limited to committal domain, insolvency, code enforcement or arrangements involving a bankruptcy or decedent, then Lender's interest in the property or the rights of powers of attorney heretofore granted, including but not limited to committal domain, insolvency, code enforcement or arrangements involving a bankruptcy or decedent, which Lender without demand upon Borrower but upon notice to Borrower pursuant to Paragraph 11 hereof, may, without releasing Borrower from any obligation in this Mortgage, make such application as Borrower has received from its attorney, and take such action as Lender deems necessary to protect the security of this Mortgagor. **5. PRESERVATION AND MAINTENANCE OF PROPERTY; LEGENDS; CONDOMINIUMS;** PLANNED UNIT DEVELOPMENTS. Borrower shall use, improve and maintain all Property in compliance with applicable laws, statutes, ordinances, regulations, decrees or regulations, shall keep the Property in good condition and repair including the repair or restoration of any improvements or deterioration of the Property, and shall manage or destroy, shall not commit or permit waste or impairment of any property or fixtures, and shall fully and promptly comply with the provisions of any lease in this Mortgage is on a lesseehold. If the Property is abandoned by Borrower or if Borrower fails to respond to Lender in writing within thirty (30) calendar days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at Lender's sole option or restoration of property or to the sums secured by this Mortgage.

Subject to the rights and terms of any mortgage, deed of trust or other security agreement with a hen which has or appears to have any priority over this Mortgage and unless Borrower and Lender otherwise agree in writing insurance proceeds shall be applied to repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall not cure or waive any economic liability resulting from the damage, unless the sum so paid is applied to the repair of the Property.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

The insurance carrier provided the insurance shall not be chosen by Borrower to approve such to approval by Lender; provided, that such approval provided the insurance shall be reasonably withheld. All insurance policies and renewals thereto shall be in a form acceptable to Lender. Lender shall have the right to hold the policies and renewals thereto subject to the terms of any mortgage. Each of the other security agreements will be held in trust for the benefit of the Lender until payment in full of the principal and interest due under the Note and until the Lender has received payment in full of all amounts due under the Note and all other obligations of the Borrower to the Lender. Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDEMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

9. **BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER.** Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release in any manner the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof, Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission, or commission, to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by Lender. Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event. 13. REMEDIES COMMUNALIVE. As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. 
