UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal and interest indebtedness evidenced by the Nose and late charges as provided in the Note.
- 2. Funds for Taxes and insurance. Subject to applicable law or a written waiver by Lender. If the amount of the Funds held by Lender, together with the nature monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, that exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly installments of Funds. Lender is authorized to collect and apply the insurance proceeds at Lender's option either to instoration or repair of the Property or to the sums secured by this Morrgage.

- 6. Preservation and Maintenance of Property; Leaseholds; Condominiums; Planned Unit Developments.
