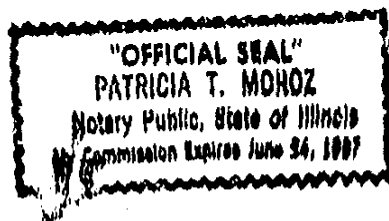

LEGAL DESCRIPTION:

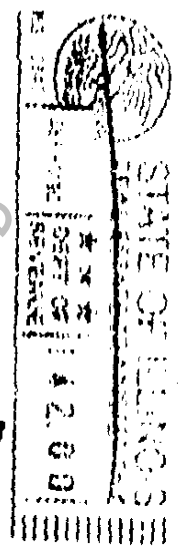
