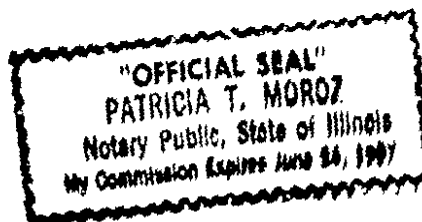

### LEGAL DESCRIPTION:

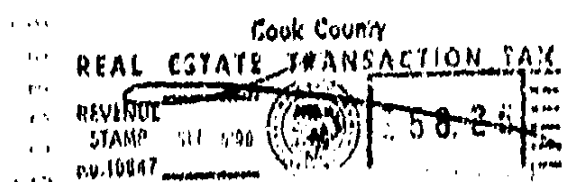
