BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grent and convey the Property and that the Property is unencumbered, except for encumbrances of record. - 13. Loan Charges. If the loan secured by this Security instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. - 15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. 26TH THIS BALLOON RIDER is made this day of JUNE 1996 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to RESOURCE BANCSHARES MORTGAGE GROUP, INC.

(the "Leruer") of the same date and covering the property described in the Security Instrument and located at:

The interest rate state 1 on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may 'can'sfer the Note, Security Instrument and this Rider.
