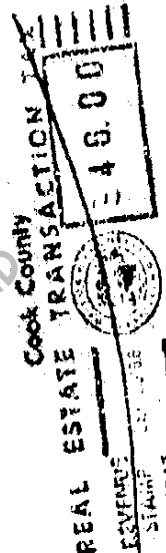
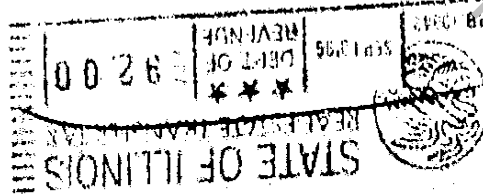

Unit 547 ~~and Parking Space~~ ~~XXXXXXXXXXXXXXXXXXXX~~ in the 1000 West Washington Lofts Condominium as delineated on the Survey of Block 41 (except the South 125.75 Feet thereof, and except that part taken for Randolph Street) in Carpenter's Addition to Chicago, being a Subdivision of the Southeast 1/4 of Section 8, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois, which Survey is attached as Exhibit "A" to the Declaration of Condominium Ownership recorded MARCH 29, 1996 as Document 96240128, together with an undivided percentage interest in the Common Elements appurtenant to said Unit as set forth in said Declaration as amended from time to time.
