THIS MORTGAGE IS DATED AUGUST 30, 1996, between David Loughnane wik/a/ David J. Loughnane and Lealie Loughnane a/k/a Lealie C. Loughnane, husband and wife, whose address is 1064 Elm Street, Winnetka, IL 60093 (referred to below as "Grantor"); and The Northern Trust Company, whose address is 50 S. GRANT OF MORTGAGE. extensions of, modifications of, refinancings of, consolidations of, and substitutions for the Credit Agreement. The maturity date of this Mortgage is August 15, 2001. The interest rate under the Credit Agreement is a variable interest rate based upon an index. The index currently is 8.250% per annum. The Credit Agreement has tiered rates and the rate that applies to Borrower depends on Borrower's credit limit. The interest rate to be applied to the credit limit shall be at a rate 1.000 percentage points above the index for a credit limit of \$49,999.99 and under and at a rate 0.500 percentage points above the index for a credit limit of \$50,000.00 and above, subject however to the following maximum rate. Under no circumstances shall the interest rate be more than the lesser of 20.000% per annum or the maximum rate allowed by applicable law.

Compliance With Laws. Grantor warrants that the Property and Grantor's use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

EXISTING INDERTEDNESS. The following provisions concerning existing indebtedness (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lien. The lien of this Mortgage securing the Indebtedness may be secondary and inferior to an existing iien. The obligation has the following payment terms: monthly installments of principal and interest. IMPOSITION OF TAXES, FEES AND CHARGES BY GOVERNMENTAL AUTHORITIES. The following provisions relating to governmental taxes, fees and charges are a part of this Mortgage:

Current Taxes, Fees and Charges.
