1. ASSIGNMENT. a. Grantor has the power and authority to execute this Assignment.

I. Grantor has not performed any act or executed any instrument which might prevent Lender from collecting rents and taking any other action under this Assignment.

- 5. GRANTOR MAY RECEIVE RENTS.
