RECITALS:

The Board administers the condominium property located in the Village of Prospect Heights, County of Cook, State of Illinois, whose legal description is attached hereto, made a part hereof and marked as Exhibit A. The Amended and Restated Declaration of Condominium Ownership, Covenants, Conditions, Restrictions, Easements and By-Laws of the Quincy Park Homeowners' Association was recorded on June 29, 1994 with the Recorder of Deeds of Cook County, Illinois as Document No. 94569560, and amended by First Amendment to Amended and Restated Declaration of Condominium Ownership, Covenants, Conditions, Restrictions, Easements and By-Laws of Quincy Park Homeowners' Association recorded December 16, 1994 with the Recorder of Deeds of Cook County, Illinois as Document No. 04051185 (the "Declaration").

The Board of Directors has determined that, in the course of merging Quincy Park Condominium Association Numbers 1, 2, 3, and 4 into the Quincy Park Homeowners Association ("Association"), provisions were not made to reallocate the percentages of ownership for each of the five hundred ninety-two (592) units in the Association; and

As a result of the merger, the percentage of ownership for the units presently exceeds one hundred percent (100%); and

Pursuant to Section 27(b)(2) of the Illinois Condominium Property Act, 765 ILCS 605/27(b)(2), the Board of Directors may correct scrivener's errors in a condominium declaration where the percentages of ownership referenced in the document exceed one hundred percent (100%).

Given the relative similarity in size and values of Units, the Board desires to amend the Declaration to assign the same percentage of ownership to each Unit listed on Exhibit B; and

Section 27(b)(2) of the Illinois Condominium Property Act states that scrivener's errors in a Declaration may be corrected by an Amendment approved by two-thirds (2/3) of the members of the Board of Directors; and that the Amendment shall become effective upon recording; and

The Amendment set forth herein has been approved by the affirmative vote of not less than two-thirds (2/3) of the members of the Board of Directors at a meeting.

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. The text of Article One, Section 1.25 to the Declaration, entitled Undivided Interest, is hereby deleted in its entirety, and the following is substituted in its place and stead:

"The percentage of ownership in the Common Elements assigned to each Unit is .16891%."

2. Exhibits D-1 through D-4 are hereby deleted in their entirety.

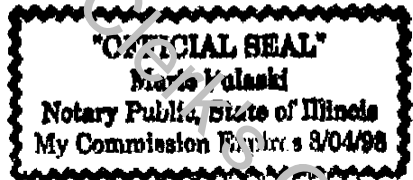

**EXHIBIT "A" TO SECOND AMENDMENT
TO AMENDED AND RESTATED DECLARATION OF CONDOMINIUM
OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS
AND BY-LAWS FOR
QUINCY PARK HOMEOWNERS ASSOCIATION**

(Legal Description)

That part of the SW 1/4 of the NW 1/4 of Section 24, Township 42 North, Range 11 East of the Third Principal Meridian described as follows:

Beginning at the Southeast corner of said NW 1/4; thence N. 89°-18' W. along the South line of said NW 1/4, a distance of 451 feet; thence N. 0°-42' E. at right angles to last described line, a distance of 132.90 feet to a point of curvature; thence Northwestery along an arc of a circle, having a radius of 170 feet, being convex to the Northeast and tangent to last described line at the last described point, an arc-distance of 56.48 feet to a point of tangency; thence N. 18°-20'-10" W. a distance of 145.61 feet to a point of curvature; thence Northwestery along an arc of a circle, having a radius of 333 feet, being convex to the Southwest and tangent to last described line at the last described point, an arc-distance of 110.64 feet to a point of tangency; thence N. 0°-42' E., a distance of 291.39 feet; thence S. 89°-18' E. and parallel with the South line of said N.W. 1/4, a distance of 200 feet; thence N. 0°-42' E. at right angles to last described line, a distance of 22 feet; thence S. 89°-18' E. and parallel with the South line of said N.W. 1/4, a distance of 102.25 feet; thence N. 0°-42' E. at right angles to last described line a distance of 36.50 feet more or less to the intersection with a line drawn parallel with the South line of said S.W. 1/4 from a point on the East line of said N.W. 1/4, which is 784.56 feet North of the Southeast corner of said N.W. 1/4; thence S. 89°-18' E. along said parallel line, a distance of 224.17 feet more or less to the East line of said N.W. 1/4; thence S. 0° E. along the East line of said N.W. 1/4, a distance of 784.56 feet to the Southeast corner of said N.W. 1/4 and the place of beginning, all in Cook County, Illinois. (Excepting therefrom that portion dedicated as a public road as per plat of dedication recorded on September 2, 1971 in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 21608547.)
