BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. The Property includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and
certain common areas and facilities, as described in
(the "Declaration"), the Property is a part of a planned unit development known as

(iv) any action which would have the effect of rendering the public liability insurence coverage maintained by the Owners Association unacceptable to Lender.
