- 3. PURPOSE. This Mortgage and the Obligations described herein are executed and incurred for consumer purposes.

- 5. EXPENSES. To the extent permitted by law, this Mortgage secures the repayment of all amounts expended by Lender to perform Grantor's covenants under this Mortgage or to maintain, preserve, or dispose of the Property, including but not illulted to, amounts expended for the payment of taxes, special assessments, or insurance on the Property, plus interest thereon.
