

MODIFICATION AUD EXTENSION AGREEMENT

THIS INDENTURE made as of the 30th day of June, 1996, by and between BANK OF LINCOLNWOOD, an Illinois banking association ("Bank"), the owner and holder of the Note and Mortgage, hereinafter described, and Thomas Puckelwartz, Lynn Fuckelwartz, his wife, representing themselves to be the owners of the real estate hereinafter described and Brookwood Companies, a sole proprietorship ("Debtor"),

WITNESSETH:

WHEREAS, the Debtor has executed, as maker, that certain Time Revolving Business Loan Note and Security Agreement dated June 30, 1995, in the original principal amount of \$195,000.00 ("Note"), secured by a Mortgage in favor of Bank of Lincolnwood dated June 30, 1995, and recorded with the Recorder of Deeds of Cook County, Illinois on August 15, 1995, as Document No. 95537129 ("Mortgage") (the Note, Mortgage and all other documents relating thereto are the "Loan Documents"); and

WHEREAS, the outstanding principal balance of the Note as of the date hereof is \$194,484.18, and

WHEREAS, the Debtor has requested and the parties hereby agree, to modify and extend the terms and time of payment of the Note and Mortgage covering the real estate located in Cook County, Illinois, legally described as follows:

NOW THEREFORE, in consideration of the premises hereto, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. The Note and Mortgage are hereby modified to provide that the remaining indebtedness shall be repaid as follows: monthly payments of accrued interest beginning on the 30th day of July, 1996, and on the 30th day of each and every month thereafter with a final payment of all arpaid principal and interest due on the 30th day of June, 1997, all such payments to include interest at a rate equal to 1% in excess of the Prime Rate at Bank of Lincolnwood. All such payments on account of the indebtedness evidenced by the Note shall be first applied to interest on the unpaid principal balance and the remainder to principal.
- 2. Except as expressly herein provided, all of the terms, provisions, representations and warranties contained in the loan document, shall remain in full force and effect.
