1 PAYMENT OF PRINCIPAL AND INTEREST. Borrower shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or a written waiver by Londer, Borrower shall pay to Lender on the day monthly payments of principal and interest are payable under the Note, until the Note is paid in full, a sum therein "Funds") equal to one-twelfth of the yearly taxes and assessments (including condominum and planned unit development assessments, if any) which may attain priority over this Mortgage and ground rents on the

Property, if any, plus one-twelfth of yearly premium installments for hazard insurance, plus one-twelfth of yearly premium installments for morigage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof. Borrower shall not be obligated to make such payments of Funds to Lender to the extent that Borrower makes such payments to the holder of a prior morigage or deed of trust if such holder is an insutannual lender.

SELINOIS-HOME IMPROVEMENT-1/80-FNMA/FHEME UNIFORM INSTRUMENT

If Borrower pays Funds to Lender, the Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or state agency including Lender if Lender is such an institution. Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground fens. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender gays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of ejecution of this Mortgage that interest on the Funds shall be paid to Borrower, and unless such agreement is made or applicable law requires such interest to be paid. Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds are pledged as additional security for the sums secured by this Mortgage.

If the amount of the Funds held by Lender, together with the future monthly installments of Fund; payable prior to the due dates of taxes, assessments, insurance premiums and glound rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly installments of Funds. If the amount of the Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due. Borrower shall pay to Lender any amount necessary to make up the definition of more payments as Lender may require.

Upon payment in full it, all sums secured by this Mortgage, Lender shall promptly refund to Burrower any Funds held by Lender. If under paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender, at the time of application as a credit against the sums secured by this Mortgage.

3. APPLICATION OF PAYMENTS. Unless /polscable law provides otherwise, all payments received by Lender under the Note and paragraphs 1 and 2 hereof shall be applied by Lender first in payment or amounts payable to Lender by Borrower under paragraph 2 hereof, then to interest payable on the Note, and then to the principal of the Note.

4. PRIOR MORTGAGES AND DEEDS OF TRUST: CHARGES LIENS. Borrower shall perform all of Borrower's obligations under any mortgage, deed of trust or other recurrity agreement with a lien which has prior to over this Mortgage, including Borrower's covenants to make payments when due. Borrower shall pay or cause to be paid all taxes, assessments and other charges. This and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any.

5 HAZARD INSURANCE. In the event of loss, Borrower shall give prompt nonce to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

If Property is abandoned by Borrower, or if Borrower fails to respond to Leader with a 30 days from the date notice is mailed by Leader to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is authorized to collect, and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the sums recured by this Mortgage.

6 PRESERVATION AND MAINTENANCE OF PROPERTY, LEASEHOLDS; CONDOMINIUMS; et an NED UNIT DEVELOPMENTS. Borrower shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the evorcity and shall comply with the provisions of any lease if this Mortgage is on a leasehold. PROTECTION OF LENDER'S SECURITY. Nothing contained in this paragraph 7 shall require Lender to incur any expense or take any action bereunder.

8. ENSPECTION. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower nonce prior to any such inspections specifying reasonable cause therefor related to Lender's interest in the Property.

9 CONDEMNATIOS The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Leader, subject to the terms of any mortgage, deed of trust or other security agreement with a lieu which has priority over this Mortgage.

BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Lender to any successor in interest of Bornower shall not operate to release, in any manner, the liability of the original Borrower's successors in interest. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower of successors in interest. Any forheatance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a warner of or preclude the exercise of any such right or remedy.

11 SUCCESSORS AND ASSIGNS BOUND; JOINT AND SEVERAL LIABILITY, CO-SIGNERS. The coverages and agreements herein contained shall bind, and the rights hereinder shall inure to, the respective successors and assigns of Lender and Borrower subject to the provisions of paragraph 16 hereof. All toverages and agreements of Borrower shall be joint and several. Any Borrower who co-signs this Mortgage, but does not execute the Note, (2) is co-signing this Mortgage only to mortgage, grant and convey that Borrower's interest in the Property to Lender under the terms of this Mortgage, (b) is not personally liable on

the Note or under this Mortgage, and (c) agrees that Lender and any other Borrower hereunder may agree to extend, modify, forbear, or make any other accommodations with regard to the terms of this Mortgage or the Note without that Borrower's consent and without releasing that Borrower or modifying this Mortgage as in that Borrower's interest in the Property.

NOTICE. Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrower provided for in this Morigage shall be given by delivering it or by mailing such notice by certified mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Morigage shall be deemed to have been given to provide to Lender when given in the manner designated herein.

43 GOVERNING LAW: SEVERABILITY. The state and local laws applicable to this Morigage shall be the laws of the jurisdiction in which the Property is footed. The foregoing sentence shall not limit the applicability of Federal law to this Morigage. In the event that any provision or clause of this Morigage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Morigage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Morigage and the Note are declared to be severable. As used herein, "costs", "expenses", and "amorneys" fees" include all sums to the extent not prohibited by applicable law or limited nerein.

14 BORROWER'S COPY Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation bereof.

15 REHABILITATION LOAN AGREEMENT. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, report, or other form agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower in execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Borrower may have against parties who supply tabor, materials or services in connection with improvements made to the Property.

16. TRANSFER OF THY, DRI PERTY. If Borrower sells or transfers all or any part of the Property or an interest therein, excluding (a) the creation of a ben or excumbrance submilinate to this Mortgage (b) a transfer by devise, descent, or by operation of law upon the death of a joint tenant, or (c) the grant of any leasehold interest of three years or) is not containing an option to purchase. Borrower shall cause to be submitted information required by Lender to evaluate the transferre at if a new loan were owing made to the transferre. Borrower will continue to be obligated under the Note and this mortgage unless Lender releases Borrower in writing.

If Lender on the basis of any information obtained regarding the transferee, reasonably determines that Lender's security may be impaired, or that there is an unacceptable likelihood of breach or vity coverant or agreement in this Morigage, or if the required information is not submitted. Lender may declare all of the sums secured by this Morigage to be immediately due and payable. If Lender exercises such option to accelerate, Lender shall mill Borrower notice of acceleration in accordance with paragraph 12 hereof. Such notice shall provide a period of not less than 36 days from the date the notice is mailed or delivered within which Borrower may pay the sums declared due, if Borrower fails to pay such sums prior to the expiration of such period, Lender may, without further notice or demand on Borrower, invoke my remedies permitted by paragraph 17 hereof.

LENDER FRIOR TO ACCELERATION SHALL GIVE NOTICE TO BORROWER AS PROVIDED IN PARAGRAPH 12 HEREOF SPECIFYING: (1) THE BREACH; (2) THE ACTION REQUIRED TO CURE SUCH BREACH; (3) A DATE, NOT LESS THAN 10 DAYS FROM THE DATE THE NOTICE IS MAILED TO BORROWER, BY WHICH SUCH BREACH; (3) A DATE, NOT LESS THAN 10 DAYS FROM THE BREACH ON OR BEFORE THE DATE SPECIFIED IN THE NOTICE MAY RESULT IN ACCELERATION OF THE SUMS SECURED BY THIS MORTGAGE, FORECLOSURE BY JUDICIAL PROCEEDING, AND SALE OF THE PROPERTY. THE NOTICE SHALL FURTHER INFORM BORROWER OF THE RIGHT TO REINSTATE AFTER ACCELERATION AND THE RIGHT TO ASSERT IN THE FORECLOSURE. IF THE BREACH IS NOT CURED ON OR BEFORE THE DATE SPECIFIED IN THE NOTICE, LENDER, AT LEIDER'S OPTION, MAY DECLARE ALL OF THE SUMS SECURED BY THIS MORTGAGE TO BE IMMEDIATELY DUE AND PAYABLE WITHOUT FUPTHER DEMAND AND MAY FORECLOSURE. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 17 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 17 hereof or abandonment of the Property, Lender shall be entitled to have a receiver appointed by a court to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by the receiver shall be applied first to payment of the costs of management of the Property and collection of rents, including, but not limited to, receiver's tees, premiums on receiver's bonds and reasonable attorneys' fees, and then to the sums secured by this Mortgage. The receiver shall be liable to account only for those rents actually received.

20. RELEASE. Upon payment of all sums secured by this Mortgage. Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of accordance, if any

21 - WAIVER OF HOMESTEAD. Borrower hereby waives all right of homestead exemption in the Property.
