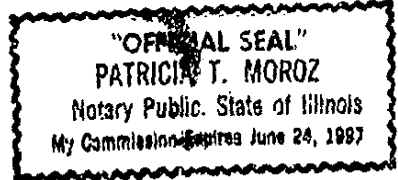

### LEGAL DESCRIPTION:

### PARCEL 2:
