Dear Mr. Grochocinski:

It is your responsibility to monitor the level of bond coverage and to increase that coverage as needed. If you have any questions regarding bonding, please contact Robert Wakefield of my office.

Please note that Fed.R.Bankr.P. 2008 requires that a person selected as a Chapter 11 trustee must notify the Court in writing of acceptance of the appointment within five days, otherwise the person shall be deemed to have rejected the appointment. Please forward a copy of this letter indicating your acceptance, and we will file it with the Court.


