#### MORTGAGE, ASSIGNMENT OF RENTS, SECURITY AGREEMENT AND FIXTURE FINANCING STATEMENT

THIS MORTGACE, ASSIGNMENT OF RENTS, SECURITY AGREEMENT AND FIXTURE FINANCING STATEMENT (this Morgage") is made this seventh day of October, 1996, between Corus Bunk, N.A., formerly known as River Forest State Bunk and Trust Company, not personally but as Trustee under Trust Agreement dated March 21, 1996 and known as Trus Number 1200 (hereinafter referred to as "Mortgager") and Corus Bunk N.A., a national banking association with a mailing address of 3959 North Lincoln Avenue, Chicago, H. 60613 (hereinafter referred to as "Mortgagee");

WHEREAS, Mortgager is indebted to Mortgager's Note of even date herewith (together with all renewals, (\$60,000.00), which indebtedness is evidenced by Mortgager's Note of even date herewith (together with all renewals, amendments, supplements, restatements, extensions and modifications thereof and thereto, if any, the "Note"). The Note is due and payable on November 1, 1999 unless extended parametr to the terms thereof and provides for payment of the indebtedness as set forth therein. The Note, this Mortgage are all other documents or instruments executed and/or delivered as additional evidence of, or security for payment of the Note, whether now or herenther existing, and all renewals, amendments, supplements, restatements, extensions, and modifications thereof and thereto, are hereinafter sometimes collectively referred to as the "Loan Documents"). The terms and provisions of the other Loan Documents are hereby incorporated herein by this reference.

NOW, THEREFORE, Mortgagor, to secure the payment of the Note with interest thereon at the variable rates as set forth therein, the payment of all late charges, fees, promiums and other sums evidenced by or owing under the Note, this Mortgage or any of the other Loan Documents, including, but not limited to, all so are expended by or advanced by Mortgagee in connection with the Loan Documents, with interest thereon as provided bards, in the Note or any of the other Loan Documents and the performance and observance of the covenants and agreements of Mortgagor and any other obligor to or benefiting Mortgagee which are evidenced or secured by or otherwise provided in the Note, this Mortgage or any of the other Loan Documents, does hereby mortgage, gaint and convey to Mortgagee the following described real estate located in the City of Chicago, County of Cook, State of Illinois: Permanent Tax Index No. 14-31-127-021; which real estate has the address of 2021 West Shakespeare. Chicago, Illinois 60647, and is legally described on Exhibit A attached hereto and hereby made a part hereof, and which, together with the property hereinafter described, is referred to herein as the "Premises."

TOGETHER with all improvements, tenements, casements, fixtures, rights of way, and rights used as a means of access to the Premises and appurtenances thereto belonging, and all rents, issues, royalties, income, revenue, proceeds and profits and other benefits thereof and any after acquired-title, franchise, or license and the reversions and remainders thereof, for so long and during all such times as Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily), and all fixtures, apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, sprinkler protection, waste removal, refrigeration (whether single units or centrally controlled), and ventilation, and other personal property

of every kind and nature whatsoever and all proceeds thereof, including (without restricting the foregoing): all fixtures, apparatus, equipment and articles, other than such as constitute trade fixtures used in the operation of any business conducted upon the Premises and distinguished from fixtures which relate to the use, occupancy and enjoyment of the Premises, it being understood that the enumeration of any specific articles of property shall in no wise exclude or be held to exclude any items of property not specifically mentioned. All of the land, estate and property hereinabove described, real, personal and mixed, whether affixed or annexed or not (except where otherwise hereinabove specified) and all rights, hereby conveyed and mortgaged are intended so to be as a unit and are hereby understood, agreed and declared to form a part and parcel of the real estate and to be appropriated to the use of the real estate, and shall for the purposes of this Mortgage be deemed to be real estate and conveyed and mortgaged hereby.

Mortgagor covenants that Mortgagor is lawfully selzed of the real estate hereby conveyed and has the right to mortgage, grant and convey the Premises, that the Premises is unencombered and that Mortgagor will warrant and defend generally the title to the Premises against all claims and demands, subject to any declarations, ensements or restrictions tisted in a schedule of exceptions to coverage in any title insurance policy insuring Mortgagee's interest in the Premises.

#### IT IS FURTHER UNDERSTOOD THAT:

- 1. Principal Interest and Other Payments. Mortgagor shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, and the principal of and interest on any future advances allowed under and secured by this Mortgago and all other amounts due and payable to Mortgago under the Note or at any time secured by this Mortgago (all such payments are collectively referred to in this Mortgago as the "indebtedness secured hereby").
- 2. Maintenance, Repole and Restoration of Improvements; Payment of Taxes and Liens, Etc. Mortgagor shall:
- (a) Promptly repair, restore or rebuild any improvement now or hereafter on the Premises which may become damaged or destroyed.
- (b) Pay immediately when due and payable and before any penalty attacks all general taxes, special assessments, water charges, sewer service charges and other tax is and charges against the Premises, including those heretofore due, and to farnish Mortgagee, upon request, with the original or duplicate receipts therefor, and all such items extended against the Premises shall be conclusively deemed valid for the purpose of this requirement. To prevent default hereunder, Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor may desire to contest. Pursuant to the terms of the Note, Mortgagor shall simultaneously with Mortgagor's monthly payments of principal and interest, deposit monthly an amount sufficiency, pay when due and payable all general taxes and said deposits may be held without any allowance of interest and next, not be kept separate and apart.
- (c) Keep the Premises and all buildings and improvements now or hereafter situated on the Premises insured against loss or damage by fire and extended coverage insurance, with malicious mischief and vandalism endorsements, and such other hazards in such amounts as may reasonably be required by Mortgagee, for the full insurable value thereof with agreed upon amount and inflation protection endorsements, but in any case in such amounts as to negate Mortgagor being a co-insurer in the event of the occurrence of a fire or other insurance casualty. Mortgagor shall also provide and keep in effect comprehensive public liability insurance with such limits for personal injury and death and preperty damage as Mortgagee may reasonably require. Mortgagor will also keep in effect upon the request of Mortgagee rent loss insurance in such amounts as Mortgagee may reasonably require, and such other insurance as Mortgagee may from time to time require. In addition, if the Premises are now or hereafter located in an area which has been identified by the Secretary of Housing and Urban Development as a flood inzard area and in which flood insurance has been made available under the National Flood Insurance Act of 1968 (the "Act"), Mortgagor will keep the Premises covered for the term of the Note by flood insurance up to the maximum limit of coverage

available under the Act. All policies of insurance to be furnished hereunder shall be in forms, issued by companies and in amounts and with deductibles reasonably satisfactory to Mortgagee, with standard mortgagee loss payable clause attached to all policies in favor of and in form satisfactory to Mortgagee, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days' prior written notice to Mortgagee. Mortgager shall deliver the original of all policies, including additional and renewal policies, to Mortgage, and, in the case of insurance about to expire, shall deliver renewal policies not less than thirty (30) days prior to their respective dates of expiration. If any renewal policy is not delivered to Mortgagee thirty (30) days before the expiration of any existing policy or policies, with evidence of premium paid, Mortgagee may, but is not obligated to, obtain the required insurance on behalf of Mortgagor (or insurance in favor of Mortgagos alone) and pay the premiums thereon. Any monies so advanced shall be so much additional indebtedness secured hereby and shall become immediately due and payable with interest thereon at the Default Interest Rate (as defined in the Note). So long as any sum repains due hereunder or under the Note, Mortgagor covenants and agrees that it shall not place, or cause to be placed or any separate casualty, fire, rent loss, or liability insurance separate from the insurance required to be maintained water the terms hereof, unless in each such instance Mortgagee is included therein as the payee under a standard mortgagee's loss payable clause. Mortgagor covenants to advise Mortgagee whenever any such separate insurance coverage is placed, issued or renewed, and agrees to deposit the original of all such other policies with Mortgagee. Application by Mortgagee of any of the proceeds of such insurance to the indebtedness secured hereby shall not excuse Mortgagor from making all monthly payments due under the Note.

- (d) Complete walture reasonable time any buildings or improvements now or at any time in process of crection upon the Premises.
- (c) Subject to the provisions hereof, restore and rebuild any buildings or improvements now or at any time upon and property and destroyed by the or other casualty so as to be of at least equal value and substantially the same character as immediately prior to such dan age or destruction. In any case where the insurance proceeds are made available for rebuilding and restoration, such projects shall be disbursed only upon the disbursing party being furnished with satisfactory evidence of the estimated cost of completion thereof and with prehitects certificates, waivers of lien, contractors and subcontractors sworn statements and categories evidence of cost and payment so that the disbursing party can verify that the amounts disbursed from time to time in represented by completed and in place work and that said work is free and clear of mechanics tien claims. No paymont prior to the final completion of the work shall exceed ninety percent (90%) of the value of the work performed from time to time and at all times the undisbursed balance of such proceeds remaining in the hands of the disbursing party shall be at least sufficient to pay for the cost of completion of the work free and clear of lights. If Mortgagee reasonably determines that the cost of rebuilding, repairing or restoring the buildings and improvements shall exceed the sum of \$15,000, it in Mortgagor shall submit plans and specifications of such work to Mortgageo for Mortgageo's prior approval before such week shall be commenced. Any surplus which remains from said insurance proceeds after payment of such costs of building or restoring shall, at the option of Mortgagee, be applied toward the indebtedness secured hereby or be paid to any party crititled thereto without interest.
- (f) Keep the Premises in good condition and repair without waste and free from any mechanics or other lien or claims of lien not expressly subordinated to the lien hereof.
- (g) Not suffer or permit any unlawful use of or any nuisance to exist on the Premises nor to diminish nor impair its value by any act or omission to act.
- (h) Comply with all requirements of law, municipal ordinances, rules and regulations with respect to the Premises and the use thereof.
- 3. Casualty. (a) In case of loss or damage, Mortgagee (or after entry of decree of foreclosure, the purchaser at the sale, or the decree creditor, as the case may be) is hereby authorized to either: (i) settle and adjust any claim under any insurance policies without the consent of Mortgagor, or (ii) allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss or damage; provided, however, that Mortgagee shall not have the right to exercise the powers granted in Paragraph 3(a) (i) hereof unless there is then existing a Default (as hereinafter defined) hereunder or an event which with the giving of notice or passage of time

would constitute a Default herounder or there has been entered a decree of foreclosure. In all cases Mortangee is authorized to collect and receipt for any such insurance proceeds and the expenses incurred by Mortgagee in the adjustment and collection of insurance proceeds shall be such additional indebtedness secured hereby and shall be reimbursed to Mortgagee upon demand with interest thereon at the Default Interest Rate or may be deducted by Mortgagee from said insurance proceeds prior to any other application thereof. The insurance proceeds may, at the option of Mortgagee, be applied in the reduction of the indebtedness secured hereby, whether due or not, in such order as Mortgagee shall determine, or be held by Mortgagee and used to reimburse Mortgagor for the cost of rebuilding or restoring buildings or intorovements on the Premises. Notwithstanding the foregoing, the insurance proceeds may be made available to Mortgagor to repair and restore the Premises if, and only if, in Mortgagoe's sole and absolute discretion, all of the following conditions are satisfied: (i) no Default, or event which with the giving of notice or passage of time would constitute a Default, shall have occurred hereunder or under my of the other Lora Documents; (ii) the insurging proceeds shall, in Mortgagee's sole and absolute judgment, be sufficient to complete the repair and restoration of the buildings, structures and other improvements on the Premises to an architectural and economic unit of substantially the sance character and the same value as existed immediately prior to such easualty, or, if Mortgagee shall determine, in its so's and absolute discretion, that the insurance proceeds are insufficient, Mortgagor shall have deposited with Mortgar, ee the amount of the deficiency in each within fifteen (15) days after Mortgagee's demand therefor; (iii) after such reviativa restoration, the Premises shall, in Mortgagee's sole and absolute judgment, adequately scenre the outstanding balance of the indebtedness secured hereby; (iv) any and all leases of the Premises remain in full force and effect and under the leases the Mortgagor is obligated to repair and restore the Mortgaged Premises; (v) the insurers do not deny flability to either or the insureds; and (vi) with respect to any claims for any loss or duringe arising out of a single occurrence which shall in one aggregate exceed Fifteen Thousand and No/100 Dollars (\$15,000), such loss or damage does not occur during the last twolve (12) months of the term of the Note.

- (b) In case of loss after forcelosure proceedings have been instituted, the proceeds of any such insurance policy or policies, if not applied as aforesa d in rebuilding or restoring the building or improvements, shall be used to pay the amount due in accordance with any decree of forcelosure that may be entered in any such proceeding, and the balance, if any, shall be paid to the owner of the equity of redemption if said owner shall then be entitled to the same, or as the court may otherwise direct. In case of forcelosure of this Mortgage, the court in its decree may provide that the mortgagee's clause attached to each said insurance policies may be canceled and that the decree creditor may cause a new loss clause to be attached to each of said policies making the loss thereunder payable to said decree creditor. Any forcelosure decree may further provide that in case of one or more redemptions under said decree, each successive redemptor may cause the preceding loss clause attached to each insurance policy to be canceled and a new loss clause to be attached thereto, making the loss thereunder payable to such redemptor. In the event of forcelosure sale, Mortgagee is hereby authorized, without the consent of Mortgagor, to assign pay and all insurance policies to the purchaser at the sale, or to take such other steps as Mortgagee may deem advisable, to cause the interest of such purchaser to be protected by any of the said insurance policies.
- (c) Nothing contained in this Mortgage shall create any responsibility or obligate a on Mortgagee to collect any amount owing on any insurance policy, to rebuild, repair or replace any damaged or destroyed portion of the Premises or any improvements thereon, or to perform any act hereunder.
- Condemnation and Eminent Domain. Mortgagor hereby assigns to Mortgagee and authorizes Mortgagee to negotiate for and collect any award for condemnation or eminent domain of all or any part of the Premises. Mortgagee is hereby authorized to give appropriate receipts and acquittances therefor. Mortgagor shall give Mortgagee immediate notice of the actual or threatened commencement of any condemnation or eminent domain proceedings of which it has knowledge affecting all or any part of the Premises (including severance of, consequential damage to or change in grade of streets), and shall immediately deliver to Mortgagee copies of any and all papers served in connection with any such proceedings. Mortgagor further agrees to make, execute and deliver to Mortgagee, free and clear of any encumbrance of any kind whatsoever, any and all further assignments and other instruments deemed necessary by Mortgagee for the purpose of validly and sufficiently assigning all awards and other compensation heretofore, now and hereafter made to Mortgagor for any taking, either permanent or temporary, under any such proceeding. Any such award shall be applied toward the indebtedness secured by this Mortgage or applied toward restoring the Premises in accordance with the provisions of and in the same manner as is provided for insurance proceeds in Paragraph 3 hereof. Notwithstanding the foregoing, any expenses, including, without limitation, attorneys'

fees and expenses, incurred by Mortgagee in intervening in such action or compromising and settling such action or claim, or collecting such proceeds, shall be reimbursed to Mortgagee that out of the proceeds.

- 5. Mortgogor's Representations and Covenants. Mortgogor hereby represents and covenants to Mortgogo that:
- (a) Mortgagor (i) has the power and authority to own its properties and to carry on its business as now being conducted; (ii) is qualified to do business in every jurisdiction in which the nature of its business or its properties makes such qualifications necessary; and (iii) is in compliance with all laws, regulations, ordinances and order of public authorities applicable to it.
- (b) The execution, delivery and performance by Mortgagor of the Note, this Mortgagor, and all other i.o.an Documents, and the borrowing evidenced by the Note: (i) are within the powers of Mortgagor; (ii) have been duly authorized or all requisite actions; (iii) have received all necessary approvals; (iv) do not violate any provision of any law, any order of any court or agency of government or any indenture, agreement or other instrument to which Mortgagor is a party, or by which it or any portion of the Premises is bound; and (v) are not in conflict with, nor will it result in breach of, or constate (with due notice and/or lapse of time) a default under any indenture, agreement, or other instrument, or result in the creation or imposition of any lien, charge or encumbrance of any nature whatsoever, upon any of its property or assets, except as contemplated by the provisions of this Mortgage and the other Loan Documents.
- (c) The Note, this Mortgago, and all other Loan Documents, when executed and delivered by Mortgagor, will constitute the logal, valid and bonding obligations of Mortgagor, and other obligors named therein, if any, in accordance with their respective terms; subject, however, to such excutpation provisions, if any, as may be hereinafter specifically set forth.
- (d) All other information, reports, papers, onlance sheets, stmements of profit and loss, and dam given to Mortgagee, its agents, employees, representatives or council regarding Mortgager or any other party obligated under the terms of this Mortgage or any of the other Loan Document; are accurate and correct in all material respects and complete insofar as completeness may be necessary to give Mortgage a true and accurate knowledge of the subject matter.
- (c) There is not now pending against or affecting Mortgagor of any other party obligated under the terms of this Mortgago or any of the other Loan Documents nor, to the knowledge of Mortgagor or any other party obligated under the terms of this Mortgago or any of the other Loan Documents, is the rethreatened, my action, suit or proceeding at law or in equity or by or before any administrative agency which if affectively determined would materially impair or affect the financial condition or operation of Mortgagor or the Premises.
- 6. Transfer of Premises: Further Encumbrances. Any sale, conveyance, transfer pledge, mortgage or other encumbrance of any right, title or interest in the Premises or any portion thereof, or any sale, transfer or assignment (either outright or collateral) of all or any part of the beneficial interest in any trust holding the to the Premises; or any sale, conveyance, assignment or other transfer of all or any portion of the stock, partnership interest, or membership interest of any corporation, partnership or limited liability company, respectively, constituting Mortgagor, that results in a material change in the identity of the person(s) or entities in control of Mortgagor; or any subordinate or secondary financing which results in a lien upon the Premises or any portion thereof; without the prior written approval of Mortgagee shall, at the option of Mortgagee, constitute a Default hereunder, in which event the holder of the Note may declare the entire unpaid balance of the indebtedness accured hereby to be immediately due and payable and foreclose the lien of this Mortgage immediately or at any time after such Default occurs; PROVIDED, HOWEVER, that sales, conveyances or transfers are permissible when and if the transferee's credit worthiness and management ability are satisfactory to Mortgagee in Mortgagee's sole and absolute discretion, and the transferee has executed any and all assumption documents, paid all fees and satisfied any and all other requirements of Mortgagee prior to such sale, conveyance or transfer.

- Performance by Mortgagee. In the case of Mortgager's failure to perform or observe any of the covenants herein, or if any action or proceeding is commenced which nanterially affects or threatens to materially affect Mortgagee's interest in the Premises, including, but not limited to, eminent domain, insolvency, code enforcement, or arrangements or proceedings involving a bankrupt or decedent, Mortgagee may do on Mortgager's behalf everything so covenanted; Mortgagee may also do any act it may deem necessary to protect the lien largeof; and Mortgager will repay upon demand any monies paid or disbursed by Mortgagee, including reasonable attorneys' tees and expenses, for any of the above purposes and such monies together with interest thereon at the Default Interest Rate shall become so much additional indebtedness secured hereby and may be included in any decree foreclosing the lien of this Mortgage and be paid out of the rems or proceeds of sale of the Premises if not otherwise paid. It shall not be obligatory upon Mortgagee to inquire into the validity or accuracy of any lien, encumbrance, or claim in advancing monies as above authorized, but nothing herein contained shall be construed as requiring Mortgage to advance any monies for any purpose nor to do any act hereurder; and Mortgagee shall not incur any personal liability because of anything it may do or omit to do becomender nor soull any acts of Mortgagee act as a waiver of Mortgagee's right to accelerate the maturity of the indebtedness seem co by this Mortgage or to proceed to foreclose the lien of this Mortgage.
- 8. Future advances: Maximum Indebtedness. It is the intent hereof to secure payment of the Note whether the entire amount and have been advanced to Mortgagor at the date hereof or at a later date, or having been advanced, shall have been repeal in part and further advances made at a later date, which advances shall in no event cause the indebtedness secured hereby to exceed the sum of One Hundred Eighty Thousand and no/100 Dollars (\$180,000,00).
- Assignment of Rents. (a) To further secure the indebtedness secured hereby, Mortgagor does hereby sall, assign and transfer unto Mortgagor all the rents, issues and profits now due and which may hereafter become due under or by virtue of any lease, whether written or verbal, or any letting of, or of any agreement for the use or occupancy of the Premises or any part thereof, which pure have been heretofore or may be hereafter made or agreed to or which may be made or agreed to by Mortgagoe under the powers herein granted, it being the intention hereby to establish an absolute transfer and assignment of all of such as as and agreements, and all the avails thereunder, unto Mortgagoe, and Mortgagor does hereby appoint irrevocably hortgagoe its true and lawful attorney in its name and sical (with or without taking possession of the Premises) to rent, lease or let all or any portion of the Premises to any party or parties at such rental and upon such terms as Mortgagoe slant, it its discretion, determine, and to collect all of said avaits, rents, issues and profits arising from or accruing at any time nerental, and all now due or that may hereafter exist on the Fremises, with the same rights and powers and subject to the same immunities, exoneration of liability and rights of recourse and indemnity as Mortgagoe would have upon taking possession of the Premises.
- (b) Mortgagor represents and agrees that no rent has been or vill be paid by any person in possession of any portion of the Premises for more than two installments in advance, and that no payment of rents to accrue for any portion of the Premises has been or will be waived, released, reduced, discounted, or otherwise discharged or compromised by Mortgagor. Mortgagor waives any right of set off against any person in possession of any portion of the Premises. Mortgagor agrees that it will not assign any of the rents or profits of the Premises, except to a purchaser or grantee of the Premises.
- (c) Nothing herein contained shall be construed as constituting Mortgagee as a mortgagee in possession in the absence of the taking of actual possession of the Premises by Mortgagee. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgager.
- (d) Mortgagor further agrees to assign and transfer to Mortgagee all future leases regarding all or any part of the Premises herembefore described and to execute and deliver, at the request of Mortgagee, all such further assurances and assignments pertaining to the Premises as Mortgagee shall from time to time require.
- (c) Although it is the intention of the parties that the assignment contained in this Paragraph 9 shall be a present assignment, it is expressly understood and agreed, anything herein contained to the contrary notwithstanding, that so long as Mortgagor is not in Dollank hereunder or under the Note, it shall have the privilege of

collecting and retaining the rents accruing under the leases assigned hereby, until such time as Mortgagee shall elect to collect such rents pursuant to the terms and provisions of this Mortgage.

- (f) Mortgagee shall not be obliged to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any leases, and Mortgagor shall and does hereby agree to indemnify and hold Mortgagee harmless of and from any and all liability, loss or damage which it may or might incur under said leases or under or by reason of the assignment thereof and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alleged obligations or undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in said leases. Should Mortgagee incur any such liability, loss or damage under said leases or under or by reason of the assignment thereof, or in the defense of any claims or demands, the amount thereof, including costs, expenses and reasonable attorney's fees, shall be secured hereby, and Mortgagor shall reimburge Mortgagee therefor immediately upon demand with interest thereon at the Default Interest Rate.
- 10. Security Agreement. (a) This Mortgage shall be deemed a Security Agreement as defined in the Illinois Commercial Code. This Mortgage creates a security interest in favor of Mortgageo in all property including all personal property, fixures and goods affecting property either referred to or described herein or in anyway connected with the use or enjoyment of the Premises. - 20. Application of Income.
