- 2. DeWindt was Owner's general contractor for the improvements on the Real Estate.
- 3. On or about April 21, 1996, DeWindt, as general contractor, made a written subcontract with Claimant under which Claimant agreed to provide labor and materials for the installation of doors, frames, and hardware (Purchase Order 16052) for a structure on the Real Estate in exchange for payment in the original contract sum of \$101,229.00 (the "Subcontract").
- 4. The Subcontract was entered into by DeWindt and the work was performed by Claimant with the knowledge and consent of Owner. Alternatively, the Owner specifically authorized DeWindt and/or DeWindt's agents to enter into contracts for improvement of the Real Estate. Alternatively, the Owner knowingly permitted DeWindt and/or DeWindt's agents to enter into contracts for the improvement of the Real Estate.
- 5. At the special instance and request of DeWindt and with the full knowledge and express consent or acquiescence of Owner, Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$128,147.46. Claimant completed providing the additional materials and labor at various times.
- 6. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by DeWindt, the balance of One Hundred Fifty Thousand One Hundred Sixty One Dollars and cony Three Cents (\$150,161.43) for which, with interest, Claimant claims a lien on the Peal Estate and on the monies or other consideration due or to become due from Owner to DeWindt under the Contract between Owner and DeWindt.
