SUBORDINATION OF MORTGAGE

This Subordination Agreement is made as of this 7th day of October, 1996, by and among The First National Bank of Chicago, a national banking association ("Jumor Mongagee"), The First National Bank of Boston, a national banking association, agent ("Senior Mortgapie") and Pamco Printed Tape & Label Co., Inc., a Delaware corporation ("Mortgagor").

Upon the recordation of the mortgage by the Mortgagor in favor of the Junior Mortgagee (the "Junior Mortgage"), with the Recorder of Cook, County, Illinois, notwithstanding the fact that the Senier Mongage has been recorded prior to the Junior Mortgage, the Senior Mortgage and the lien created thereunder are hereby agreed to be and shall continue to be subject and subordinate to the lien created by, as well as all of the terms covenants and conditions contained in the Junior Mortgage.

This Subordination Agreement shall be governed by the internal laws (and not the law of conflicts) of the State of Illinois.
