Further deponent says not.

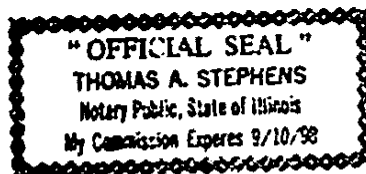

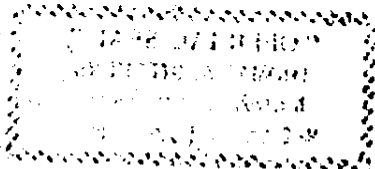
