TOGETHER with all the improvements now or hereafter erected on the property, and all casements, rights, appurtenances and rents, all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the lessehold estate if this Mortgage is on a lessehold) are hereinafter referred to as the "Property."
