THIS ASSIGNMENT OF LEASES AND RENTS (this "Assignment" is made as of July 16, 1896, by Angel L. Mercado and Ruth R. Mercado, husband and wife, having an address at 1312 Valayna Drive, Aurora, IL 60504 ("Assignor"), to CITYSCAPE MORTGAGE CORP., organized and existing under the laws of New York, having an address at 565 Taxter Road, Elmsford, New York 10523-2300 ("Assignee").

#### WITNESSETH:

Assignor, for good and valuable consideration, receipt whereof is hereby acknowledged, and intending to be legally bound hereby grants, transfers and assigns to Assignee the entire Assignor's interest in and to all lesses and other agreements affecting the use, enjoyment or occupancy of all or any part of that certain lot or piece of land, more particularly described in Exhibit "A" annexed hereto and made a part hereof, together with the buildings, structures, fixtures, additions, enlargements, extensions, modifications, repairs, replacements and improvements now or hereafter located hereon (hereinafter collectively referred to as the "Mortgaged Fregerty");

TOGETHER MITH all other leases and other agreements affecting the use, enjoyment or occupancy of the Mortgageu Property or any portion thereof now or hereafter made, together with any extension or renewal of the same, this prepared to other present and future leases and present and future agreements and any extension or renewal of same (hereinafter collectively referred to as the "Leases") being effective without further or supplemental assignment;

TOGETHER WITH any and all Lights against any guaranter of any lessee's performance under any of the Leases; and

TOGETHER WITH all rents, income, is suggested and profits arising from the Leases and together with all rents, income, issues and profits (including all of and gas or other mineral royalties and bonuses) from the use, enjoyment and occupancy of the Mortgaged Property (hereinafter collectively referred to as the "Rents").

THIS ASSIGNMENT is made in consideration of that certain mortgage loan made by Assignee to Assigner evidenced by that certain Mortgage Note made by Assigner to Assignee, dated the date hereof, in the principal sum of \$298,150.00 (the "Note"), and secured by the certain Mortgage and Security Agreement given by Assigner to Assignee, dated the date hereof, covering the Mortgaged Property and intended to be duty recorded (the "Mortgage"). The principal sum, interest and all other rums due and payable under the Note and Mortgage are collectively referred to as the "Debt." The documents other than this Assignment, the Note and the Mortgage, now or hereafter executed by Assigner and/or others and in favor of Assignee which wholly or partially secure or guarantee payment of the Debt, are hereinafter referred to as the "Other Security Documents."

ASSIGNOR WARRANTS that (a) Assignor is the sole owner of the entire in sour's interest in the Leases; (b) the Leases are valid and enforceable and have not been altered, modified or smended in any manner whatsoever except as therein set forth; (c) none of the Rents reserved in the Leases have been assigned or otherwise piedged or hypothecated; (d) none of the Rents have been collected for more than one (1) month in advance; (e) Assignor has full power and authority to execute and deliver this Agreement and the execution and delivery of this Assignment has been duly authorized and does not conflict with or constitute a default under any law, judicial order or other agreement affecting Assignor or the Mortgaged Property; (f) the improvements to the premises demised under the Leases have been completed and the tenants under the Leases have accepted the same and have taken possession of the same on a rent paying basis; and (g) there exist no offsets or defenses to the payment of any portion of the Rents.

ASSIGNOR COVENANTS with Assignee that Assignor (a) shall observe and perform all the obligations imposed upon the lessor under the Lesses and shall not do or permit to be done anything to impair the value of the Lesses as security for the Debt; (b) shall promptly send copies to Assignee of all notices of default which Assignor shall send or receive thereunder; (c) shall enforce all of the terms, coverants and conditions contained in the Lesses and any guarantees thereof upon the part of the lesses and the

guarantors thereunder to be observed or performed, short of termination thereof; (d) shall not collect any of the Rents more than one (1) month in advance; (e) shall not execute any other assignment of lessor's interest in the Leases or the Rents; (f) shall not alter, modify or change the terms of the Leases without the pilor written consent of Assignee, or cancel or terminate the Leases or accept a surrender thereof or convey or transfer or suffer or permit a conveyance or transfer of the Mortgaged Property or of any interest therein so as to effect a merger of the estates and rights of, or a termination or diminution of the obligations of, leasees thereunder; (g) shall not alter, modify or change the terms of any guaranty of any of the Leases or cancel or terminate any such guaranty without the prior written consent of Assignee; (h) shall not consent to any sesignment of or subletting under the Leases not in accordance with its terms, without the prior written consent of Assignee; and (i) shall execute and deliver at the request of Assignee shall from time to time require.

ASSIGNOR FURTHER COVENANTS with Assignee that (a) all Leases shall be written on the standard form of trace which has been approved by Assignee; (b) upon request, Assigner shall furnish Assignee with executed copies of all Leases; (c) no material changes may be made to the Assignee-approved standard lease without the prior written consent of Assignee; (d) in addition, all renewals of Leases and all proposed leases shall provide for rental rates comparable to existing local market rates and shall be armsiength transactions; (e) all proposed leases shall be subject to the prior approval of the Assignee except that all proposed leases which (i) are on the same form of lease which has been approved by Assignee, (ii) are the result of an arms-length transaction. (iii) which provide for rental rates comparable to existing market rates, and (iv) do not contain any terms which would materially affect Assignee's rights under the Mortgage, the Note, the Other Security Documents or this Assignment, shall not be subject to the prior approval of Assignee; and (i) all Leases shall provide that they are subordinate to the Mortgage and that the lessees agree to attorn to Assignee.

THIS ASSIGNMENT is made on the following 'em's, covenants and conditions:

#### GENERAL PROMINING

- Present Assignment. Assignor does hereby absolutely and unconditionally assign to Assignee Assignor's right, title and interest in all current and future Leases and Flents, it being intended by Assignor that this assignment constitutes a present, absolute assignment and not an assignment for additional security only. Such assignment to Assignee shall not be construed to bind Assigned to the performance of any of the covenants, conditions and provisions contained in any such Lease or otherwise impose any obligation upon Assignee. Assignor agrees to execute and deliver to Assignee such additional instruments, in form and substance satisfactory to Assignee, as may hereafter be requested by Assigned to further evidence and confirm such assignment. Nevertheless, subject to the terms of this paragraph 1, Assignee grants to Assigner a revocable license to operate and manage the Mortgaged Property and to collect the Ronte Assignor shall hold the Rents, or a portion thereof sufficient to discharge all current sums due on the Debtilio trust for the benefit of Assignee for use in the payment of such sums. Upon an Event of Default (as defined in the Mortgage), the license granted to Assignor herein may be revoked, and Assignee shall immediately be entitled to possession of all Rents, whether or not Assignee enters upon or takes control of the Mortgaged Property. Any Rents collected after the revocation of the license may be applied toward payment of the Debt in such priority and proportions as Assignee in its discretion shall deem proper.
- 2. Remedies of Assignee. Upon or at any time after an Event of Default, Assignee may, at its option, without waiving such Event of Default, without notice and without regard to the adequacy of the security for the Debt, either in person or by agent, with or without bringing any action or proceeding, or by a receiver appointed by a court, take possession of the Mortgaged Property and have, hold, manage, lease and operate the Mortgaged Property on such terms and for such period of time as Assignee may deem proper and, either with or without taking possession of the Mortgaged Property, in its own name, demand, sue for or

otherwise collect and receive all Rents, including those past due and unpaid with full power to make from time to time all alterations, renovations, repairs or replacements thereto or thereof as may seem proper to Assignee and may apply the Rents to the payment of the following in such order and proportion as Assignee in its sole discretion may determine, any law, custom or use to the contrary notwithstanding: (a) all expenses of meneging and security the Mortgaged Property, including, without being limited thereto, the salaries, fees and wages of a managing agent and such other employees or agents as Assignee may deem necessary or desirable and all expenses of operating and maintaining the Mortgaged Property, including, without being #miled thereto, all taxes, charges, claims, assessments, water charges, sewer rents and any other liens, and premiums for all insurance which Assignee may deem necessary or desirable, and the cost of all alterations, renovations, repairs of replacements, and all expenses incident to taking and retaining possession of the Mortgaged Property; and (b) the Debt, together with all costs and attorneys' fees, in addition to the rights which Assignee may have herein, upon the occurrence of an Event of Default, Assignee, at its option, may either require Assignor to pay monthly in advance to Assignee, or any receiver appointed to collect the Rents, the fair and responsible rental value for the use and occupation of such part of the Mortgaged Property as may be in possession of Assignor or may require Ausignor to vacate and surrender possession of the Mortgaged Property to Assignor may be evicted by summary proceedings or otherwise. For purposes of this paragraph 2, Assignor grants to Assignee its irrevocable power of attorney, coupled with an interest, to take any and all of the aforementioned actions and any or all other actions designated by Assignate for the proper management and preservation of the Mortgaged Property. The exercise by Assignee of the option granted it in this paragraph 2 and the collection of the Rents and the application thereof as herein ployleted shall not be considered a waiver of any default by Assignor under the Note, the Mortgage, the Leases, tills Assignment or the Other Security Documents:

- No Liability of Assigner. Assignee shall not be liable for any loss sustained by Assignor resulting from Assignee's failure to let the live rip and Property after an Event of Default or from any other act or omission of Assignee in managing the Morro and Property after default unless such loss is caused by the willful misconduct and bad faith of Assignee. Assignee shall not be obligated to perform or discharge any obligation, duty or liability under the Leases or under or by reason of this Assignment and Assignor shall, and hereby agrees, to indemnify Assignee for, and to hold Ausignee harmless from, any and all liability, loss or damage which may or might be incurred under the Lesses or under or by reason of this Assignment and from any and all cialms and demands whatsoever, including the defende of any such claims or demands which may be ascerted against Assignee by reason of any alleged obligations and undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in the beases. Should Assignee incur any such liability, the amount thereof, including costs, expenses and reasonable attorneys' fees, shall be secured hereby and by the Mortgage and the Other Security Documents and Accipnor shall reimburse Assignee therefor immediately upon demand and upon the fallure of Assignor so to do. Assignee may, at its option, declare all sums secured hereby and the Morigage and the Other Security Dour ments immediately due and payable and all such costs, expenses and altomeys' fees incurred by Assignee shall blar interest at the Note rate. Nothing contained in this Agreement and no act done or omitted by Assignee pursuant to the power and rights granted to Assignee hereunder shall be deemed to be a waiver by Assignee of its rights and remedies under the Note, the Mortgage, or the Other Security Documents and this Assignment is made and accepted without prejudice to any of the rights and remedies possessed by Assignee under the terms thereof. - apecifically provided herein, words used in this Assignment may be used interchangeably in singular or plural form and the word "Assignor" shall mean "asch Assignor and any subsequent owner or owners of the Mortgaged Property or any part thereof or interest therein," the word "Assignee" shall mean "Assignee and its successors and any subsequent holder of the Note," the word "Note" shall mean "the Note and any other evidence of indebtedness secured by the Mortgage," the word "Person" shall include an individual, corporation, pertnership, trust, unincorporated association, government, governmental authority, and any other entity, the word "Mortgaged Property" shall include any portion of the work gaged Property and any interest therein, and the word "Debt" shall mean the principal balance of the Note with relevent thereon as provided in the Note and the Mortgage and all other sums owing pursuant to the Note, the Mortgage, this Assignment and the Other Security Documents; whenever the context may require, any pronounce and pronouns shall include the corresponding masculine, feminine or neuter forms, and the singular form of nouns and pronouns shall include the plural and vice versa.
- Non-Water. The failure of Assignee to insist upon strict performance of any term hereof shall not be deemed to be a waiver of any term of this Assignment. Assignor shall not be relieved of Assignor's obligations hereunder by reason of (i) failure of Assignee to comply with any request of Assignor or any other party to take any action to enforce any of the provisions hereof or of the Mortgage, the right or the Other Security Documents, (ii) the release regardless of consideration, of the whole or any part of the Mortgaged Property, or (iii) any agreement or attpulation by Assignee extending the time of payment or other Security modifying or supplementing the terms of this Assignment, the Note, the Mortgage or the Other Security Documents. Assignee may resort for the payment of the Debt to any other security held by Assignee in such order and manner as Assignee, in its discretion, may elect. - Governing Law. This Assignment shall be governed and construed in accordance with the 14. laws of the State of illinois.
- Termination of Assignment. Upon payment in full of the Debt and the delivery and recording of a satisfaction or discharge of the Mortgage duty executed by Assignee, this Assignment shall become and be void and of no effect.

THIS ASSIGNMENT, together with the covenants and warranties therein contained, shall insure to the benefit of Assignee and any subsequent holder of the Mortgage and shall be binding upon Assignor, his heirs, executors, administrators, successors and sasigns and any subsequent owner of the Mortgaged Property.
