
TERMINATION OF ASSIGNMENT OF LEASES

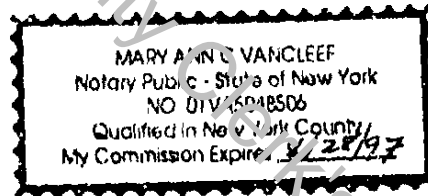
