
TERMINATION OF ASSIGNMENT OF RENTS

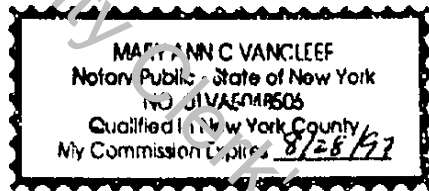
