
MATERIALMAN'S CLAIM FOR LIEN

That on or about May 31, 1996, ALBRIGHT made a contract with OZINGA, as materialman, to furnish and supply ready mixed concrete to the property for the construction and/or improvement of the property.

That OZINGA completed delivery of all of said materials to the property on June 18, 1996 and that the value of the materials was \$1,867.32. That there is due and unpaid, and owing to OZINGA the sum of \$1,867.32, for which, with interest at the statutory rate of 10% per annum, OZINGA claims a lien on the property and improvements and on the moneys or other considerations due or to become due from OWNERS under said contract to MOLIDOR and/or ALBRIGHT.
