## CONTRACTOR'S NOTICE AND CLAIM FOR LIEN

The claimant, Allstar Asphalt, Inc., 165 West Hintz Road, Wheeling, Illinois 60090 (referred to as "CONTRACTOR") files this notice and claim for lien against Sound Experience, Inc., 400 Anthony Trail, Northbrook, Illinois 60062, and 400 Anthony Trail Partnership, 400 Anthony Trail, Northbrook, Illinois 60062 ("OWNERS"), and states:

Between the dates of April 1, 1996, through at least through the date of this notice, the OWNERS owned the following described property in the county of Cook, State of Illinois, to wit:

At the special instance and request of OWNERS, the CONTRACTOR furnished labor and materials for work on THE PREMISES in the amount of \$12,400.00. Thereafter, CONTRACTOR furnished extra and additional materials at and extra and additional labor on the property of the value of \$6,276.00. OWNERS have paid CONTRACTOR \$5,000.00, leaving an unpaid balance due of \$13,676.00, plus attorneys' fees and interest pursuant to the contract between CONTRACTOR and OWNERS.

NOW THEREFORE, CONTRACTOR claims a lien on THE PREMISES and their improvements for the payment of the above-described sums of money.

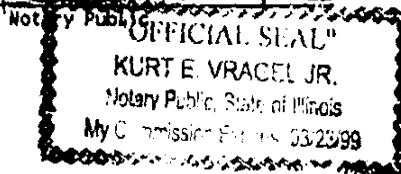
