- 2. MAXIMUM OBLIGATION LIMIT. The total principal amount of the Obligations secured by this Mortgage, not including, however, any sums advanced for the protection of the Property or Bank's interest therein, nor interest, attorneys' fees, paralegal fees, costs and other legal expensus, shall not exceed the sum of \$60,000.00, provided, however, that nothing contained herein shall constitute a commitment to make additional or future loans or edvances in any amounts.
- 3. OBLIGATIONS DEFINED. The term "Obligations" is defined as and includes the following:
  - A promissory note, No. , (Note) dated October 30, 1996, with a maturity date of October 30, 1997, and executed by STATE BANK OF COUNTRYSIDE ATTUITIA DATED 10-01-1896 ATK/A TRUST #86-1751 AND NOT PERSONALLY and A. A premissory note, No. LISDOON CONSTRUCTION (Borrower) payable in monthly payments to the order of Bank, which wireinces a loan (Loan) to Borrower in the amount of \$60,000.00, plus interest, and all extensions, renewals, modifications or sub-selucine thereof.

B. All future advances by Bank to Borrower, to Mortgagor, to any one of them or to any one of them and other (and all other obligations referred to in the subparagraph(s) below, whether or not this Mortgage is specifically referred to in the uvidence of indebtedness with regard to such future and additional indebtedness).

C. All additional sums advanced, and expenses incurred, by Bank for the purpose of insuring, preserving or otherwise protecting the Property (as herein deilined) and its value, and any other sums advanced, and expenses incurred by Bank pursuant to this

Mortgage, plus interest at the same rate provided for in the Note computed on a simple interest method.

All other obligations, now existing or hereafter arising, by Borrower owing to Bank to the extent the taking of the Property (as berein defined) as security therefor is not prohibited by law, including but not limited to liabilities for overdrafts, all advances made by Bank on Borrower's, and/or Montgagor's, behalf as authorized by this Montgage and liabilities as guarantor, endorses or surely, of Borrower to Bank, due or to become due, direct or indirect, absolute or contingent, primary or secondary, liquidated or unliquidated, or joint, several, or joint and several.

- 4. CONVEYANCE. In consideration of the Loan and Obligations, and to secure the Obligations (which includes the Note according to its specific terms and the obligations in this Mortgage), Mortgagor hereby bargains, grants, mortgages, sells, conveys and warrants to Bank, as Mortgagee, the following described property (Property) situated in COOK County, ILLINOIS, to-wit:

such property not constituting the homestuad of Borrower, togother with all buildings, improvements, fixtures and equipment now or hereafter attached to the Property, including, but not limited to, all heating, air conditioning, ventilation, plurnbing, cooling, electrical and lighting fixtures and equipment; all landscaping; all exterior and interior improvements; all easements, issues, rights, appurtenances, rents, royalties, not gas rights, privileges, proceeds, profits, other minerals, water, water rights, and water stock, crops, grass and timber at any time proving upon said land, including replacements and additions thereto, all of which shall be deemed to be and remain a part of the Property. The term "Property" further includes, but is not limited to, any and all wells, water, water rights, disches, laterals, reservoirs, reservoir sites rure dams, used, appurtenant, connected with, or attached to the Property, whether or not evidenced by stock or shares in a corporation, resolution or other entity howscever evidenced. Mortgagor further releases and waives all rights under and by virtue of the homestead law, and exemption laws of the state of ILLINOIS.

- 5. LIENS AND ENCUMBRANCES. Mortgagor viara its and represents that the Property is free and clear of all liens and encumbrances whatsoever. Mortgagor agrees to pay all claure when due that might result, if unpitid, in the foreclosure, execution or imposition of any lien, claim or encumbrance on or against the Properly or any part thereot. Mortgagor may in good faith contest any such lien, claim or encumbrance by posting any bond in an amount receivery to prevent such claim from becoming a flen, claim or encumbrance or to prevent its foreclosure or execution.
- 8. ASSIGNMENT OF LEASES AND RENTS. Mortgagor grants bargains, mortgages, sells, conveys, warrants, assigns and transfers as additional security all true right, title and interest in and to any and all:
  - A. Existing or future leases, subleases, licenses, guaranties are any other witten or verbal agreements for the use and occupancy of any portion of the Property, including any extensions renewals, modifications or substitutions of such agreements (all referred to as "Leases").
  - B. Ronto, issues and profits (all referred to as "Rents"), including but of limited to security deposits, minimum rent, percentage rent, additional rent, common area maintenance charges, parking charges, real estate taxes, other applicable taxes, insurance premium contributions, liquidated damages following default, cancellation premiums, "loss of rents" insurance, quest receipts, revenues, royalties, proceeds, bonuses, accounts, contract rights, general intengibles, and all rights and claims which Mortgagor may have that in any way pertain to or are on account of the use or occupancy of the whole or any part of the Property.

In the event any item listed as Leases or Rents is determined to be personal property, this who raise be regarded as a security agreement.

Mortgagor will promptly provide Bank with true and correct copies of all existing and future Louise. Mortgagor may collect, receive, enjoy and use the Rents so long as Mortgagor is not in default. Except for one lease period's rent, Mc tgag it will not collect in advance any Rents due in future lease periods, unless Mortgagor first obtains Bank's written consent. Upon default wortgagor will receive any Rents in trust for Bank and Mortgagor will not commingle the Rents with any other funds. Any amounts collected shall be applied at Bank's discretion first to costs of managing, protecting and preserving the Property, and to any other necessity related expenses including Bank's court costs. Any remaining amounts shall be applied to reduce the Obligations.

Mortgagor agrees that this assignment is immediately effective between the parties to this Mortgage and effective as to third parties on the recording of this Mortgage. Mortgager agrees that Bank is antitled to notify Mortgagor or Mortgagor's tenants to make payments of Rents due or to become due directly to Bank after such recording, however Bank agrees not to notify Mortgagor's tenants until Mortgagor defaults and Bank notifies Mortgagor of the default and demands that Mortgagor and Mortgagor's tenants pay all Rents due or to become due directly to Bank. On receiving the notice of default, Mortgagor will endorse and deliver to Bank any payments of Rents. If Mortgagor becomes subject to a voluntary or involuntary bankruptcy, then Mortgagor agrees that Bank is entitled to receive relief from the automatic stay in bankruptcy for the purpose of enforcing this assignment under state and lederal law and within Mortgagor's bankruptcy proceedings.

Mortgagor werrants that no default exists under the Leases or any applicable landlord law. Mortgagor also warrants and agrees to maintain, and to require the tenants to comply with, the Leases and any applicable law. Mortgagor will promptly notify Bank of any noncompliance. If Mortgagor neglects or refuses to enforce compliance with the terms of the Leases, then Bank may opt to enforce compliance to the extent that the law permits. Mortgagor will obtain Bank's written authorization before Mortgagor consents to subjet, modify, cancel, or otherwise after the Leases, to accept the surrender of the Property covered by such Leases (unless the Leases so require), or to assign, compromise or encumber the Leases or any future Rents. Mortgagor will hold Bank harmless and indomnify Bank for any and all flability, loss or damage that Bank may incur as a consequence of the assignment under this paragraph.

- 7. EVENTS OF DEFAULT. Mortgagor shall be in default upon the occurrence of any of the following events, circumstances or conditions (Events of Delault):
  - A. Failure by any party obligated on the Obligations to make payment when due; or
  - B. A default or breach by Borrower, Mortgagor or any co-signer, endorser, surely, or guaranter under any of the terms of this Mortgage, the Note, any construction loan agreement or other loan agreement, any security agreement, mortgage, deed to secure debt, deed of trust, trust deed, or any other document or instrument evidencing, guarantying, securing or otherwise relating to the Obligations; or
  - C. The making or furnishing of any verbal or written representation, statement or warranty to Bank which is or becomes teles or incorrect in any material respect by or on behalf of Mortgagor, Borrowor, or any one of them, or any co-signer, endorser, surely or guarantor of the Obligations; or
  - D. Fallure to obtain or maintain the insurance coverages required by Bank, or insurance as is customary and proper for the Property (as herein defined); or
  - E. The death, dissolution or insolvency of, the appulntment of a receiver by or on bohalf of, the assignment for the benefit of creditors by or on behalf of, the voluntary or involuntary termination of existence by, or the commencement of any proceeding under any present or future federal or state insolvency, bankruptcy, reorganization, composition or debtor relief law by or against Mortgager, Borrower, or any one of them, or any co-signer, endorser, surety or guaranter of the Obligations; or

  - H. A material runges change in Mortgagor's business, including ownership, management, and financial conditions, which in Bank's oplinon, impairs the Property or repayment of the Obligations; or
  - 1. A transfer of a superiorial part of Mortgagor's money or property; or
  - J. If all or any pact of the Property or any Interest therein is sold, leased or transferred by Mortgagor except as permitted in the paragraph below entiter, "DUE ON SALE OR ENCUMBRANCE".
- 8. REMEDIES ON DEFAULT. At the option of Pank, all or any part of the principal of, and accrued interest on, the Obligations shall become immediately due and payable without in see or demand, upon the occurrence of an Event of Default or at any time thereafter. In addition, upon the occurrence of any Event of Default, Bank, at its option, may immediately commence foreclosure proceedings and may immediately invoke any or all other remedies provided in the Note, this Mortgage or related documents. Bank is entitled to all rights and remedies provided at law or equity whether or not expressly stated in this Mortgage. By choosing any terredy, Bank does not waive its right to an immediate use of any other remedy if the great of default continues or occurs again.
- 9. DUE ON SALE OR ENCUMBRANCE. Bank may, at Back's option, declare the entire balance with all accrued interest on the Obligations to be immediately due and payable upon the contract for, or are, flor of, any lion, encumbrance, transfer or sale of the Property, or any portion thereof, by Mortgagor. Lapse of time or the acceptance of payments by Bank after such creation of any lien, encumbrance, transfer or sale, or contract for any of the foregoing, shall not by deemed a waiver or estoppel of Bank's right to accelerate the Obligations. If Bank exercises such option to accelerate, Bank and really reall, by certified mail or otherwise, Mortgagor notice of acceleration to the address of Mortgagor shown on Bank's records; the notice site period of not less than 30 days from the date the notice is mailed within which Mortgagor shall pay the sums declared due. If Mortgagor fails to pay such sums prior to the expiration of such period, Bank may, without further notice or demand on Mortgagor, an oka any remedies permitted on Default. This covenant shall run with the Property and shall remain in effect until the Obligations and this Mr. Lage are fully paid.

In the preceding paragraph, the phrase "transfer or sale" includes the conveyance of any right, title or interest in the Property, whether voluntary or involuntary, by outright sale, deed, installment contract sale, land contract, contract for deed, 'essehold interest with a term greater than tikee years, lease-option contract or any other method of conveyance of the Property Interests; the term "interest" includes, whether legal or equitable, any right, title, interest, lien, claim, encumbrance or proprietely right, choate or incheate, any of which is superior to the ilen created by this Mortgage.

- 10. POSSESSION ON FORECLOSURE. If an action is brought to foreclose this Mortgage for all or any pert of the Obligations, Mortgagor agrees that the Bank shall be entitled to immediate possession as Mortgages in possession of the Property to the extent not prohibited by law, or the court may appoint, and Mortgagor hereby consents to such appointment, a receiver to take pussession of the Property and to collect and receive rents and profits arising therefrom. Any amounts so collected shall be used to pay taxes on, provide insurance for, pay costs of needed repairs and for any other expenses relating to the Property or the forecording proceedings, sale expenses or as authorized by the court. Any sum remaining after such payments will be applied to the Obligation.
- 11. PROPERTY OBLIGATIONS. Mortgagor shall promptly pay all taxes, assessments, levies, water rents, other rents, insurance premiums and all amounts due on any encumbrances, it any, as they become due. Montgagor shall provide written proof to Bank of such payment(s).
- t2. INSURANCE. Mortgagor shall lisure and keep insured the Property against loss by fire, and other hazard, casualty and loss, with 🕊 extended coverage including but not limited to the replacement value of all improvements, with an insurance company acceptable to Bank and in an amount acceptable to Bank. Such insurance shall contain the standard "Mongagee Clause" and where applicable, "Loss Payee Clause", which shall name and enderse Bank as mortgagee and loss payee. Such insurance shall also contain a prevision under which the insurer shall give Bank at least 30 days notice before the cancellation, termination or material change in coverage.

If an insurer elects to pay a fire or other hazard loss or damage claim rather than to repair, reballd or replace the Property lost or image. Property repaired or rebuilt. Mortgagor shall deliver or cause to deliver evidence of such coverage and copies of all notices and renowals relating thereto. Bank shall be entitled to pursue any claim under the insurance if Mortgagor falls in promotive do no

Mortgagor shall pay the premiums required to maintain such insurance in effect until such time as the requirement for such insurance

terminates. In the event Mortgagor falls to pay such premiums, Bank may, at its option, pay such premiums. Any such payment by Bank shall be repayable upon demand of Bank or if no demand is made, in accordance with the paragraph below titled "BANK MAY PAY".

- 13. WASTE. Mortgagor shall not alienate or encumber the Property to the projudice of Bank, or commit, permit or suffer any waste, impairment at deterioration of the Property, and regardices of natural depreciation, shall keep the Property and all its improvements at all times in good condition and repair. Mortgagor shall comply with and not violate any and all laws and regulations regarding the use, ownership and occupancy of the Property. Mortgagor shall perform and abide by as obligations and restrictions under any declarations, covenants and other documents governing the use, ownership and occupancy of the Property.
- 14. CONDITION OF PROPERTY. As to the Property, Mortgagor shall

A. keep all buildings occupied and keep all buildings, structures and improvements in good repair.

- B. retrain from the commission or allowance of any acts of waste or impairment of the value of the Property or improvements
- C. not cut or remove, or permit to be cut or removed, any wood or timber from the Property, which cutting or removel would adversely affect the value of the Property.
- prevent the opread of noxious or damaging weeds, preserve and prevent the crosion of the soil and continuously practice approved methods of farming on the Property if used for agricultural purposes.
- 15. ENTRONMENTAL LAVYS AND HAZARDOUS SUBSTANCES.
  - A. As used in waterwageaph:
    - (1) "F. vir.nmental Law" means, without limitation, the Comprehensive Environmental Response, Compensation, and Liabilit (A.) ("CERCLA", 42 U.S.C. 9601 et seq.), all federal, state and local laws, regulations, ordinances, court orders, arbitry general opinions or interpretive letters concerning the public health, safety, welfare, environment or a Hazardour, Substance (as defined herein).
    - (2) "Hazardous Subtance" means any toxic, radioactive or hazardous material, waste, pollutant or contaminant which has characteristics which render the substance dangerous or potentially dangerous to the public health, salety, welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material," "toxic substances," "hazardous waste" or "hazardous substances" under any Environmental Law.
  - B. Mortgagor represents, warrants and agrees that:
    - (1) Except as previously disclosed and acknowledged in writing to Bank, no Hazardous Substance has been, is or will be located, transported, manufactured, treated, refined, or handled by any person on, under or about the Property except in the ordinary course of business and in strict compliance with all applicable Environmental Law.
    - (2) Except as previously disclosed and sixhowledged in writing to Bank, Mortgagor has not and shall not cause, contribute to or permit the release of any Hramitous Substance on the Property.
    - (2) Mortgagor shall immediately notity Bank I. (a) a release or threatened release of Hazardous Substance occurs on, under or about the Property or migrates or the tens to migrate from nearby property; or (b) there is a violation of any Environmental Law concerning the Property. In such an event, Mortgagor shall take all necessary remodial action in accordance with any Environmental Law.
    - (4) Except as previously disclosed and scknowledged in writing to Bank, Mortgagor has no knowledge of or reason to believe there is any pending or threatened investigation claim, or proceeding of any kind relating to (a) any Hazardous Substance located on, under or about the Processy or (b) any violation by Morigagor or any tenant of any Environmental Law. Mortgagor shall immediately notify Bank in writing as soon as Mortgagor has reason to believe there is any such pending or threatened investigation, claim, or proceeding. In such an event, Bank has the right, but not the obligation, to participate in any such proceeding including the right to receive copies of any documents relating to such proceedings.
    - (5) Except as previously disclosed and acknowledged in writing to Bank, intergagor and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law.
    - (6) Except as previously disclosed and acknowledged in writing to Bank, there are no underground storage tanks, private dumps or open wells located on or under the Property and no such tank thinp or well shall be added unless Bank first agrees in writing.
    - (7) Mortgagor will regularly inspect the Property, monitor the activities and operations on the Property, and confirm that all pormits, licenses or approvals required by any applicable Environmental Law are obtained and compiled with.
    - (8) Mortgagor will permit, or cause any tenant to permit, Bank or Bank's agent to other and inspect the Property and review all records at any reasonable time to determine: (a) the existence, location, and nuture, of any Hazardous Substance on, under or about the Property; (b) the existence, location, nature, and magnitude of any Hazardous Substance that has been released on, under or about the Property; (c) whether or not Mortgagor and any tenant are in compliance with any applicable Environmental Law.
    - (8) Upon Bank's request, Mortgagor agrees, at Mortgagor's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Bank. The choice of the environmental engineer who will perform such audit is subject to the approval of Bank.
    - (10) Bank has the right, but not the obligation, to perform any of Mortgagor's obligations under this paragraph of Mortgagor's expense.
    - (11) As a consequence of any breach of any representation, warranty or promise made in this paragraph, (a) Mortgogor will indemnify and hold Bank and Bank's successors or assigns harmless from and against all losses, claims, demands, liabilities, damages, cleanup, response and remediation costs, penalties and expenses, including without limitation all costs of litigation and reasonable attorneys' fees, which Bank and Bank's successors or assigns may sustain; and (b) at Bank's discretion, Bank may release this Mortgage and in return Mortgager will provide Bank with collateral of at least equal value to the Property secured by this Mortgage without prejudice to any of Bank's rights under this Mortgage.
    - (12) Notwithstanding any of the language contained in this Mortgage to the contrary, the terms of this paragraph shall survive any foreclosuru or satisfaction of any deed of trust, mortgage or any obligation regardless of any passage of

title to Bank or any disposition by Bank of any or all of the Property. Any claims and detenses to the contrary are hereby waived.

- 18. INSPECTION BY BANK. Bank or its agents may make or cause to be made reasonable entries upon the Property and inspect the Property provided that Bank shall make reasonable efforts to give Mortgagor prior notice of any such inspection.
- 17. PROTECTION OF BANK'S SECURITY. It Mortgagor tails to perform any covenant, obligation or agreement contained in the Note, this Mortgago or any loan documents or if any action or proceeding is commenced which materially affects Bank's Interest in the Property, including, but not limited to, foreclosure, eminent dornain, insolvency, housing or Environmental Law or law enforcement, or arrangements or proceedings involving a bankrupt or decedent, then Bank, at Bank's sule option, may make such appearances, disburse such sums, and take such action as is necessary to protect Bank's interest. Mortgagor hereby assigns to Bank any right Mortgagor may have by reason of any prior encumbrance or; the Property or by law or otherwise to cure any default under said prior encumbrance. Without Bank's prior written consent, Mortgagor will not partition or subdivide the Property.
- 18. CCLLECTION EXPENSES. In the event of any default or action by Bank for collection of the Obligations, for protection of the i copiny or for foreclosure, Mortgagor agrees to pay all fees and expenses incurred by Bank. Such fees and expenses include but are not limited to filling fees, stringgrapher fees, witness fees, costs of publication, foreclosure minutes, and other expenses of collecting and enforcing the Obligations and protecting the Property. Any such collection expenses shall be added to the principal amount of the Obligations, shall accrue interer; at the same rate as the Obligations and shall be secured by this Mortgage.
- 19. ATTORNEYS' FEES. If the event of any default or action by Bank for collection of the Obligations, for protection of the Property or for toreclosure, Mortgagor agrees to pay reasonable attorneys' less, paralogal less and other legal expenses focured by Bank. Any such reasonable attorneys' less that the added to the principal amount of the Obligations, shall accrue interest at the same rate as the Obligations and shall be secured by this Mortgage.
- 20. CONDEMNATION. In the event all or any part of the Property (including but not limited to any easement therein) is sought to be taken by private taking or by virtue of the law of ardinent domain, Mortgagor will promptly give written notice to Bank of the institution of such proceedings. Mortgagor further agrees to notify Bank of any attempt to purchase or appropriate the Property or any easement therein, by any public authority or by any other person or corporation claiming or having the right of eminent domain or appropriation. Mortgagor further agrees and directs that all condemnation proceeds or purchase money which may be agreed upon or which may be found to be due shall be paid to Bank as a preparation funder the Note. Mortgagor also agrees to notify the Bank of any proceedings instituted for the establishment of any sewer, ware, conservation, ditch, drainage, or other district relating to or binding upon the Property or any part thereof. All awards payable for the "arring of title to, or possession of, or damage to all or any portion of the Property by reason of any private taking, condemnation, eminent of main, change of grade, or other proceeding shall, at the option of Bank, be paid to Bank. Such awards or compensation are hereby assign of to Bank, and judgment therefor shall be entered in favor of Bank.

When peid, such awards shall be used, at Bank's option, toward the payment of the Obligations or payment of taxes, assessments, repairs or other items provided for in this Mortgage, whether due or not, all in such order and manner as Bank may determine. Such application or release shall not cure or waive any detault.
