THIS MCRIGAGE, ASSIGNMENT OF RENTS. - 1. <u>Principal, Interest and Other Payments</u>. Mortgagor shall promptly pay when due the principal of and interest on the indebtedness evidented by the Note, and the principal of and interest on any future advances allowed under and secured by this Mortgage and all other amounts due and payable to Mortgage under the Note or at any time secured by this Mortgage (all such payments are collectively referred to in this Mortgage as the "indebtedness secured hereby").
- 2. <u>Maintenance, Repair and Restoration of Improvements: Payment of Taxes and Liens, Etc.</u>
 Mortgagor shall:
- (a) Promptly repair, restore or rebuild any improvement now or hereafter on the Premises which may become damaged or destroyed.
- (b) Pay immediately when due and payable and before any penalty attaches all general taxes, special taxes, special assessments, water charges, sewer service charges and other taxes and charges against the Premises, including those heretofore due, and to furnish Mongagee, upon request, with the original or duplicate receipts therefor, and all such items extended against the Premises shall be conclusively deemed valid for the purpose of this requirement. To prevent default hereunder, Mongagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mongagor may desire to contest. In all cases Mortgagee is authorized to collect and receipt for any such insurance proceeds and the expenses incurred by Mortgagee in the objectment and collection of insurance proceeds shall be such additional indebtedness secured hereby and shall be reimbursed to Mortgagee upon demand with interest thereon at the Default Interest Rate or may be deducted by Montagee from said insurance proceeds prior to any other application thereof. insurance proceeds may, at the option of Mortgagee, be applied in the reduction of the indebtedness secured hereby, whether due or not, in such order as Mortgagee shall determine, or be held by Mortgagee and used to reimburse Mortgagor for the cost of rebuilding or restoring buildings or improvements on the Premises. Notwithstanding the foregoing, the inst rance proceeds may be made available to Mortgagor to repair and restore the Premises if, and only if, in Mortgag e's sole and absolute discretion, all of the following conditions are satisfied: (i) no Default, or event which with the giving of notice or passage of time would constitute a Default, shall have occurred hereunder or under any of the other Loan Documents; (ii) the insurance proceeds shall, in Mortgagee's sole and absolute judgment, be sufficient to complete the repair and restoration of the buildings, structures and other improvements on the Premises to in architectural and economic unit of substantially the same character and the same value as existed immediately prior to such casualty, or, if Mortgagee shall determine, in its sole and absolute discretion, that the insurance proceeds are insufficient, Mortgagor shall have deposited with Mortgagee the amount of the deficiency in cash within lifteen (15) days after Mortgagee's demand therefor, (iii) after such repair or restoration, the Premises shall, in Mortgagee's sole and absolute judgment, adequately secure the outstanding balance of the indebtedness secured in eby; (iv) any and all leases of the Premises remain in full force and effect and under the leases the Mortgagor is obligated to repair and restore the Mortgaged Premises; (v) the usurers do not deny liability to either of the insureds, and (vi) with respect to any claims for any loss or damage arising out of a single occurrence which shall in the aggregate exceed Fifteen Thousand and No/100 Dollars (\$15,000), such loss or damage does not occur during the 1 st tivelve (12) months of the term of the Note.

- (b) Mortgagor represents and agrees that no rent has been or will be paid by any person in possession of any nortion of the Premises for more than two installments in advance, and that no payment of rents to accrue for any portion of the Premises has been or will be waived, released, reduced, discounted, or otherwise discharged or compremised by Mortgagor. Mortgagor waives any right of set off against any person in possession of any portion of the Premises. Mortgagor agrees that it will not assign any of the rents or profits of the Premises, except to a purchaser or grantee of the Premises.
- (c) Nothing herein contained shall be construed as constituting Mortgagee as a mortgagee in possession in the absence of the taking of actual possession of the Premises by Mortgagee. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagee.
- (d) Mortgagor further agrees to assign and transfer to Mortgagee all future leases regarding all or any part of the Premises hereinbefore described and to execute and deliver, at the request of Mortgagee, all such further assurances and assignments pertaining to the Premises as Mortgagee shall from time to time require.
