

This promissory note is made between Alina Teresa Jaroslawska, hereinafter referred to as "Alina", and Andrew Jaroslawski, hereinafter referred to as " Andrew".

Alina states that she has loaned the following sums of money to Andrew and Andrew acknowleges the receipt of these sums:

- On April 2, 1993, Alina lent Andrew the sum of fourteen thousand dollars (\$14,000.00) which was used to purchase a residence at 9468 Bay Colony Drive in Des Plaines, Illinois.
