FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 6th day of November 1996 by and between
MIGUEL A. RAMIREZ and LUZ C. RAMIREZ, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated November 6, 1996 (herein "Note") with a credit limit of Twenty Five Thousand Dollars and no/100 dollars (\$ 25,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXXXXXXXXXX (S X X) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim, and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly premium installments for hazard insurance, and ground rents on the property if any, plus one-twelfth of yearly premium installments for hazard insurance, and taxes and assessments which may alias priority over documents, second, to the payment of any sums due under Paragraph 2 hereof; third, to the payment of interest permitted by law) delineations of the Credit Documents, costs and expenses of exercising rights and remedies granted under the Credit Agreement; fourth, to the payment of principal of the Note; and then to interest and principal on any future Advances.

1. PAYMENT AND COMPLIANCE WITH NOTE; APPLICATION OF PAYMENTS. Borrower shall when due the principal and interest on the indebtedness evidenced by the Note together with any late charges or other charges imposed under the Note, and the principal and interest on any Funds levied in Paragraph 27 below) secured by this Mortgage. Unless applicable law requires otherwise, all payments received under the Note and this Mortgage shall be applied by Lender first in Payment of any additional sums owing to Lender pursuant to the provisions of the Credit Documents, whether as advances, attorney's fees (to the extent permitted by law) delineations of the Credit Documents, costs and expenses of exercising rights and remedies granted under the Credit Agreement; second, to the payment of any sums due under the Credit Documents, costs and expenses of exercising rights and remedies granted under the Credit Agreement; third, to the payment of principal of the Note; and then to interest and principal on any future Advances.

COVENANTS. Borrower and Lender covenant and agree as follows:

Borrower acknowledges that the Note calls for a variable interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder, reduce the amount of credit available, and/or require repayment of the outstanding balance under the Note.

THIS MORTGAGE IS GIVEN TO SECURE: (i) the repayment of the indebtedness evidenced by the Note; (ii) the payment of all other sums, with interest thereon, advanced in account, agree herewith to protect the security of this Mortgage; and (iii) the performance of the covenants and agreements of Borrower contained herein and in the Note, given to evidence the indebtedness evidenced by the Note are contained in the Credit Documents. The Credit Documents constitute and this Mortgage permits and enables, future advances.

TO HAVE AND TO HOLD the Property unto Lender, its successors and assigns, forever, for the uses and purposes set forth herein.

Borrower conveys and mortgages the property, and the estate in land hereby conveyed and has the right to grant, convey or dispose of the same to any person, firm or corporation in any way the condition of title or Deed of Trust in favor of Gentry, and recorded/re registred September 2, 1993 as Document No. 9303310 in the Office of the Recorder of Deeds/Register of Titles, C. O. K. County, Illinois. Borrower (unless Borrower is a Trustee) conveys that Borrower warrants and will defend generally the title to the property against all claims and demands, subject to encumbrances of record. Borrower covenants that Borrower will neither take nor permit any action to partition or subdivide the property or otherwise change the legal description of any part thereof, or change in any way the condition of title of the property of any part thereof.

Agreement under the UCC for the purpose of creating a security interest in such property, which Borrower hereby grants to Lender as Secured Party (as such term is defined in the UCC); and not withstanding to the contrary herein, the property shall include all of Borrower's rights, title, and interest in and to the real property described above whether such rights, title, and interest acquired before or after execution of this Mortgage.

Specifically and without limitation of the foregoing, if this Mortgage is given with respect to a leasehold held by Borrower, and Borrower subsequently acquires a fee interest in the real property, the lien of this Mortgage shall attach to and include the fee interest acquired by Borrower.

TOGETHER WITH all improvements now or hereafter erected on the property, and all easements, rights,

restitutions, royalties in general, oil and gas rights and profits, water, water rights, and water stock, insurance and rentals, and rents (subject however to the rights and authorities given herein to Lender to collect and apply such property, and rents), and all additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property"; as to any property which does not constitute a fixture (as replacement proceeds, and all fixtures now or hereafter attached to the property, all of which, including condominiums and additons thereto, shall be deemed to be and remain a part of the property covered by this Mortgage); and all fixtures now or hereafter attached to the property, all of which, including

insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds, if any, are pledged as additional security for the sums secured by this Mortgage, and are held by Lender as a creditor and not as a trustee.

If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

3. PRIOR ENCUMBRANCE; CHARGES; LIENS. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 1 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

4. HAZARD INSURANCE. Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

6. **PROTECTOR'S SECURITY.** If Borrower fails to perform the covenants and agreements contained in this Mortgage or in the Credit Documents, or if any action or proceeding is commenced which affects Lender's interest in the Property or the rights of Lender hereunder, including but not limited to eminent domain, insolvency, code enforcement or arrangements involving a bankruptcy or receivership, without demand upon Borrower but upon notice to Borrower pursuant to Paragraph 11 hereof, then Lender, Borrower from any obligation in this Mortgage, make such appearances, defend the action or proceedings, disburse such sums, including reasonable attorney's fees, and take such action as Lender deems necessary to protect the security of this Mortgage. If Lender has required mortgage insurance as a condition of making the loan secured by this Mortgage, Borrower shall pay the premiums required to maintain such insurance in effect until such time as the requirement for such insurance terminates in accordance with Borrower's written agreement of applicable law.

5. PRESERVATION AND MAINTENANCE OF PROPERTY: LEASEHOLDS; CONDOMINIUMS; PLANNED UNIT DEVELOPMENTS; BORROWER SHALL USE, IMPROVE AND MAINTAIN THE PROPERTY IN COMPLIANCE WITH APPLICABLE LAWS, STATUTES, ORDINANCES, DECREES OR REGULATIONS, SHALL KEEP THE PROPERTY IN GOOD CONDITION AND REPAIR INCLUDING THE REPAIR OR RESTORATION OF ANY IMPROVEMENTS ON THE PROPERTY, WHICH MAY BE DAMAGED OR DESTROYED, SHALL NOT COMMIT OR PERMIT IMPAIRMENT OR DEGENERATION OF THE PROPERTY, AND SHALL FULLY AND PROMPTLY COMPLY WITH THE PROVISIONS OF ANY LEASE IN THIS MORTGAGE IS ON A LEASEHOLD, IF THIS MORTGAGE IS ON A UNIT IN A CONDOMINIUM OR A PLANNED UNIT DEVELOPMENT, BORROWER SHALL PROMPTLY PERFORM ALL OF BORROWER'S OBLIGATIONS UNDER THE DECLARATION OF CONDOMINIUM OR PLANNED UNIT DEVELOPMENT, WHICH MAY BE RECAST FROM TIME TO TIME. IF A CONDOMINIUM OR PLANNED UNIT DEVELOPMENT RIDER IS EXECUTED BY BORROWER AND RECORDS LOGICALLY WITH THIS MORTGAGE, THE CONDOMINIUM OR PLANNED UNIT DEVELOPMENT RIDER SHALL BE INCORPORATED INTO AND SHALL AMEND AND SUPPLEMENT THE COVENANTS AND AGREEMENTS OF THIS MORTGAGE AS IF THE RIDER WERE A PART HEREOF.

Units less Leander and Borger other wise agree in writing, any such application or proceeds to principal shall not exceed or postpone the due date of the installments referred to in Paragraph 1 and I believe or change the amount of such installments.

If under Paragraph 17 hereof the Property is acquired by Lender, all rights, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to such sale or acquisition shall become the property of Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

If the Property is abandoned by Borrower or if Borrower fails to respond to Lender's written notice within thirty (30) calendar days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at Lender's sole option either to restoration or repair the Property or to the sums secured by this Mortgage.

Subjec^t to the t^{erms} and t^{erms} of any Mortgage, deed of trust or other security agreement with a lien which has or appears to have a priority over this Mortgage and unless Borrower and Lender otherwise agree in writing insurance proceeds shall be applied to restoration of the Property damaged, provided such restoration or repair is economical^{ly} feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economical^{ly} feasible and the security of this Mortgage is not thereby impaired, the Insuranc^e shall not cover or waive any economic^{ly} feasible or in the security of this Mortgage would be impaired, the Insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. Such application shall not cure or waive any default under this Mortgage or invalidate any act done pursuant to such notice.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDEMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Borrower or if, after notice by Lender to Borrower that the condemnor offers to make an award or settle a claim for damages, Borrower fails to respond to Lender within thirty (30) days after the date such notice is mailed, Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the installments referred to in Paragraph 1 and 2 hereof or change the amount of such installments.

9. **BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER.** Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release in any manner the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof, Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission or commission, to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by Lender. Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event. The procurement of insurance or the payment of taxes, other liens or charges by Lender shall not be a waiver of Lender's right as otherwise provided in this Mortgage to accelerate the maturity of the indebtedness secured by this Mortgage in the event of Borrower's default under this Mortgage or the other Credit Documents.

10. **SUCCESSORS AND ASSIGNS BOUND; JOINT AND SEVERAL LIABILITY; CO-SIGNERS; CAPTIONS.** As used herein, the terms "Borrower" and "Lender" shall include their respective heirs, devisees, endorsees, guarantors, sureties, endorsers, legal representatives, successors, assigns and subsequent holders of the Note. All of the terms, covenants, conditions, and agreements set forth herein shall be binding upon and terms to the benefit of such parties except that no right shall inure to any successor of Borrower unless consumed to by Lender as herein provided. Borrower hereby acknowledges that Lender may freely assign or transfer all or any part of Lender's rights hereunder. If one or more person or entity signs this Mortgage, each of them is jointly and severally obligated hereunder. Any

B. Set forth below is a list of events which, upon the lapse of the grace period, if any, shown parentetically after such event, will constitute an Event of Default: (1) Borrower's failure to pay due under the Credit Agreement (30 day grace period); (2) Borrower's receipt of notice from material misrepresentation by Borrower in connection with the line of credit, whether contained in or omitted from Borrower's credit application or communication during the term of the Note (no grace period); (3) Borrower's death or change in marital status and the transfer of Borrower's interest in the Collateral (as such term is defined in the Security Agreement) to someone who is a signee of all the Credit Documents; if any, and, as a result thereof, Lender's right to receive payment of the Note prior to its due date; (4) Borrower's failure to make any payment of principal or interest when due, or any other amount due under the Credit Agreement (30 day grace period); (5) Borrower's sale or transfer of the Collateral, whether voluntary or involuntary, without Lender's prior written consent (no grace period); (6) the sale or transfer of, or promise to sell or transfer, all or any part of the Property or any interest therein, of any interest in the Note or any rights of the Lender in such security or adversely affected (no grace period); (7) any security interest of the Note or any rights of the Lender in such security or adversely affected (no grace period); (8) any other event or circumstance which, in the opinion of Lender, results in a material impairment of the value of the Collateral.

A. An Event of Default will occur under upon the expiration of the applicable grace period, if any, after Lender gives Borrower written notice of the breach of Borrower's promises under the terms of the Credit Document and upon Borrower's failure to cure such breach and to provide Lender with evidence reasonably satisfactory to it of such cure, within the applicable grace period, if any. In each case, the grace period beginning on the day after notice is given, and upon Borrower's failure to cure such breach and to provide Lender with evidence reasonably satisfactory to it of such cure, within the applicable grace period, if any, on the last day of the period. All grace periods in case of default days, not business days. If there is no grace period of the notice, such notice shall be given to Borrower in accordance with Paragraph 11 hereof and shall contain the following information: (1) the nature of Borrower's breach; (2) the specific period, if any, during which such breach must be cured; and (3) whether failure to cure such breach within the specified grace period, if any, will result in acceleration of the sums secured by this Mortgage and the potential foreclosure of this Mortgage. The notice shall further inform Borrower of the right, if any under applicable law, to repossess the revolving line of credit under this Mortgage after acceleration.

14. REMEDIES CUMULATIVE. Lennder may exercise all of the rights and remedies provided in this Mortgage and in the Credit Documents, or which may be available to Lennder by law, and all such rights and remedies shall be cumulative and concurrent, and may be pursued singly, successively or together, at Lennder's sole discretion, and may be exercised as often as occasion arises in connection therewith.

12. GOVERNMENT LAW: SEVERABILITY: This Mortgage shall also govern the construction, enforcement and interpretation of the laws of the State of Illinois, which laws shall control the construction of this Note.

13. BORROWER'S COPY: Borrower shall be furnished a conforming copy of this Note and of this Mortgage at the time of execution or after recordation hereof.

11. **NOTICES.** Except for any notice required under applicable law to be given in another manner: (a) Any notice to Borrower provided for in this Mortgage shall be given by hand deliverying it to, or by mailing such notice by registered mail addressed to Borrower at the address given in this Mortgage; (b) any notice required under applicable law to Borrower as provided hereinafter shall be given by written notice to Borrower as provided hereinafter; and (c) any notice required under applicable law to Lender shall be given by registered mail addressed to Lender at 800 Wakeland Road, Glenview Illinois 60025 or to such other address as Lender may designate by written notice to Lender; and (d) any notice to Lender shall be given by registered mail addressed to Borrower as provided hereinafter; and (e) any notice required under applicable law to the Property Address or at such other address as Borrower may designate by written notice to Borrower as provided hereinafter; and (f) any notice required under applicable law to the date holder of this Mortgage is actually made or the date notice is deposited into the U.S. mail system as described in this Paragraph 11.

Borrower who consigns this Mortgage, but does not execute the Note, (a) is co-signing this Mortgage only to consumer Borrower's interest in the Property under the Note or under this Mortgage, (b) is not personally liable on the Note or under this Mortgage, and (c) agrees that Lender and any other Borrower may agree to extend, modify, redebit, or make any other accommodations with regard to the terms of this Note, without giving notice to any other Borrower.

the amendment or termination of any ground leases affecting the Property and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected; (6) Borrower files for bankruptcy, or bankruptcy proceedings are instituted against Borrower and not dismissed within sixty (60) calendar days, under any provisions of any state or federal bankruptcy law in effect at the time of filing and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected (no grace period); (7) Borrower makes an assignment for the benefit of Borrower's creditors, becomes insolvent or becomes unable to meet Borrower's obligations generally as they become due and, as a result thereof, Lender's security for the Note and rights of Lender in the security are adversely affected (no grace period); (8) Borrower further encumbers the Property or Collateral, if any, or suffers a lien, claim of lien or encumbrance against the Property or the Collateral, if any and, as a result thereof Lender's security for the Note or any rights of Lender in the security are adversely affected (30 day grace period in which to remove the lien, claim of lien or encumbrance); (9) Borrower is in default or an action is filed alleging a default under any credit instrument or mortgage evidencing or securing an obligation of Borrower with priority in right of payment over the line of credit described in the Credit Documents or whose lien has or appears to have any priority over the lien created by the Mortgage or the security interest created by the Security Agreement or any of Borrower's other creditors attempts to (or actually does) seize or obtain a writ of attachment against the Property or the Collateral, if any and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected (no grace period); (10) Borrower fails to keep any other covenant contained in any of the Credit Documents not otherwise specified in Paragraph 15 (ten (10) day grace period, unless the failure is by its nature not curable, in which case no grace period or, if another grace period is specified in the Credit Documents, that grace period will prevail); or (11) any action or inaction by Borrower which adversely affects Lender's security for this Note or any right of Lender in such security (no grace period).
