#### MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT

THIS MOREGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT (the "Mortgage") is dated November 1, 1996, by and between BASSAM HAJ YOUSIF ("Mortgagor") and PRAIRIE BANK & TRUST CO., an Illinois banking association, 7661 South Harlem Avenue, Budgeview, Illinois 60455 (the "Mortgagee").

#### WITNESSETH

THAT WHEREAS on November 1, 1996, PRAIRIE BANK & TRUST CO., not personally but as Trustee under Trust Agreement dated October 25, 1996, and known as Trust No. 96-082, and JOSEPH ZIVKOVIC executed a Construction Note payable to Mortgagee in the amount of FOUR HUNDRED NINETY THOUSAND AND NO/100 DOLLARS (\$490,000.00) (the "Zivkovic Note") and PRAIRIE BANK & TRUST CC.. not personally, but as Trustee under Trust Agreement dated October 25, 1996, and known as Trust No. 96-083 and BASSAM HAJ YOUSIF, ISSAM HAJ YOUSIF and HOUSAM HAJ YOUSIF executed a Construction Note payable to Mortgagee in the amount of FOUR HUNDRED MINETY THOUSAND AND NO/100 DOLLAR (\$490,000.00) (the "Haj Yousif Note") (the Zivkovic Note and the Haj Yousif Note are hereinafter jointly referred to as the "Notes"), payable with interest on the principal balance from time to time outstanding at a rate equal to One (1%) percent in excess of the Prime Rate (hereinafter defined) per annum. After default or maturity, interest accrues and is payable on the principal balance of the Notes at a rate equal to five (5%) percent in excess of the aforesaid rate. The entire remaining balance of principal and interest is due on or before November 1, 1997.

NOW THEREFORE, the Mortgagor, to secure the payment of the Indebtedness (hereafter defined) including interest and late charges in accordance with the terms, provisions and limitation of this Mortgage, of the Notes, the performance of the obligations of Borrower under the terms of that certain Construction Loan Agreement, dated November 1, 1996, between Prairie Bank & Trust Co., not personally but as Trustee under Trust Agreement dated October 25, 1996, and known as Trust No. 96-082, and Joseph Zivkovic, as Borrower, and Mortgagee, as Lender, the performance of the obligations of Borrower under the terms of that

All of the land, estate and property hereinabove described, real, personal and mixed, whether affixed or infraced or not (except where otherwise hereinabove specified) and all rights hereby conveyed and mortgaged are intended so to be as a unit and are hereby understood, agreed and declared (to the maximum extent permitted by law) to form part and parcel of the real estate and to be appropriated to the use of the real estate, and shall be, for the purposes of this Mortgage, deemed to be real estate and conveyed and mortgaged hereby.

As used herein, the term "Prime Rate" at any time shall mean the rate of interest then most recently announced at Mortgagee's corporate office as Mortgagee's Prime Rute; provided, however, that in the event that Mortgagee ceases to use the term "Prime Rate" in setting a base rate of interest for commercial loans, then the Prime Rate shall be determined by reference to such base rate as designated in writing by Mortgagee to Mortgagor. Mortgagee makes no representation or warranty that the Prime Rate is the lowest or best rate of interest offered by the Mortgagee to commercial or other borrowers.

TO HAVE AND TO HOLD the Premises unto the Mortgagee and its successors and assigns until all Indebtedness evidenced by the Notes is fully discharged, for the purposes and uses herein set forth.

#### IT IS FURTHER UNDERSTOOD AND AGREED THAT:

- 1. Maintenance, Repair and Restoration of Improvements, Payment of Prior Liens, etc. Mortgagor shall: (a) to the extent of available insurance proceeds, promptly repair, restore or rebuild any buildings and other improvements now or hereafter on the Premises which may become damaged or destroyed to substantially the same character as prior to such damage or destruction: (b) keep the Premises constantly in good condition and repair, without waste; (c) keep the Premises free from mechanics' liens or other liens or claims for lien not expressly subordinated to the lien hereof (collectively called "Liens"), subject, however, to the rights of the Mortgagor set forth in Paragraph 2 below: (d) immediately pay when due any indebtedness which may be secured by a lien or charge on the Premises on a parity with or superior to the lien hereof (no such lien to be permitted hereunder), and upon request exhibit satisfactory evidence of the discharge of such lien to Mortgagee, subject, however, to the rights of the Mortgagor set forth in Paragraph 2 below; (e) complete within a reasonable time any building(s) or other improvement(s) now or at any time in process of crection upon the Premises; (f) comply with all federal, state and local requirements of law, regulations, ordinances, orders and judgments and all covenants, ensements and restrictions of record with respect to the premises and the use thereof; (g) except as provided in the Lease, make no alterations in the premises without Mortgagoe's prior written consent which consent shall not be unreasonably withheld or delayed; (h) suffer or permit no change in the general nature of the occupancy of the Premises without Mortgagee's prior written consent; (i) observe and comply with all conditions and requirements (if any) necessary to preserve and extend all rights, casements, liconses, permits (including without limitation, zoning variations and any non-conforming uses and structures), privileges, franchises and concessions applicable to the Premises or contracted for in connection with any present or future use of the Premises; and (k) pay each item of indebtedness secured by this Mortgage when due according to the terms hereof and of the Notes.
- 2. Right to Contest. Anything in Paragraphs 4 and 5 of this Mortgage to the contrary notwithstanding, Mortgagor may, in good faith and with regentable diligence, contest the validity or amount of any lien on the Premises, and defer payment and discharge thereof during the pending of such contest, provided, (a) that such contest shall have the effect of preventing the sale or forfeiture of the Premises or any part thereof, or any liariest therein, to satisfy such lien; (b) that, within thirty (30) days after Mortgagor has been notified of the assertion of such lien Mortgagor shall have notified Mortgagee in writing of Wortgagor's intention to contest such lien; and (c) that Mortgagor shall have deposited with Mortgageo at such place as Mortgagee may from time to time in writing appoint, and in the absence of such appointment, then at the office of Mortgagee, a sum of money which shall be sufficient in the reasonable judgment of Mortgagee to pay in full such lien and all interest which might become due thereon, and shall keep on deposit an amount so sufficient at all times, increasing such amount to cover additional interest whenever, in the reasonable judgment of Mortgagee, such increase is advisable or shall obtain a title endorsement or title indomnity to the lender's title insurance policies of Mortgageo or a surety bond of a surety company reasonably satisfactory to Mortgagee, insuring or bonding Mortgagee against any harm as a result of such contest. plus any interest finally determined to be due upon the conclusion of such contest, to the extent such amount exceeds the amount which Mortgagee will pay as provided below, or shall fail to maintain sufficient funds on deposit as hereinabove provided or to provide a title endorsement or indemnity or surety bond, Mortgagee may, at its option, apply any money so deposited in payment of or on account of such lien, or that part thereof then unpaid, together with all interest thereon. If the amount of money so deposited shall be insufficient for the payment in full of such lien, together with all interest thereon. Mortgager shall forthwith, upon demand, deposit with Mortgagee a sum which, when added to the funds then on deposit, shall be sufficient to make such payment in full. Mortgagee shall, upon the final disposition of such contest, apply any money so deposited in full payment of such lien or that part thereof then unpaid, together with all interest thereon (provided Mortgagor is not then in default hereunder) when so requested in writing by Mortgagor and when furnished by Mortgagor with sufficient funds to make such payment in full and with evidence satisfactory to Mortgagee of the amount of payment to be made.

- 3. Indebtedness. "Indebtedness" means all obligations of Mortgagor and the Borrower under the Notes to Mortgage for payment of any and all amounts due under the Notes or this Mortgage, together with any and all indebtedness at any time owing from the beneficiaries of Maker, howsoever and whensoever arising or created. "Indebtedness" also includes all amounts so described herein and all costs of collection, legal expenses and in-house or reasonable outside attorneys' fees incurred or paid by Mortgagee in attempting the collection or enforcement of the Notes or this Mortgage, or any extension or modification of this Mortgage or the Notes, and guaranty of the Notes, or in any legal proceeding occurring by reason of Mortgagee's being the mortgagee under this Mortgage or any extension or modification thereof or the payee under the Notes or any extension or modification thereof, including but not limited to any declaratory judgment action, or in the repossession, custody, sale, lease, assembly or other disposition of any collateral for the Notes. Notwithstanding enything contained herein to the contrary, in no event shall the lien of this Mortgage secure outs and ingliabilities in excess of 200% of the original stated principal amount of the Notes.
- Payment of Taxes. Mortgagor shall pay all general taxes before any penalty interest attaches, and shall pay special taxes, special assessments, water charges, sewer service charges, and all other charges against the Premises of any nature whatsoever when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor within thirty (30) days following the date of payment. Mortgagor may pay in full "under protest" any tax or assessment which Mortgagor may desire to contest, in the manner provided by law. If Mortgagor does not elect to pay under protest, Mortgagor will post such bond or other security as Mortgagee may reasonably require to protect the lien of this Mortgage.
- 5. Tax Deposits. Mortgagor shall deposit with the Mortgagee or such depositary ("Depositary") as the Mortgagee may from time to time in writing appoint, and in the absence of such appointment, then at the office of Mortgagee, commencing within ten (10) days of such request and continuing on the first day of each month following thereafter, a sum equal to one

twelfth (1/12) the amount of all real estate taxes and assessments (general and special) assessed against the Premises, as computed by Mortgagee. Such deposits are to be held without any allowance of interest to Mortgagor and are to be used for the payment of taxes and assessments (general and special) on the Premises next due and payable when they become due. If the funds so deposited are insufficient to pay any such taxes or assessments (general or special) when the same become due and payable, the Mortgagor shall, not later than the thirtieth (30th) day prior to the last day on which the same may be paid without penalty or interest, deposit with the Mortgagee or the Depositary such additional funds as may be necessary to pay such taxes and assessments (general and special) in full. If the funds so deposited exceed the amount required to pay such taxes and assessments (general and special) for any year, the excess shall be applied on a subsequent deposit or deposits. Said deposits need not be deposited separate and apart from any other funds of the Mortgagee or the Depositary.

If any such taxes or assessments (general or special) shall be levied, charged, assessed or imposed upon or for the premises, or any portion thereof, and if such taxes or assessments shall also be a levy, charge, assessment or imposition upon or for any other premises not encumbered by the lien of this Mortgage, then the computation of any amount to be deposited under this Paragraph 5 shall be based upon the entire amount of such taxes or assessments, and Mortgagor shall not have the right to apportion the amount of any such taxes or assessments for the purposes of such computation.

Mortgagor shall keep all buildings and improvements and the б. Insurance. Collateral (defined in Paragraph 10 below) now or hereafter situated on said Premises insured against loss or damage by fire, lightning, wind storm, hail storm, aircraft, vehicles, smoke, explosion, riot or civil commotion as provided by the standard all risks policy and against such other hazards as may reasonably be required by Mortgaves, including without limitation of the generality of the foregoing: (a) rent loss or business interruption insurance to cover losses for not less than twelve (12) months; and (b) flood insurance whenever same is available and, in the reasonable opinion of Mortgagee, such protection is necessary. Mortgagor shall also provide insurance coverage with such limits for injury to and death of any person or damage to property of a combined single limit coverage of not less than the indebtedness secured hereby. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts satisfactory to Mortgagee, with waiver of subrogation and full replacement cost endorsements and a standard non-contributory mortgagee clause attached to all policies, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days prior written notice to the Mortgagee. Mortgagor shall deliver the original policy to the Mortgagee and, in the case of insurance about to expire, shall deliver a certificate evidencing renewal not less than twenty-five (25) days prior to their respective dates of expiration.

Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained hereunder unless Mortgagee is included thereon under a standard non-contributory mortgagee clause acceptable to Mortgagee. Mortgagor shall immediately notify Mortgagee whenever any such separate insurance is taken out and shall promptly deliver to Mortgagee the original policy of insurance. In the event of a foreclosure of

the lien of this Mortgage, or of a transfer of title to the Premises either in lieu of forcelosure or by purchase at the forcelosure sale, all interest in all insurance policies in force shall pass to Mortgagee, transferce or purchaser, as the case may be.

- 7. Insurance Deposits. Mortgagor shall deposit with the Mortgagee or the Depositary for the purpose of providing funds with which to pay premiums when due on all policies of fire and other hazard insurance covering the Premises and the Collateral(defined below), commencing within ten (10) days of such request and on the first day of each month following thereafter, a sum equal to the Mortgagee's estimate of the premiums that will next become due and payable on such policies reduced by the amount, if any, then on deposit with the Mortgagee or the Depositary, divided by the number of months to elapse before one (1) month prior to the date when such premiums become due and payable. No interest shall be allowed to Mortgagor on account of any deposit and said deposit need not be kept separate and apart from any other funds of the Mortgagee or the Depositary.
- 8. Mortgagee's Interest In and Use of Tax and Insurance Deposits: Security Interest. If an Event of Default exists or occurs hereunder, the Mortgagee may, at its option but without being required so to do, apply any monies at the time on deposit pursuant to Paragraphs. 5 and 7 hereof on any of Mortgagor's obligations contained herein or in the Notes, in such order and manner as the Mortgagee may elect. When the Indebtedness has been fully paid, any remaining deposits shall be paid to Mortgagor of to the then owner or owners of the Premises as the same appear on the records of the Mortgagee. If the Mortgagee elects to make said proceeds available to reimburse Mortgagor or any lessee for the cost of repair, rebuilding or restoration of buildings or other improvements on the Premises, such proceeds shall be made available under

the terms of a standard construction escrow and shall be disbursed on receipt of architect's certificates, lien waivers and any other documentation or certificates required under the terms of standard construction escrows. If the buildings and other improvements shall be so repaired, restored or rebuilt, such repaired, restored or rebuilt buildings and other improvements shall be of at least equal value and substantially the same character as prior to such damage or destruction. The Mortgagee must approve plans and specifications of such work before such work shall be commenced which approval shall not be unreasonably withheld or denied. If the proceeds are made available by the Mortgagee to reimburse the Mortgager or any lessee for the cost of repair, rebuilding or restoration, any proceeds remaining after payment of all costs of such repair, rebuilding or restoration and the reasonable charges of the Disbursing Party (hereinafter defined) shall, be paid to any party entitled thereto as the same appear on the records of the Mortgagee. Any proceeds of insurance held by the Disbursing Party shall be invested in an interest-bearing account for the benefit of Mortgagor which is insured by an agency of the United States Government. The rick of loss of such funds, while so invested shall be borne solely by Mortgagor.

As used in the Paragraph 9, the term "Dishursing Party" refers to the Mortgagee and to any responsible trust company or atte insurance company selected by the Mortgagee.

The reasonable expenses of retaking, holding, preparing for sale, selling and the like incurred by the Mortgagee shall include, but not be limited to, reasonable attorneys' fees and legal expenses incurred by Mortgagee. The Mortgager agrees that, without the written consent of the Mortgagee, the Mortgagor will not remove or permit to be removed from the Premises any of the Collateral except that so long as no

Event of Default exists or occurs hereunder, Mortgagor shall be permitted to sell or otherwise dispose of the Collateral when obsolete, worn out, inadequate, unserviceable or unnecessary for use in the operation of the Premises, but only upon replacing the same or substituting for the same other Collateral at least equal in value and utility to the initial value and utility of that disposed of and in such a manner that said replacement or substituted Collateral shall be subject to the security interest created hereby and that the security interest of the Mortgagee shall be perfected and first in priority, it being expressly understood and agreed that all replacements, substitutions and additions to the Collateral shall be and become immediately subject to the security interest of this Mortgage and covered hereby. The Mortgagor shall, from time to time, on request of the Mortgagee, deliver to the Mortgagee at the cost of the Mortgagor: (a) such further financing statements and security documents and assurances as Mortgagee may require to the end that the liens and security interest created hereby shall be and remain perfected and protected in accordance with the requirements of any present or future law; and (b) an inventory of the Collateral in reasonable detail. The Mortgagor covenants and represents that all Collateral now is, and that all replacements thereof, substitutions therefor or additions thereto, unless the Mortgagee otherwise consents, will be free and clear of lions, encumbrances, title retention devices and security interests of others.

Mortgagor (and Mortgagor's beneficiary or beneficiaries) will not, without Mortgagee's prior written consent, which consent shall not be unreasonably withheld or denied: (a) execute any assignment or pledge of any rents or any leases of the Premises except an assignment or pledge securing the Indebtedness; or (b) make any lease of the Premises except for actual occupancy by the tenant thereunder.

Mortgagor at its sole cost and expense will: (a) at all times promptly and faithfully abide by, discharge and perform all of the covenants, conditions and agreements contained in all leases of the Premises, on the part of the landlord thereunder to be kepland performed; (b) enforce or secure the performance of all of the covenants, conditions and agreed ents of such leases on the part of the tenants to be kept and performed, but Mortgagor shall not (and Mortgagor's beneficiary or beneficiaries shall not) modify, amend, cancel, terminate or accept surrender of any lease without the prior written consent of Mortgagee, which consent shall not be unreasonably withheld, except that such consent is not required for any such action which is in the ordinary course of business and which does not have a material adverse effect on the operation of, or rental income from the Premises; (c) appear in and defend any action or proceeding arising under, growing out of or in any manner connected with such leases or the obligations, duties or liabilities of the landlord or of any tenants thereunder; (d) transfer and assign or cause to be separately transferred and assigned to Mortgagee, upon written request of Mortgagee, any tease or leases of the Premises heretofore or hereafter entered into, and make, execute and deliver to Mortgagee upon demand, any and all instruments required to effectuate said assignment; (e) furnish Mortgagee, within thirty (30) days after a written request by Mortgagee so to do, a written statement containing the names of all tenants and the terms of all leases of the Premises, including the spaces occupied and the rentals payable thereunder; and (f) exercise within thirty (30) days of any written demand therefor by Mortgagee any right to request from the tenant under any lease of the Premises a certificate with respect to the status thereof.

Nothing in this Mortgage or in any other documents relating to the loan secured hereby shall be construed to obligate Mortgagee expressly or by implication, to perform any of the covenants of any landlord under any of the leases assigned to Mortgagee or to pay any sum of money or damages therein provided to be paid by the landlord, each and all of which covenants and payments Mortgagor agrees to perform and pay or cause to be performed and paid.

At the option of the Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority or entitlement to insurance proceeds or any award in eminent domain), to any one or more leases affecting any part of the Premises, upon the execution by Mortgagee and recording or registration thereof, at any time hereafter, in the office wherein this Mortgage was registered or filed for record, of a unilateral declaration to that effect.

In the event of the enforcement by Mortgagee of any remedies provided for by law or by this Mortgage, the tenant under each lease of the Premises shall, at the option of the Mortgagee, attorn to any person succeeding to the interest of landlord as a result of such enforcement and shall recognize such successor in interest as landlord under such lease without change in the tenas or other provisions thereof; provided, however, that said successor in interest shall not be bound by any payment of any remer additional rent for more than one month in advance or any amendment or modification to any make made without the consent of Mortgageo or said successor in interest. Each tenant, upon request by said successor in interest, shall execute and deliver an instrument or instruments confirming such autornment.

Mortgagee shall have the option to declare this Mortgage in default because of a material default of landlord beyond all applicable cure periods in any lease of the Premises, whether or not such default is cured by Mortgagee pursuant to the right granted herein. It is covenanted and agreed that a default under any Assignment of Rents or Leaces executed pursuant to this Paragraph 12 shall constitute an Event of Default hereunder after expiration of all applicable notice and grace periods, on account of which the whole of the Indebteoress secured hereby shall at once, at the option of the Mortgagee, become immediately due and payable, without notice to the Mortgage.

Mortgager's option, without giving notice to or obtaining the consent of Mortgager or Mortgager's successors or assigns or the consent of any junior lienholder, guarantor or tenant, without liability on Mortgager's part and notwithstanding Mortgager's breach of any covenant, agreement or condition: (a) release anyone primarily or secondarily liable on any of the Indebtedness; (b) accept a renewal note or notes therefor; (c) release from the lien of this Mortgage any part of the Premises; (d) take or release other or additional security for the Indebtedness; (e) consent to any plat, map or plan of the Premises; (f) consent to the granting of any easement; (g) join in any extension or subordination agreement; (h) agree in writing with Mortgagor to modify the rate of interest or period of amortization of the Notes or change the time of payment or the amount of the monthly installments payable thereunder; and (i) waive or fail to exercise any right, power or remedy granted by law or herein or in any other instrument given at any time to evidence or secure the payment of the Indebtedness.

Any actions taken by Mortgagec pursuant to the terms of this Paragraph 13 shall not impair or affect: (a) the obligation Mortgager or Mortgagor's successors or assigns to pay any sums at any time secured by this Mortgage and to observe all of the covenants, agreements and conditions herein contained; (b) the guaranty of any individual or legal entity for payment of the Indebtedness; and (c) the lien or priority of the lien hereof against the Premises. Mortgagee's Reliance on Tax Bills, etc. Mortgagee in making any payment hereby authorized: (a) relating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the validity of any 'ax assessment, sale, forfeiture, tax lien or title or claim thereof; or (b) for the purchase, discharg a compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.
- Acceleration of indebtedness in Case of an Event of Default. An Event of 15. Default shall mean the following: (a) If Mortgagor shall fail to make due and punctual payment of principal or interest on the Notes, or any other payment due in accordance with the terms thereof beyond all applicable cure periods (which terms are hereby incorporated by reference); or (b) the Mortgagor or any beneficiary thereof or any guarantor of the Notes shall file (i) a petition for liquidation, reorganization or adjustment of debt under Title 11 of the United States Code (11 U.S.C. §§ 101 et seq.) or any similar law, state or federal, whether now or hereafter existing, or (ii) any answer admitting insolvency or inability to pay its debts, or (iii) fail to obtain a vacation or stay of involuntary proceedings within ninety (90) days, as heroinafter provided; or (c) any order for relief for the Mortgagor (or for any beneficiary thereof) or for any guaranter of the Notes shall be entered in any case under Title 11 of the United States Code, or a trustee or a receiver shall be appointed for the Mortgagor (or for any bracficiary thereof) or for any guarantor of the Notes in any voluntary or involuntary proceeding, or may court shall have taken jurisdiction of all or the major part of the property for the Mortgagor (or for any beneficiary thereof) or for any guaranter of the Notes in any voluntary or involuntary proceeding for the reorganization, dissolution, liquidation, adjustment of debt or winding up of the Mortgagor (or of any beneficiary thereof) or of any guaranter of the Notes and such trustee or receiver shall not be discharged or such jurisdiction not be relinquished or vacated or stayed on appeal or otherwise stayed within ninety (90) days; or (d) the Mortgagor (or any beneficiary thereof) or any guaranter of the Notes secured hereby shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or trustee or liquidator of all or any major part of its property; or (e) Mortgagor shall fail to observe or perform any other covenant, agreement or condition set forth herein and required to be kept or performed or observed by the Mortgagor (or its beneficiary), which failure is not cured within thirty (30) days after written notice thereof, provided that, if Mortgagor acts diligently, continuously in good faith to cure such failure within such thirty (30) day period after written notice and such failure cannot reasonably be cured within such time period, then such time period shall be extended; or (f) Mortgagor (and its beneficiary or beneficiaries) shall fail to observe or perform any covenant, agreement or condition required to

All reasonable expenditures and expenses of the nature in this paragraph mentioned and such reasonable expenses and fees as may be incurred in the protection of the Premises and the maintenance of the lien of this Mortgage, including the reasonable fees of any attorneys employed by Mortgagee in any litigation or proceeding affecting this Mortgage, the Notes or the Premises, including probate, appellate and bankruptcy precedings, or in preparations for the commencement or defense of any action or proceeding or threatened action or proceeding, shall be immediately due and payable by Mortgagor, promptly on receipt of a statement, with interest thereon at the rate set forth in the Notes applicable to a period when a default exists thereunder, and shall be secured by this Mortgage.

At all times, the Mortgagor shall appear in and defend any suit, action or proceeding that might in any way in the sole judgment of Mortgagoe affect the value of the Premises, the priority of this Mortgago or the rights and powers of Mortgagoe hereunder or under any document given at any time to secure the Indebtedness. Mortgagor shall, at all times, indemnify, hold harmless and reimburse Mortgagoe on demand for any and all loss, damago, expense or cost, including cost of evidence of title and attorneys' fees, arising out of or incurred in connection with any proceeding in which Mortgagoe is held to have been liable as a result of negligence or willful act of Mortgagor.

- 17. Application of Proceeds of Foreclosure Sale. - 32. Release of Previous Holder. The word "Mortgagee" when used herein shall include the successors and assigns of the original Mortgagee named on page one (1) hereof, and the holder or holders, from time to time, of the Notes. However, whenever the Notes are sold, each prior holder shall be automatically freed and relieved, on and after the date of such sale, of all liability with respect to the performance of each covenant and obligation of Mortgages hereunder thereafter to be performed, provided that any monies in which the Mortgagor has an

interest, which monies are then held by the seller of the Notes, are turned over to the purchaser of the Notes.

- 33. Severability and Applicable Law. In the event one or more of the provisions contained in this Mortgage or in the Notes or in any other document given at any time to secure the payment of the Notes shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall, at the option of the Mortgage, not affect any other provision of this Mortgage, the Notes or other document and this Mortgage, the Notes or other document shall be construed as if such invalid, illegal or unenforceable provision had never been contained herein or therein. 38. Lien for Loan Commissions, Service Charges and the Like.
