Note provided, or according to any agreement modifying payment thereof; (2) To pay when due and before any penalty attaches thereby all taxes, special taxes, special assessments, water charges, and sewer service charges against said property (including those heretofore d'.c), and to turnish Mortgagee, upon request, displicate receipts therefor, and all such items extended against said property shall be constantely deemed valid for the purpose of this requirement; (3) To keep the improvements now or hereafter upon said premises insured against damage by fire, and such other hazards as the Mortgagee may require to be insured against; and to provide public liability insurance, builder's risk insurance if applicable, and such other insurance as the Mortgagee may require, until said indebtedness is fully paid, or in case of foreclosure, until expiration of the period of redemption, for the full insurable value thereof, in such companies, through such agents or brokers, and in such form as shall be satisfactory to the Mortgagee; such insurance policies shall remain with the Nortgagee during said period or periods, and Hispontain the usual clause satisfactory to the Mortgagee making them payable to the Mortgagee, and in case of forcelosure sale payable No the owner of the certificate of sale, owner of any deficiency, any receiver or redemptioner, or any grantee in a deed pursuant to foreclosure and in case of loss under such policies, the mortgagee is authorized to adjust, collect and compromise, in its discretion, all claims thereunder and to execute and deliver on behalf of the Mortgagor all necessary proofs of loss, secupts, wonchers, releases and acquittances required to be signed by the insurance companies, and the Mortgagor agrees to sign, upon deane id, all receipts, southers, Indirelenses required of him to be signed by the Mortgagee for such purpose, and the Mortgagee is authorized a apply the proceeds of any insurance claim to the restoration of the property or upon the indebtedness hereby secured in its discretion, it is northly payments shall continue until said tudebtedness is paid in full; (4) Immediately after destruction or damage, to commence and promotely complete the rebuilding or restoration of buildings and improvements now or hereafter on said premises, unless Mortgages elects to apply on the indebtedness secured hereby the proceeds of any insurance covering such destruction or damage; (5) To keep said premises in good condition and repair, without waste, and free from any mechanic's or other hen or claim of lien not expressly subordinated to the lien hereof; (6) No; to make, suffer or permit any unlawful use of or any nuisance to exist on said property nor to diminish nor impair its value by any act or omission to act; (7) To comply with all requirements of law with respect to the mortgaged premises and the use hereof; (B) Not to make, suffer or permit without the written permission of the Mortgagee being first had and obtained, (a) any use of the property for any purpose other than that for which is it now used, (b) any alterations of the improvements, apparatus, apputtenances, fixtures or equipment now or hereafter upon said property, (c) any panchase on conditional sale, leave or agreement under which title is reserved in the vendor, of any apparatus, fixtures or equipment to be placed in or upon any buildings or improvements on said property; (9) to comply with the Loan Documents, as may be defined in the Note, and any other documents relating hereto.

- B. In order to provide for the payment of taxes, assessments, insurance premiums, and other charges upon the property securing this indebtedness, and other insurance required or accepted. Mortgagor promises to pay to the Mortgagoe, upon the Mortgagoe's demand, sums estimated to be sufficient to pay the aforementioned obligations up to the maximum amounts permissible by law in addition to the sums payable pursuant to the Note, which payments may, at the option of the Mortgagoe, (a) be held by it and commingled with other such funds or its own funds for the payment of such items; (b) be carried in a savings account and withdrawn by it to pay such items; or (c) be credited to the unpaid balance of said indebtedness as received. If the amount estimated to be sufficient to pay said items is not sufficient. Mortgagor promises to pay the difference upon demand. If such sams are held or carried in a savings account, or escrow account, the same are hereby pledged to further secure this indebtedness. The Mortgagoe is authorized to pay said items as charged or billed without further inouity.
- C. The covenants and agreements of this Mortgage shall bind the heirs, legal representatives, successors and assigns of the Mortgager and shall inure to the benefit of the successors and assigns of the Mortgagee. Mortgager's covenants and agreements shall be joint and several. Any Mortgager who cosigns this Mortgage but does not execute the Note: (a) is cosigning this Mortgage only to mortgage, grant and convey that Mortgagor's interest in the property under the terms of this Mortgage; (b) is not personally obligated to pay the sums secure; (b) this Mortgage; and (c) agrees that Mortgagee and any other Mortgagor may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Mortgage or the Note without the Mortgagor's consent.
- D. In case of Mortgagor', follure to perform any of the convenants herein, Mortgagoe may do on Mortgagor's behalf everything so covenanted; said Mortgagoe may also do any act it may deem necessary to protect the lien hereof; Mortgagor will repay upon demand any moneys paid or disbursed by Mortgagoe for any of the above purposes and such moneys together with interest thereon per the Note shall become so much additional indebtedness secured by this Mortgage with the same priority as the original indebtedness and may be included in any decree foreclosing this Mortgage and be paid out of the rents or proceeds of sale of said premises if not otherwise paid; and the Mortgagoe shall not incur any personal liability because of anything it may do or omit to do hereunder.
- E. It is the intent hereof to secure payment of said Note and to secure any other amount or amounts that may be added to the mortgage indebtedness under the terms of this Mortgage, the Loan Documents, as may be defined in the Note and any other documents relating hereto.
- F. If all or any part of the property or any interest in it, including any beneficial interest, is sold, leased, encumbered, fiened, transferred, conveyed, or assigned without Mortgagee's prior written consent. Mortgagee may, at its option, require immediate payment in full of all sums secured by this Mortgage. The acceptance of payment, shall not constitute a waiver of this right to require immediate repayment. However, this option shall not be exercised by Mortgagee if exercised by law as of the date of this Mortgage.
- G. Time is of the essence hereof and if default be made in performance of any coverant herein contained, or the Loan Documents as may be defined in the Note, or any other documents relating hereto, or in making my payment under said Note or any extension or renewal thereof, or if proceedings be instituted to enforce any other lien or charge (40) any of said property, or upon the filing of a proceeding in bankrupty by or against the Mortgagor, or if the Mortgagor shall make an assignment for the benefit of his creditors or if his property be placed under control of or in custody of any court, or if the Mortgagor shall abandon any of said property, or in the event of the filing of a suit to condemn all or a part of the said property, then and in any of said events, the Mortgagee is hereby authorized and empowered, at its option and without affecting the ben hereby created or the priority of said lien or any right of the Mortgagee hereunder, to declare without notice, all sums secured hereby immediately due and payable, whether or not such default be remedied by Mortgagor, and apply toward the payment of said mortgage indebtedness any indebtedness of the Mortgagee may also immediately proceed to foreclose this Mortgage, and in any foreclosure, a sale may be made of the premises en masses without offering the several parts separately.
- H. The Mortgagee may employ counsel for advice or other legal service at the Mortgagee's discretion in connection with any dispute as to the debt hereby secured or the lien of this instrument, or any litigation to which the Mortgagee may be made a party on account of this lien or which may affect the title to the property securing the indebtedness hereby secured or which may affect said debt or lien and any attorney's fees and expenses so incurred shall be added to and be a part of the debt hereby secured. Any costs and expenses incurred in the foreclosure of this Mortgage and sale of the property securing the same and in connection with any other dispute or litigation affecting said debt or lien, including reasonably estimated amounts to conclude the transaction, shall be added to and be a part of the debt hereby secured. All such amounts shall be payable by the Mortgagor to the Mortgagee on demand, and if not paid shall be included in any decree or judgment as a part of said mortgage debt nod shall include interest at the highest contract rate, or if no such contract rate then at the legal rate. In the event of a foreclosure sale of said premises there shall first be paid out of the proceeds thereof all of the aforesaid amounts, then the entire indebtedness whether due and payable by the terms hereof or not and the interest due thereon up to the time of such sale, and the overplus, if any, shall be paid to the Mortgagor, and the purchaser shall not be obliged to see to the application of the purchase money.

- 1. In case the mortgaged property, or any part thereof, shall be taken by condemnation, the Mortgagee is hereby empowered to collect and receive all compensation which may be paid for any property taken or for damages to any property not taken and all condemnation compensation so received shall be forthwith applied by the Mortgagee as it may elect, to the immediate reduction of the indebtedness secured hereby, or to the repair and restoration of any property so damaged, provided that any excess over the amount of the indebtedness shall be delivered to the Mortgagor or his assignce.
- All easements, rents, issues and profits of said premises are pledged, assigned and transferred to the Mortgagee, whether now due or hereafter to become due, under or by virtue of any lease or agreement for the use or occupancy of said property, or any part thereof, whether said lease or agreement is written or verbal, and it is the intention hereof (a) to pledge said tents, issues and profits on a parity with said real estate and not secondarity and such pledge shall not be deemed one god in any foreclosure decree, and (b) to astablish an absolute transfer and assignment to the Mortgagee of all such leases and agreements and all the avails thereunder, together with the right in case of default, either before or after forcefosure sale, to enter upon and take possession of, manage, maintain and operate said premises, or any part thereof, make leases for terms deened advantageous to it, terminate or modify existing or future leases, collect said avails, rems, issues and profits, regardless of when carned, and use such measures whether legal or equitable as it may deem proper to enforce collection thereof, employ renting agents or other employees, after or repair said promises, buy furnishings and equipment therefor when it deems necessary, purchase adequate fire and extended coverage and other forms of insurance as may be deemed advisable, and in general exercise off powers ordinarily incident to absolute ownership, advance or borrow money necessary for any purpose beceir stated to be secured by a lien which is hereby created on the mortgaged premises and on the income therefrom which lien is prior to the lien of any other indebtedness hereby secured, and out of the income retain reasonable compensation for itself, pay insurance premiums, taxes and assessments, and all expenses of every kind, including attorney's fees incurred in the exercise of the powers herein gives, and from time to time apply any balance of income not, in its sole discretion, needed for the aforesaid purposes, first on the interest and then on the principal of the indebtedness hereby secured, before or after any decree of forcelosure, and on the deficiency in the proceeds of sale, if any, whether there be a decree in personam therefor or not. Mortgagor agrees that upon Mortgagee's determination that in Elent of Default has occurred, as defined in the Note. Mortgagee may direct all tenunts to remit all subsequent rent payments directly to Mortgagee, and all tenants shall thereafter remit all rent payments directly to Mortgagee without further liability to Mortgagor, whenever all of the indebtedness secured hereby is paid, and the Morgagee, in its sole discretion, determines that there is no substantial accorrected default in performance of the Mortgagor's agreements herein, the Mortgagee, on satisfactory evidence thereof, shall relinquish possession and pay to Mortgagor any surplus income in its hands. The possession of Mortgagee may continue until all indebtedness secured hereby is paid in full or until the delivery of a deed pursuant to a decree forcelosing the lien hereof, but if no deed be issued, then notif the expiration of the statutory period during which it may be issued. Mortgagee shall, however, have the discretionary power at any time to refuse to take or to abandon possession of said premises without affecting the lien hereof. Morigagee shall have all powers, if any, which it might have had without this paragraph. No suit shall be sustainable against Mortgagee based upon acts or omissions relating to the subject matter of this paragraph. No action taken by Mortgagee hereunder shall create any liability whatsoever on the part of Mortgage, to any tenants.
- K. Upon the commencement of any foreclosure proceeding hereunder, the court in which such suit is filed may at any time, either Solvefore or after sale, and without notice to the Mortgagor, or any party claiming under him, and without regard to the solvency of the Mortgagor or the then value of said premises, or whether the same shall then be occupied by the owner of the equity of redemption as a homestead; appoint a receiver with power to manage and rent and to collect the rents, issue, and profits of said premises during the pendency of such foreclosure suit and the statutory period of redemption, and such rents, issues and profits, when codected, may be applied before as well as after the sale, towards the payment of the indebtedness, costs, taxes, insurance or other items necessary for the protection and preservation of the property, including the expenses of such receivership, or on any deficiency decree whether here be a decree therefor in personam or not, and if a receiver shall be appointed he shall remain in possession until the expiration of the full period allowed by statute for redemption, whether there be redemption or not, and until the issuance of deed in case of sale, but if no deed be issued, until the expiration of the statutory period during which it may be issued and no lease of said premises shall be nullified by the appointment or entry in possession of a receiver but he may elect to terminate any lease junior to the lien hereof.
 - L. Each right, power and remedy herein conferred upon the Mortgagee is cumulative of every other right or remedy of the Mortgagee, whether herein or by law conferred, and may be enforced concurrently therewith. No waiver by the Mortgagee of performance of any covenant herein or in said obligation contained shall thereafter in any manner affect the right of Mortgagee to require or enforce performance of the same or any other of said covenants. Wherever the context hereof requires, the masculine gender, as used herein, shall include the feminine and the neuter and the singular number, as used herein, shall include the plural. All rights and obligations under this Mortgage shall extend to and be binding upon the respective heirs, legal representatives, successors and assigns of the Mortgagee. The powers herein mentioned may be exercised as often as occasion therefor arises.

If the Note secured by this Mortgage is subject to a faw which sets maximum loan charges, and that faw is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: the any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from the Mortgagor which exceeded permitted limits will be refunded the Mortgagor. Mortgagee may choose to make this pland by reducing the principal owed under the Note or by making a direct payment to the Mortgagor.

IN This Mortgage shall be governed by the law of the State of Illinois and any applicable bederal laws. In the event that any provision or clause of this Mortgage, the Note, the Loan Documents as may be defined in the Note, or any other documents relating heretic conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage of the Note which can be given effect without the conflicting provision. To this end the provisions of this Mortgage, the Note, the Loan Documents as may be defined in the Note, and any other documents relating hereto are declared to be severable.

O Monyagor shall not cause or permit the presence, use, disposal, storage, or release of any intradous substances on or in the property. Mortgagor shall not do, not allow anyone else to do, anything affecting the property that is in violation of any environmental law. The preceding 750 entences shall not apply to the presence, use, or storage on the property of hazardous substances that are generally recognized to or appropriate to normal uses and manuferance of the property.

Mortgagor shall promptly give Mortgagee written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulators agence or private party involving the property and any hazardons substance or environmental law of which Mortgagee has actual knowledge. It clorigagor learns, or is notified by any governmental or regulatory authority, that any removal or other remediation of any hazardons solustance affecting the property is necessary, Mortgagor shall promptly take all necessary remedial actions in accordance with environmental laws.

As used in this paragraph, "hazardous substances" are those substances defined as toxic or hazardous substances by environmental law and the 'ollowing substances: gasoline, kerr sene, other flammable or toxic petroleum products, toxic perticides and berbicides, solarile solvents, materials containing asbestos or tornaldebyde, and radioactive materials. As used in this paragraph, "environmental law" means tederal laws and laws of the jurisdiction where tree property is located that relate to health, safety or environmental protection.

P. Mortgagee or its agent may make reasonable entries upolically inspections of the the property. Mortgagee shall give Mortgagor notice at the time of or prior to an inspection specifying reasonable cause for the inspection.

Q. Any nonce to Mortgagor shall be given by regular mail to the property address or any other address Mortgagor designates by nonce to Mortgagor. Any notice to Mortgagor shall be given by certified to direturn receipt requested to Mortgagor's address stated become or any other address Mortgagor designates by notice to Mortgagor. No fixes shall be dremed to have been given to Mortgagor and Mortgagor when given as provided in this paragraph.

The Mortgagor hereby waives any and all rights of redemption from sale under any order or decree of foreclosure of this Mortgage.
